The following terms and conditions may kindly be noted:-

The Scheme is valid upto 01.12.2019

- Retired staff who have retired from Mumbai Division of Central Railway and from the same category and same department for which notification is issued can apply.
- 2. The re-engagement shall be strictly upto 01.12.2019 or attaining the age of 65 years or till the availability of regular candidates from RRB/Departmental Selection whichever is earlier.

- 3. Maximum upper age limit for re-engagement on 01.12.2019 is 65 years. No reengaged employee should continue in service beyond 65 years of age.
- 4. The Administration is at liberty to terminate the services of the re-engaged employees even before 01.12.2019 in case their work/ conduct is found unsatisfactory by giving a notice of 7 days. The re-engage retired staff should give a notice of 7 days before discontinuing his services.
- 5. The employees Removed / Dismissed/ Compulsory retired as a result of disciplinary action or in review, are not eligible for re-engagement. Further employees retired under SRRS/LARSGESS will not be eligible
- 6. The re-engaged employees are entitled only for monthly fixed remuneration i.e reducing pension from his/her last pay drawn, (i.e. Basic+DA) at the time of retirement. The monthly fixed remuneration plus full pension shall not exceed the last pay drawn at the time of retirement.
- The Re-engaged employee will not be eligible for any kind of leave (like CL,APL, sick Leave etc). For absence if any, appropriate deduction will be made from the monthly remuneration.
- 8. The re-engaged employees are not entitled for any other benefit or facilities except the monthly fixed remuneration.
- 9. The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
- 10. Re-engagement shall be subject to prescribed medical fitness for the relevant Category.
- 11. Suitability / Competency of the applicant shall be adjudged by nominated committee before their re-engagement.
- 12. The duty hours of the re-engaged employees would be 9.30hrs to 18.00 hrs. The duty can be changed as per the requirement of works by the administration with weekly off for one day.
- 13. Copy of any of the following documents should be attached with the application & it is Mandatory.
 - p. Service certificate
 - q. Pensioner Identity Card
 - r. Pension Payment Order
- 14. The last date for submission of the application is 08.11.19. Staff retired from Mumbai Division Central Railway desirous for re-engagement, have to submit their applications in the prescribed format at Annexure A in the box kept in P/General Section of this office on or before 08.11.19.
