- A) Candidates complying with the above criteria may apply by downloading the Application form from the Bank's website "www.acab.bank.in"
- B) The Application form needs to be filled up as per the instruction contained therein and duly signed by the Applicant.
- C) 1(one) copy of recent passport size photograph should be pasted on the application in the space specified with signature across it and 1(one) copy should be enclosed.
- D) Applications must be accompanied by self attested copies of educational qualifications from H.S.L.C. onwards both pass certificate & marksheets, experience certificate (specifying designation, job profiles & period of service etc.), Age proof certificate (birth certificate/H.S.L.C. Admit Card etc), caste certificates, certificate of computer proficiency and other qualifications etc.
