- All interested candidates, fulfilling the eligibility conditions **are hereby instructed to submit their filled in application form in the prescribed format as available on the Institute's website by email at recruitment.contractual@aiimsbhopal.edu.in within 10 days of the publication of this advertisement on Institute's website along with requisite documents in support of their eligibility.**
 - **The candidates are required to bring the same filled in application in the prescribed format along with proof of identity, date of birth, eligibility qualification mark sheets, degrees, experience certificates, No objection certificate and other relevant documents (in original) in support of their eligibility along with 02 sets of self-attested photocopies & application fee in form of Demand Draft (if applicable) at the time of document verification/Interview.**
2. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the aforesaid post and must fulfill all the eligibility criteria before applying.
 3. The schedule of document verification and Interview will be intimated separately on the Institute's website only.
 4. Applicants are advised to visit the Institute's website regularly for further updates.
 5. Candidates reporting for document verification after **12:00 PM** may not be allowed unless in case of any genuine exigencies.
 6. On the day of DV/Interview, the candidate is required to be present "in person" with all **original** certificates along with 02 sets of self-attested photocopies at the venue of the following documents:-

7. The above schedule is tentative and the Institute reserves the right to cancel or reschedule the same depending upon the availability of Selection Panel or other Administrative reasons.
 8. Candidates who fail to produce valid caste/category certificate during document verification/Interview or as and when required to produce the same, the candidature of such candidates is liable to be cancelled. All candidates are therefore advised to ensure that they possess required valid caste/category certificate in advance.
 9. The Executive Director, AIIMS Bhopal reserves the right to reschedule the above date, time and venue at any stage of interview.
 10. The above vacancies are provisional and subject to variation. The Executive Director, AIIMS Bhopal reserves the right to vary the vacancy including reserved vacancies as per the GoI rules/circulars and as per Institute's requirements. The reservation is as per the guidelines of MoHFW/Government of India.
 11. Age, Experience and all prescribed qualifications shall be counted **as on date of interview**.
 12. The engagement will be purely on contractual basis and under no circumstances are linked to regular appointments and **cannot be regularized at any stage**. If the contract is not extended further, the same will lapse automatically.
 13. The emoluments will be consolidated in nature as determined by the Competent Authority and nothing additional will be paid. The appointment can be terminated by the competent authority any time (before one year also), without assigning any reason thereof.
 14. **The period of experience, wherever prescribed shall be counted after obtaining the prescribed qualifications.** For posts having experience as an Essential Criteria, the experience which has been acquired only after obtaining Essential Qualification, will be considered as valid.
 15. The Executive Director, AIIMS Bhopal reserve the rights to cancel the advertisement at any point of time without prior notice or fill up less number of posts as advertised depending upon the institutional requirements.
 16. **Application Fees:**

17. **No Objection Certificate:** Those who are working in Central/State Government/ /Semi Government/ Autonomous body/PSU shall be required to submit “**No Objection Certificate**” from their respective organization at the time of document verification/interview, as and when demanded, failing which the candidate will not be permitted to attend the interview and the candidature will be rejected.

18. **Age Limit:**

The age of the candidates should be up to **50 years** as on the date of the interview. Age relaxation for candidates belonging to different categories shall be applicable as per Government of India rules/orders.

19. **Reservation:** As per Government of India rules.

Caste/Category Certificates:

A. OBC Category

i. The vacancies are being advertised in financial **year 2026-2027**, therefore, valid NCL-OBC certificate issued during the period **from 01.04.2026 to 31.03.2027** will be considered valid. Candidature who have OBC-NCL certificate issued before or after this period (i.e. 01.04.2026 to 31.03.2027) will not be considered valid for this advertisement.

ii. Candidates applying under OBC category must produce the valid caste certificate in the format provided by the DoP&T vide O.M. No. 36036/2/2013-Estt. (Res.) dated 30.05.2014 and further clarification issued by DoP&T OM No. 36036/2/2013 Estt(Res-I) dated 31.03.2016.

iii. **Certificate must be valid for employment in Central Government Institutions.** OBC candidate’s eligibility will be based on Castes borne in the Central List of Govt. of India. **Their Sub-caste should also match with the entries in Central List of OBC, failing which their candidature as OBC candidate will not be considered.** The OBC certificate should clearly show that the applicant does not belong to the Creamy Layer.

B. EWS Category

The vacancies advertised under EWS Category are as per the instructions issued by DoPT, Ministry of Personnel, Public Grievances & Pension, Govt. of India, vide OM. No. 36039/1/2019-Estt (Res), dated 31.01.2019. Application under EWS category will be considered subject to submission of Income and Assets certificate on a prescribed format issued by the competent authority and subject to verification of genuineness of the certificate by the issuing authority. In pursuance to DoP&T OM No. 36039/1/2019-Estt (Res), dated 31.01.2019, a EWS certificate issued in prescribed format for employment in Central Government on the basis of income of financial year 2025-2026 issued on or after 01.04.2026 and valid for the financial year 2026-2027 will be considered valid.

20. PwBD Candidates may apply against the identified posts for PwBD. Applicants with disabilities mentioned in Section 32 (1) of Rights of Persons with Disability Act, 2016,

are eligible to apply under this category provided they have benchmark disability (equal to or more than 40%). Person who wants to avail the benefit of reservation would have to submit a Disability Certificate as issued by a Competent Authority in the prescribed format.

21. **Place of Interview:** The document verification / interview will be held at Administrative Block, Kautilya Bhawan, All India Institute of Medical Sciences, Saket Nagar Bhopal-462020
22. No TA/DA will be paid for appearing in the interview.
23. The Executive Director, AIIMS Bhopal reserves the right to reschedule the date and time of Interview/ Document Verification & venue at any stage.
24. **Short listing:** After scrutiny / verification of the documents as per eligibility criteria/conditions, only eligible candidates will be permit to appear before the selection committee for interview. Candidates reporting for document verification must bring printed copy of the application form.

OTHER TERMS & CONDITIONS

1. Canvassing of any kind will lead to disqualification.
2. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
3. The appointees shall be whole-time contractual employee of the institute and shall not accept any other assignment paid or otherwise and shall not engage him/her in a private practice or any kind during the service period.
4. He/She is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
5. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available/applicable to the Government Servants, appointed on regular basis.
6. The engagement of selected candidates can also be terminated at any time, on either side, by giving one month's prior notice or by paying one month's salary, without assigning any reason to the satisfaction of competent authority.
7. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
8. Leave entitlement of the appointee shall be governed as per the existing rules of the Institute for Contractual Employees.
9. The appointee shall not be entitled to avail any allowances/facilities being extended to the regular/permanent faculty members of the AIIMS.
10. The candidate should not have been convicted by any Court of Law.

In case any information given or declaration by the candidate is found to be false or if the candidate has willfully suppressed any material information relevant to this appointment, he/she will be liable to be removed from the service and any other action as deemed fit may be taken by the Competent Authority.
12. The decision of the competent authority regarding selection of candidates will be final and no representations will be entertained in this regard.
13. No Interim enquiries/correspondence/communication of any sort will be entertained on the matter.
13. Applications incomplete in any aspect are liable to be summarily rejected.
