ADVERTISEMENT FOR RECRUITMENT FOR THE POSTS OF JUNIOR RESIDENT (NON-ACADEMIC) IN VARIOUS DEPARTMENTS OF AIIMS, BIBINAGAR, UNDER GOVT.OF INDIA RESIDENCY SCHEME

- 1. AIIMS Bibinagar is an apex healthcare institute, established by the Ministry of Health & Family Welfare, Government of India under the Pradhan Mantri Swasthya Suraksha Yojana (PMSSY).
- 2. Applications are invited in prescribed format from Indian Nationals for the post of **Junior Resident**, as per Govt. of India Residency Scheme for the tenure period up to six months.
- 3. Tentative dates for counseling/ interview: 20.12.2023. This shall be a rolling recruitment.
- **4.** Details of vacancies for the posts of Junior Resident are as follows:

Note:

1) In case suitable Economically Weaker Sections (EWS) candidates are not found, these posts will not be carried forward/or considered as backlog vacancy, hence Unreserved (UR) candidates may also be allowed provisionally to apply against EWS posts advertised through above referred advertisement who may be considered incase suitable EWS candidate are not found to fill up these posts reserved for EWS.

2) 4% PwBD on horizontal basis as per Government rules.

5. **QUALIFICATION:**

- **1.** The candidates should have passed MBBS/BDS (including completion of Internship) or equivalent degree recognized by MCI/NMC/DCI.
- **2.** Valid Registration with MCI/NMC/DCI/State Medical Council/ State Dental Council is mandatory before joining, if selected.
- **3.** Those who had joined Junior Residency (Non-Academic) at any AIIMS and whose services were terminated on account of unauthorized absence or any other disciplinary/ground, will be ineligible to be considered for these JR (NA) post even if they otherwise qualify.

4. For all eligible candidates, maximum three terms* are allowed (depending upon concerned department assessment and availability of posts). Any AIIMS graduates will be considered to be allotted post on preferential basis. Candidates who have already done 3 terms* of Junior Residency (Non-Academic) either at AIIMS or outside will not be considered.

<u>Note (*):</u> One term of JR (Non-Acad.) is 6 months, if any one join and leaves at anytime it will be counted as one term irrespective of duration of work. For each term, the candidate(s) required to submit his/her application separately.

6. PAY SCALE:

Level 10 of pay matrix under 7th CPC plus usual allowances including NPA.

7. <u>UPPER AGE LIMIT:</u> 37 Years (As on last date of submission of application)

The relaxation in age shall be as per Government of India norms and the maximum permissible relaxation

- i) SC/ST candidates 5 years
- ii) OBC candidates 3 years
- iii) Persons with Bench-mark Disabilities [PWBD] General Category 10 years
- iv) Persons with Bench-mark Disabilities [PWBD] OBC Category 13 years
- v) Persons with Bench-mark Disabilities [PWBD] SC/ST Category 15 years

8. APPLICATION PROCESS:

Last date for submission of application is 19.12.2023 upto 5:00PM.

SC/ST/PWD Category : No application fees.

The candidate must produce the receipt of application fee at the time of document verification without fail.

10. RESERVATION:-

- > The reservation for EWS/OBC/SC/ST candidates is as per Central Govt. Rules and 4 % for PWD candidates (on horizontal basis).
- For OBC Candidate: Candidates must attach certificate valid for the posts under the Central Government of India which mentions that the Candidate does not belong to Creamy Layer. Date of issue of Certificate should be issued on or after 01.04.2023.
- For EWS, OBC, SC and ST Certificate should be issued by Tehsildar or above rank authorities prescribed by Govt.of India in format of State/Central Government.

For Persons with Disability (PWD):

- The candidate must possess a valid document certifying his/her physical disability is conforming to judgment of Supreme Court of India i.e.: "With the approval of the Ministry of Health & Family Welfare, Govt. of India vide letter no. 18018/2/2009-ME(P-1) dated 17.02.2009 it has been decided that while providing reservation in admission to medical course in the first instance candidates with disability of lower limbs between 50% to 70% shall be considered and incase candidates are not available of such candidates in that category then the candidates with disability of lower limbs between 40% to 50% will also be considered for admission as per decision in the Writ Petition (Civil) 184/2005- Dr. Kumar Sourav Vs. UOI& others in the Supreme court of India".
 - > The disability certificate should be signed by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/ Institutions& counter signed by Medical Superintendent.
 - The constitution of the Medical Board will be one consultant each from disciplines of Orthopedics, Physical Medicine & Rehabilitation and Surgery.

PWD candidates who apply will be considered against seats in category in which he/she has applied ie.GEN/EWS/OBC/SC/ST. Last seat/s in the respective category will be

offered to PWD candidates, in case PWD candidate is not able to make on his/her their own merit.

ABBREVIATIONS USED: S=Sitting, ST=Standing, H=Hearing, W=Walking, RW=Reading, Writing and SE=Seeing, OL = One Leg & OA = One Arm

For EWS (Economically Weaker Sections):

- ➤ 10% of Vacancies are reserved for the EWS as per the directions of Government of India instructions issued vide DoPTOMNo.36039/1/2019-Estt (Res) dated19th January2019.
- Persons who are not covered under the existing scheme of reservations to the Scheduled Castes, the Schedule Tribes and the socially and Educationally Backward Classes and whose family has gross annual income Below Rs. 8.00 lakh are to be identified as EWSs for the benefit of reservation. Family for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. The income shall include income from all sources i.e. salary, Agriculture, business, profession etc. and it will be income for the financial year prior to the year of application. Also persons whose family owns or possesses any of the Following assets shall be excluded from being identified as EWSs, irrespective of the family income:
- a. 5acres of Agricultural Land and above;
- b. Residential flat of 1000sq.ft.andabove;
- c. Residential plot of 100 sq. yards and above in notified municipalities;
- d. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.
- The income and assets of the families as mentioned in Para 2 would be required to be certified by an officer not below the rank of Tehsildar in the States/UTs. The candidates shortlisted for document verification/interview shall be required to bring the requisite certificate as specified by the Government of India at the time of appearing for the process of document verification/interview. The income and asset certificate issued by one of the authorities mentioned shall only be accepted as proof of candidate's claim as belonging to EWS.
- > The instructions issued by the Government of India in this regard from time to time shall be adhered to.
- Date of issue of Certificate should not be earlier 01.04.2023.

11. SELECTION PROCEDURE:-

AIIMS Bibinagar graduates:

- ➤ The Junior Residency (Non-Academic) will be provided first to all the AIIMS Bibinagar MBBS graduates who fulfill above eligibility criteria.
- ➤ The merit for AIIMS Bibinagar MBBS graduates will be made on the basis of their aggregate marks in the 1st, 2nd, and 3rd Professional examinations.
- ➤ All JR(NA) posts which remain unfilled after allotment to AIIMS Bibinagar MBBS graduates will be offered to other candidates.

Non AIIMS Bibinagar graduates:

- ➤ The merit order of these candidates (non AIIMS Bibinagar MBBS graduates) will be on the basis of rank obtained in the AIIMS PG entrance examination (INICET) held immediately before recruitment for these posts.
- Candidates, who have not appeared in the above exam will be ranked in merit after those who have appeared in the above exam. Their merit list will be prepared based on the percentage of marks scored as per criteria below.
- For candidates who have completed their MBBS from a Medical College in India, aggregate percentage of marks obtained in the MBBS examination will be considered.
- For Indian Citizens, who have completed their MBBS from a Medical College outside India and have passed the MCI screening test for registration (FMGE test), marks obtained in percentage in the MCI screening exam will be considered for merit. These students must enter the MCI exam percentage at the appropriate place in the Online Application Form. They must not enter percentile scores obtained in the MBBS course.
- > Selected Candidate will be expected to stay in Institute Campus if offered residential accommodation.
- > Selection will be done only on the basis of merit.
- ➤ Waiting list as may be deemed fit will be maintained. Any vacancy arising because of non-joining by selected candidate/s in this selection or by resignation of candidate/s, post will be offered to the candidates from the waiting list according to the merit.
- ➤ For qualification /Reservation / Selection Procedure/Emolument/date of counseling/ interview and other latest details, candidates are advised to visit AIIMS, Bibinagar website regularly.
- ➤ No separate call letters shall be sent to candidates for appearing in counseling/interview.

12. TERMS & CONDITIONS:-

> Canvassing information of any kind will lead to disqualification. Incomplete applications will not be considered and will be REJECTED. No interim correspondence shall be entertained.

- ➤ The prescribed qualification is minimum and merely possessing the same does not entitle any candidate for selection.
- Late applications/ Incomplete applications in any respect will be summarily rejected.
- > The appointee shall be on the whole time appointment of the AIIMS and shall not accept any other assignment, paid or otherwise and shall not engage himself/ herself in a private practice of any kind during the period of contract.
- ➤ He / She may work in shifts and can be posted at any place in the Institute as per the discretion of the MS/Dean/Director.
- ➤ The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
- > The appointees shall be granted leave in accordance with the instructions issued by the Government of India from time to time.
- > The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
- If an appointee wishes to apply somewhere else or resign within the first 03 months of joining, then neither he/she will be issued a No Objection Certificate (NOC) nor he/she will receive any relieving letter or experience certificate.
- ➤ He/ She is expected to abide by the rules of conduct and discipline as applicable to the Institute employees.
- The candidate should not have been convicted by any Court of Law.
- > In case, any information given or declaration by the candidate is found to be false or if the candidate has willfully suppressed any information relevant to this appointment, he/she will be liable to be removed from the service and action will be taken as deemed fit by the Competent Authority.
- ➤ The decision of the Competent Authority regarding selection of candidates will be final and no representation will be entertained in this regard.
- ➤ The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
- All disputes will be subject to jurisdictions of High Court, Hyderabad (Telangana).
- ➤ Candidates working in Govt. / Semi-Govt. PSU should apply through proper channel. The candidates in-service will not be permitted for examination / interview, without "No Objection Certificate" from the employer. In this connection, it is mentioned that as per the terms and conditions of Central Residency Scheme, their engagement is to be regulated as per the CCS (Temporary Service Rules).
- > On selection, the candidates will be given one month time to join the post at AIIMS, Bibinagar. In exceptional situations (with reasonable justification) extension may be granted by the Competent Authority.
- > If any candidate, who joins the post and leaves/resigns/gets terminated before the completion of the tenure, he/she may do so by giving one month's prior notice as per the rules or by depositing pay and allowance in lieu thereof with the Institute for the period of which notice falls short of one month or so.
- The appointment can also be terminated at any time by either side, by giving one

month's notice or by paying one month's salary, without assigning any reason.

> The Competent Authority reserves the right to cancel the advertisement at any point of time without assigning any reason there of or fill up less/more number of posts as advertised depending upon the Institutional requirement.
