1) As per guidelines EWS posts are not carried forward / or considered as backlog vacancy in case unfilled hence other category candidates may be allowed provisionally to apply for post subjected to condition that they will be considered for the post as an UR Candidate only if EWS category seat is otherwise not filled.

NOTE:-

1. Candidate can apply for these posts through online registration of application on AIIMS, Jodhpur website: www.aiimsjodhpur.edu.in w.e.f. **24th September, 2026** as per the terms & conditions mentioned therein. The last date for applying for the post of Senior Residents is **5th October, 2026 (Monday) (17:00 Hrs)**.
2. **Candidates should not send hard copy of the online application or any document thereof.**
3. The above vacancies are provisional and subject to variation. The Executive Director, AIIMS, Jodhpur reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules/circulars and requirements.
4. Reservation will be as per Government of India Policy.

UPPER AGE LIMIT (5th October, 2026) AND ELIGIBILITY

- a) For eligibility to apply for these posts upper age limit as on **5th October, 2026** (Last date of application form) will be **45 years**. This is **relaxable** for **SC/ ST** candidate for a maximum period of **Five years**. In the case of **OBC** candidates it is relaxable upto maximum period of **Three years**. In the case of Persons with Disabilities (**PwBD**) candidates, this is relaxable upto maximum period of **Ten years for General category, Thirteen years for OBC category and Fifteen years for SC/ST category candidates**.
- b) To be eligible for selection for these posts, the candidate should pass the qualifying examination by **30th September, 2026** & result should be declared to this effect on or before this date.
- c) In case of those who have appeared for exam / viva voce and result is yet to be declared then applicant will be allowed to appear in theory and/or interview provisionally.
- d) In cases where result of qualifying exam is declared after **30th September, 2026** their candidature will stand cancelled and no claim for selection on the basis of theory exam and Interview allowed provisionally will be considered.
- e) **The candidates who are in service in any Government Institutions are required to submit No Objection Certificate (NOC) from the employer at the time of Interview.** The candidates will not be permitted for Interview if they fail to produce no objection certificate on the day of interview during scrutiny of documents.

APPLICATION FEE:

- i). **Person with Bench-mark Disabilities (PwBD) Candidate: Nil**
- ii). General/OBC/EWS category: ₹ 1,000/- + transaction charges as applicable.
- iii). SC/ST category: ₹ 800/- + transaction charges as applicable.

Note: Payment should be made online only and the application fee once remitted shall not be refunded.

PAY SCALE:

Senior Resident (Medical): ₹ 18,750 + 6,600 (Grade Pay) + NPA (Non Practicing Allowance) plus other usual allowance or revised pay scale as per 7th CPC as applicable (Level – 11 of the Matrix (Pre-revised PB – 3, entry pay of the ₹ 67,700/- per month + NPA plus other usual allowance admissible under rules). **NPA is applicable for only Medical candidates.**

RESERVATION FOR SC / ST / OBC / EWS/ PwBD SHALL BE APPLICABLE AS PER GOVT. OF INDIA POLICY.

Reservation for Persons with Bench-mark Disabilities Candidates (PwBD) is applicable by Govt. of India Policy, which will be provided on horizontal basis to PwBD candidate in their respective categories.

Criteria for Persons with Disabilities Candidates:

The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals / Institutions and countersigned by Medical Superintendent / CMO / Head of Hospital / Institution.

Candidate applying in EWS/ OBC / SC / ST Category, must possess the caste certificate issued by competent authority, valid for admission / Job in Central Govt. Institutions issued before the date of interview, failing which he / she shall not be allowed to appear in interview for the same category. However, he / she can be treated as UR Candidate.

OBC/EWS category must possess valid OBC/EWS certificate issued by the competent authority for admission in Central Govt. Institution.

OBC certificate must have been issued within one year of last date of application / Date of Interview. Candidate should belong to non-creamy layer of Central List of OBC.

Candidate applying in EWS category must possess a valid EWS certificate by the competent authority for admission / jobs in central government institutions. EWS certificate must have issued after 01.04.2026 and be valid for financial year 2026-27

In case candidate fails to produce valid OBC certificate for admission / Job in Central Government Institution or issued within one year at the time of interview / document verification otherwise, he/ she may be treated as UR Candidate.

RESERVATION FOR ECONOMICALLY WEAKER SECTIONS (EWS):

Persons who are not covered under the scheme of reservation for SC's, ST's and OBC's and whose family has gross annual income below ₹ 8 lakh (Rupees eight lakh only) are to be identified as EWS's for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application. Such candidates should have valid income certificate on the date of application in the prescribed format or on the letter head of the issuing authority to this effect before filling the application and submit the same at the time of document verification, failing which their candidature will be rejected. PROCESS OF SELECTION:

1. **The Candidate can apply in one department only.**
2. Selection will be on the basis of MCQ based written examination and Interview.
3. The selection criteria for MD/MS, DNB, DM/M.Ch, M.Sc/Ph.D candidates.
 - a). 50% weightage – Written Examination (MCQ based)
 - b). 30% weightage – Academic Record (based on marks of MBBS/BDS, extra attempts in MBBS/BDS & MD/MS/DNB/MDS and Pubmed Indexed Publication.
 - c). 20% weightage – Interview
4. Candidates will be called for Interview in the ratio of 1:6 i.e. for one post, only six candidates will be called for the Interview.
5. List of Eligible candidates for Interview / MCQ based Written Examination will be uploaded on website www.aiimsjodhpur.edu.in. Candidates are advised to check the Institute website regularly for the information related to interview / screening exam
6. The examination and interview will be conducted at AIIMS, Jodhpur. **A separate notice regarding schedule of examination and interview will be uploaded on the institute's website.**
7. **List of the selected candidates will be uploaded on website www.aiimsjodhpur.edu.in. Candidates are advised to check the Institute website regularly.**

DOCUMENTS TO BE PRODUCED IN ORIGINAL AT THE TIME OF INTERVIEW: -

The Candidate should bring following original documents and one set of self-attested photocopies at the time of Interview with application form:-

- II. Address Proof.
- III. Certificate showing Date of Birth. (Birth Certificate/ 10th Certificate). ***No Age relaxation would be available to SC/ST/OBC candidates applying for unreserved vacancies.***
- IV. Class 10th & 12th Marksheet and Certificates.
- V. Qualifying degree-
 1. MBBS/BDS/M.Sc Marksheet and degree certificates.
 2. MD/DNB/MS/MDS/Ph.D degree certificate.
 3. DM/M.Ch/DNB degree certificates.
- VI. Attempt and Internship Completion Certificate.
- VII. Registration with Medical Council of India /State Medical Council & DCI for Dentistry candidates.
- VIII. Experience Certificate (if have).
- IX. FMGE certificate conducted by NBE (For foreign graduate).
- X. Reservation category Certificate (OBC*/SC/ST/PH) (****Candidate should belong to non-creamy layer of Central List of OBC.***)
- XI. ***In case of OBC candidate, the OBC certificate must be issued within one year (Older certificate not be entertained).***
- XII. ***In case of EWS candidate, the EWS certificate must be issued on or after 01st April, 2026 to last date of application and be valid for financial year 2026-27.***
- XIII. Candidates working in Government Institution- No Objection Certificate.
- XIV. Publications.

Note: Candidates who do not produce the above mentioned original documents at the time of interview will not be considered for selection.

TERMS & CONDITIONS

Tenure: - **The appointment is initially for a period of One (01) year extendable upto Three (03) years.** This appointment will not vest any right to claim by the candidate for permanent absorption in the institute OR for continued contractual appointment which may be renewed or terminated as decided by the Institute.

Expiry of Appointment: - The contract will automatically expire on completion of One (01) Year, which may extendable upto three (03) years based on performance & conduct. The appointment can be terminated at any time by the Institute. The employee can also leave the Institute by giving one month notice or one month salary in lieu thereof.

The leave entitlement of the appointee shall be as per the Central Residency Scheme and Institute Policy.

The Competent Authority reserves the right to change the number of vacancies, withdraw the process in full or in part and also the right to reject any or all applications received without assigning any reasons or giving notice etc.

The prescribed qualification is minimum requirement and mere possessing the same does not entitle any candidate for selection.

This appointment is full time and private practice of any kind is prohibited.

He / She will have to work in shifts and can be posted at any place in the Institute.

He / She should also note that he/she will have to conform to the rules of discipline and conduct as applicable to the Institute employees.

No travelling or other allowances will be paid to the candidate for joining the post.

The candidate should not have been convicted by any Court of Law.

Canvassing in any form will render the candidate disqualified for the post.

If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material information, he / she will be liable to be removed from services and such action as the appointing authority may deem fit.

The decision of the Competent Authority regarding selection of the candidate will be final and no representations will be entertained in this regard. The decision of the committee shall be final and binding.
