Note: Vacancies may increase or decrease at the time of selection. The number of vacancies indicated as above are provisional and subject to change without any prior notice.

1. QUALIFICATION:

- A. Post Graduate Degree i.e. MD/MS/DNB/DM/M.Ch or equivalent in the above Departments recognized by Medical Council of India / NMC/ NBE.
- B. For Cardiology and Neurology seats, candidates with MD in General Medicine will also be considered.
- C. For Clinical Haematology seats candidates with MD in General Medicine and MD in Paediatrics will also be considered.



2. AGE LIMIT:

The upper age limit for applying these posts is 45 years.

Cut-off date to determine eligibility in terms of age of candidates will be the last date on 06.10.2024.

SC/ST/OBC/PWBD candidates who opt to apply for unreserved vacancies will not be eligible for age relaxation or relaxation in cut off marks which are otherwise allowed to those belonging to these categories. Further, reserve category candidates (SC/ST/OBC/PWBD) who become eligible by virtue of age relaxation applicable in their category will be considered only for reserved seats of the category to which they belong even if they have the merit to be considered otherwise for UR.

Age relaxation is permissible to various applicants is as under: -

- 1. SC/ST- 5 years
- 2. OBC 3 years
- 3. PWBD- 10 years
- 4. Ex Servicemen Candidate- 5 years.

3. <u>APPLICATION FEES & MODE OF PAYMENT:</u>

- ➤ General/OBC Category : Rs 1500/-
- SC/ST/EWS Category : Rs 1200/-
- Ex-servicemen/Women/PwBD candidate is exempted from any fee.

Application fee is required to be remitted through Demand Draft only. The **Demand Draft should be drawn in favour of AIIMS, Patna payable at AIIMS, Patna**. Any other instrument of payment is not acceptable. The application fee is non-refundable.

4. FILLING UP OF APPLICATION FORM ON THE DATE OF WALK-IN INTERVIEW:

- a) For filling up of application on the date of walk-in interview, the candidates have to bring the following documents (**original and one set of self-attested copies**) which also needs to be produced at the time of walk-in interview:-
 - Recent Passport size photograph of candidate
 - face clearly visible
 - The picture should be in colour, against a light-coloured, preferably white background
 - Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face.
 - Demand Draft in original (if applicable)
 - Aadhar Card
 - Date of Birth/SSC/HSSC pass certificate (mentioning Date of Birth)
 - MBBS Degree Certificate
 - Internship Completion Certificate
 - MD/MS/DNB/DM/M.Ch Degree/Provisional Degree Certificate
 - UG & PG NMC/State Registration Certificate
 - Category/PwBD Certificate (If seat is claimed in reserved category)
 - Experience Certificate, if any
 - NOC from present employer (applicable for those working in Govt./Pvt. organization)
 - > Any other relevant documents (viz. Research Work, Publication etc.)

- b) The candidates are requested to fill the correct details regarding name/age/gender/caste/address/educational qualification and other relevant fields mentioned in the application form.
- c) Once form is submitted, there shall be no provision for making changes in the application form.
- d) Payment of application fees by any other mode viz. Cash, Cheque, Money Orders, Postal Orders, Pay Orders, Banker's Cheques, Postal Stamps, etc., will not be accepted. Such applications will be summarily rejected. The decision of Executive Director, AIIMS Patna in this regard shall be final and binding.

5. <u>RESERVATION:</u>

- The reservation for EWS/OBC-NCL/SC/ST candidates is as per Central Govt. rules and 4% for PwBD candidates (on horizontal basis).
- For OBC-NCL Candidates: Candidate(s) must attach certificate valid for the posts under the Central Government of India which mentions that the Candidates does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 1 year from the last date of application from 07.10.2023 to 06.10.2024 (both dates inclusive). Candidate must submit the OBC certificate issued by the competent authority of Govt. of India in Format given by DOPT/ Govt. of India or for the appointment to the Central Government Job.
- For EWS Candidates: Candidate(s) must attach certificate valid for the posts under the Central Government of India which mentions that the Candidates does belong to EWS category. Date of issue of Certificate should be from 07.10.2023 to 06.10.2024 (both dates inclusive).
 *If no suitable candidate is found in the EWS Category during the selection process, the EWS seat may be converted to General Category.

6. PAY SCALE:

Rs. 67,700/- as per 7th CPC, Level – 11 of the Matrix + NPA plus usual allowances as admissible.

- c) Those who have already completed 03 years of their Senior Residency, are not eligible to apply.
- d) Qualification/Experience will be counted as on 06.10.2024
- e) The final result will be displayed on the website i.e. (www.aiimspatna.edu.in).
- f) Eligibility is subject to verification of the documents on the day of Walk-in Interview.

9. METHOD OF RESOLVING TIES:

All Tie cases (more than one candidate having same marks) have been resolved on date of birth. Older candidate (earlier date of birth) is ranked above younger candidate.

10. REASONS FOR REJECTION/CANCELLATION OF APPLICATION:

APPLICATION/CANDIDATURE OF APPLICANTS IS LIABLE TO BE CANCELLED/ REJECTED IN THE EVENT OF ALL OR ANY OF THE FOLLOWING:

- i. Applications being incomplete.
- Any variation in the Signatures. All the SIGNATUREs in FULL (NOT IN SHORT) done on the Application Form and also on other Documents must be the same.
- iii. Non-payment of application fees through Demand Draft, if not otherwise exempted.
- iv. Fee not paid as per instructions.
- v. Under aged/over aged candidates.
- vi. Failure to bring (in original) all relevant Certificates/Documents issued by the competent authority, along with self-attested legible copies in support of the information given in their Application Forms about their Educational Qualifications; Experiences; Percentage of Marks obtained; Proof of Age; Proof of Category [SC/ST/OBC/EWS/PwBD] at the time of Walk-in Interview and/or verification of document.
- vii. Not having the requisite Educational Qualification/Experience/Category Status as on 06.10.2024
- viii. Incorrect information or misrepresentation or suppression of material facts.
- ix. Any other irregularity.

11. ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT:

- (A) Candidates are warned that they should not furnish any particulars that are false or suppress any material information while filling in the application form. Candidates are also warned that they should in no case attempt to alter or otherwise tamper with any entry in a document or the attested certified copy submitted by them nor should they submit a tampered/fabricated document. If there is any inaccuracy or any discrepancy, an explanation regarding this discrepancy should be submitted.
- (B) Without prejudice to criminal action/debarment up to 3 years from recruitment/examinations conducted by AIIMS, Patna wherever necessary, candidature will be summarily cancelled at any stage of the appointment in respect of candidates found to have indulged in any of the following activities:
 - i. Impersonate/ procuring impersonation by any person.
 - ii. Submitting fabricated documents or documents which have been tampered with.
 - iii. Making statements which are incorrect or false or suppressing material information.
 - iv. Resorting to any other irregular or improper means in connection with his/her candidature for the selection.

- ii. Any Amendment/Rectification/Change/Editing is NOT allowed in Name, Category, and Department and PWBD status. Any change in address, mobile no. and email ID should be intimated to this office immediately.
- iii. The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
- iv. In case, any information given or declaration by the candidate is found to be false or if the candidate has wilfully suppressed any material information relevant to his/her candidature & he/she will be liable to be removed from the institute and any action taken as deemed fit by the competent authority.
- v. The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
- vi. Name of the selected candidates will be displayed in the institute website. No separate individual intimation will be sent. The Institute will not be responsible in any manner if a candidate fails to visit / access the website in time.
