1. The above vacancies are provisional and subject to variation. The Executive Director, AIIMS, Rajkot reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules/circulars and requirements.
2. Reservation will be as per Government of India guidelines issued from time to time.
3. Reservation for Persons with Benchmark Disability (PwBD) will be as per Government of India guidelines in accordance with Notification No. 38-16/2020-DD-III dated 04.01.2021 issued by the Ministry of Social Justice and Empowerment, Govt. of India or as identified by the Institute considering the functional/physical requirements of the post.
4. Reservation for Economically Weaker Sections (EWSs) shall be applicable as per Govt. of India, Office Memorandum No. 36039/1/2019-Estt (Res) DoPT dated 19th January, 2019 and 31st January, 2019: EWSs Candidates will attach certificate issued by the competent authority in the form prescribed as per Annexure – EWS.
5. As per EWS guidelines posts are not carried forward/or considered as backlog vacancy in case unfilled; hence other category candidates will be allowed provisionally to apply for post subjected to condition that they will be considered for the post as an UR Candidate only, if EWS category seat is otherwise not filled.
6. Age and all other qualification will be counted as on the last date of submission of application (crucial date).
7. Overseas Citizen of India (OCI) cardholders under section 7(A) of Citizenship Act, 1955 are also eligible to apply for teaching post as per Ministry of Home Affairs Order No. 26011/52/2016- OCI dated 02nd August, 2018.
8. The period of experience wherever prescribed shall be counted after obtaining the prescribed qualification, on the last date of application (crucial date).
9. The posts of Professor/ Additional Professor is also open for Deputation:
  - a) In case of Deputation, the terms and conditions shall remain same with the stipulation that the OMs of DoPT on Deputation shall be applicable. The candidate has to submit a NOC and Vigilance Clearance certificate from the current employer. There will be no reservation while considering deputation applications. The initial period of Deputation shall be three years, extendable/ curtailable as per the discretion of the competent authority. The terms of Deputation are further governed by MoH&FW OM dated 20th November 2017, which amongst others states the following:
    - i. Faculty drawn from Institutes of National Importance and Government Medical Colleges may be recruited on Deputation.
    - ii. The Deputation can be of maximum 7 years. As of now the initial Deputations are being considered for 3 years, as the Institute is in establishment phase which are further extendable as per provisions.

iii. Terms of Deputation shall be regulated by relevant DoPT OMs and Government of India Instructions, and Circulars/order from MoH&FW, from time to time.

- b) Maximum age limit is 56 years as on the Crucial date

- d) Applications without vigilance clearance and APAR/ACR Dossiers will not be considered.

**3. Those who have undergone DNB training from Institutions given under para 2 at (a) and (b) of aforementioned MCI notification-will not need to have extra experience after qualifying degree. Those who have undergone DNB training at Institution given at (c) and (d) of aforementioned MCI notification will need to have 1 year and 2 years extra experience i.e. total 4 & 5 years' experience respectively from MCI recognized/ permitted Institution for equivalence.

**GENERAL CONDITIONS:**

1. All the posts carry usual allowances as admissible to Central Autonomous Body (like other AIIMS) / Central Government Employees of similar status at Rajkot, Gujarat.
2. This is a '**rolling advertisement**' and will be used to fill the unfilled-posts by issuing subsequent notifications on the website- [www.aiimsrajkot.edu.in](http://www.aiimsrajkot.edu.in) for at least one-year and till the Notice of closure, without the need to re-publish. **3. Application Process:**

- a. The aspiring applicants satisfying the eligibility criteria in all respect should apply through ON-LINE

application mode only. The applicants applying for deputation posts of Professor and Additional Professor have to send the applications offline to AIIMS Rajkot (Application Format attached on page no. 15). The Online registration of applications will be on the official website of AIIMS, Rajkot i.e. [www.aiimsrajkot.edu.in](http://www.aiimsrajkot.edu.in) The notification for date of activation of link for submission of online applications in respect of above said posts along with other relevant information will be subsequently notified on the Institute's website.

- b. The candidate must ensure that their photo, signature and thumb impression should be clearly visible in preview at the time of online application. If photo/signature/thumb impression image is displayed small or not visible in preview on website, that means photo/signature is not as per the AIIMS, Rajkot prescribed guidelines and in that case, their application can be rejected. So, candidates are advised to be very careful while uploading their photo and signatures. Both must be visible clearly on Online Application Form before final submission.
- c. No documents including online application form is required to be sent physically, however, all the applicants are advised to keep a hard copy of online application forms with them along with proof of payment (a copy of online payment receipt) for their records.

4. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling eligibility criteria as on the closing (crucial) date of applications failing which their application will be rejected.

5. The candidature of such applicants who fails to complete the application submission by the stipulated date and time will not be considered and no correspondence in this regard will be entertained.

10. Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/ PwBD will be considered subject to production of Caste Certificate issued by the appropriate/ competent authority on the prescribed format. Community should be clearly and legibly mentioned in the certificate. OBC candidate's eligibility will be based on the caste(s) borne in the Central List of Government of India. OBC candidate(s) should not belong to Creamy Layer and their sub-caste should be match with the entries in Central List of OBC, failing which their candidates will not be considered under any of the applied reserved category post(s).

11. Person with Disabilities (PwD) /candidate(s) with benchmark disability will be allowed in accordance with Ministry of Social Justice and Empowerment's, Notification No. 16- 15/2010DD.III dated 29th July, 2013 as amended from time to time, in the above recruitment process. Further, only such persons would be eligible for reservation under PwBD quota in service/posts who suffer from not less than 40% of physical disability.

12. Persons who want to avail the benefit of reservation would have to submit a Disability Certificate issued by a competent authority in prescribed format.

**13. Clearances:** Appointments are subject to clearances as for equivalent posts in Government of India.

**14. Qualifications and Experience:** The experience will be counted as on last date of submission of application; The experience is counted after obtaining the qualifying degree/PhD.

15. Short Listing: The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection. Based on the format (Appendix 1), the Selection Committee may short-list candidates for interview if the vacancy candidate ratio exceeds 1:6. Candidates called for interview will have to produce all relevant original documents in proof of details furnished in their application at the time of interview.

a) The candidates may note that the proceedings of the Standing Selection Committee are confidential and under no circumstances the minutes will be disclosed to the participants. Reserve category candidates applying for unreserved posts will be treated as unreserved candidates.

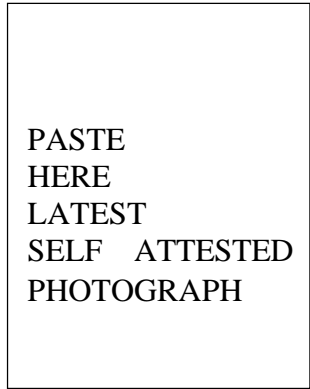
