Instruction for Deputation Basis: -

- Any number of vacancies can be **DECREASED/CANCELLED** before/after interview without reasons. No intimation on same will be provided.
- The Maximum age limit for applying for the afore said posts on deputation is **58 years** for the post of Medical Superintendent, while other remain posts are **56 years** as on last date of receipt of application.
- The period of deputation shall be initially for 3 years as per DoPT norms / Govt. of India rules.
- Experience and age will be calculated by last date to receive application forms i.e. __. __. **2025**
- The Officers/Officials, who fulfil the specified eligibility conditions may submit their application in the prescribed Performa as **Annexure – A** through proper channel along with attested copies of all relevant certificates to be sent to “**Recruitment Cell, All India Institute of Medical Sciences, Rishikesh, Uttarakhand, Pin-249203**” super scribing the envelope “**Application for the post of on deputation basis**” by Speed Post/Registered Post ONLY.
- While forwarding their applications, it may be ensured that the particulars of the candidates are verified and that they fulfil the eligibility conditions. The qualification/eligibility prescribed is minimum requirement and the same does not automatically make candidates eligible for selection. Based on bio-data, the Institute will short-list candidates who may be called for Interview. The candidates have to produce all relevant original documents as proof of details furnished in their application at the time of selection.
- Application of eligible officers may be forwarded through proper channel along with:
 - Duly attested photocopies of Confidential Reports of the applicant (last five years);
 - Vigilance Clearance Certificate duly signed by an authorized officer clearly indicating that no disciplinary or criminal proceedings are either pending or contemplated against the officer concerned;
 - Latest Salary Slip mentioned with designation and grade pay & Level.
 - Statement showing the minor/major penalties imposed, if any, and
 - A certificate about the integrity of the Officer recommended for on Deputation. Application without vigilance clearance and attested copies of CR Dossiers **will not be considered**. The candidates have to produce all relevant original documents as proof of details furnished in their application at the time of interview. **Application received without the proper channel will not be considered for interview.**
