### SELECTION PROCEDURE

- The applications received will be scrutinized by the Screening committee.
- Skill test will be held for the post of Data entry operator, a day prior to the day of interview.
- In case of a large number of eligible candidates after scrutiny of applications for the remaining posts, and if it is not feasible to call all for interview (maintaining a 1:5 post-to-interviewee ratio), the PI requests to reserve the right to apply higher criteria for shortlisting for the interview. A written/skill test may be conducted, or a merit-based screening process (relevant experience, higher educational qualifications, and research publications) may be adopted to shortlist the candidates for the interview.
  - ➤ Candidates appearing for the interview must possess the above-mentioned documents in original at the time of interview.

#### **Terms and Conditions**

- Method of recruitment may be Written exam / Interview or both.
- Selection is based purely on merit
- The Selected candidate will have to join within 7 days of declaration of results.
- It is NOT a permanent employment with AIIMS Rishikesh, co-terminus with the project & the candidate will have No right to claim for permanent Employment under ICMR/AIIMS, Rishikesh or continuation of his/her services in any other project.
- The posts are purely on contract basis; The contract will be valid for 11 months or until the completion of the project, whichever is earlier, and may be extended further—up to a maximum of



three years—subject to continued project funding and performance review.

- Employee Performance Indicator will be applied.
- NO claim for any other regular post in AIIMS Rishikesh shall be entertained.
- Candidate must bring the completely filled application form at the time of interview.
- Incomplete applications or applications received after the due date will not be considered.
- No TA/ DA will be paid for the interview.
- Experience should have been gained after acquiring minimum essential qualification.
- Mere filling the essential qualification doesn't guarantee selection.
- Persons already in regular time scale service under any government organization/ department are not eligible to apply
- Age relaxation shall also be applicable for SC, ST & OBC candidates as per Govt. of India/ICMR Norms
