Incomplete or late applications will not be considered.
- 2. Candidate must bring a printed copy of duly filled application form with a two recent passport size colour photo, and all relevant documents in original (arranged serially as attached); with one set of self-attested photocopies, in proof of his/her qualifications (all certificates/mark-sheets 10th Std. onwards), working experience, age, caste and photo id [Aadhar Card/Indian Passport/PAN Card/Driving License] etc., failing which his/her candidature will not be considered.
- 3. Submission of wrong/false information during the process of selection shall disqualify the candidature at any stage.
- 4. The Executive Director (AIIMS Rishikesh) and the appointing authority reserves the right to consider or reject any application/candidature without assigning any reason. Any correspondence regarding this matter shall not be entertained.

- 6. Candidates already in regular time scale service under any Government Department/ Organizations are not eligible to apply.
- 7. Candidates will be short-listed for interview based on essential and desirable qualifications. Mere fulfilling the essential qualification does not guarantee the selection. The candidate's selection will be through Interview Committee and its decision will be final. The Institute may also conduct written / skill test, if required.
- 8. Qualification, experience, other terms and conditions may be relaxed/ altered at the discretion of Director AIIMS Rishikesh / Recruitment Committee.
