All India Institute of Medical Sciences, Mangalagiri is a healthcare Institute of National Importance, established by the Ministry of Health & Family Welfare, Government of India under the Pradhan Mantri Swasthya Suraksha Yojna (PMSSY), with the aim of correcting regional imbalances in the availability/reliable tertiary healthcare services and also to augment facilities for quality medical education in the country.

Online applications are invited from eligible Indian citizens for the Non-Faculty Group-C posts on DIRECT RECRUITMENT BASIS in All India Institute of Medical Sciences, Mangalagiri, Andhra Pradesh.

1. IMPORTANT INSTRUCTIONS TO CANDIDATES:

- i. The portal for online application for these posts will be available on the website of AIIMS Mangalagiri (www.aiismangalagiri.edu.in) as per the following schedule:

- ii. The above vacancies are provisional and subject to variation. The Executive Director, AIIMS Mangalagiri reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India Rules/Circulars and requirements. The Institute may cancel the advertisement or cancel selection of any of the post(s), as felt necessary.
- iii. Reservation will be as per Government of India Policy.
- iv. 4% of the total vacancies are horizontally reserved for PwD candidates with bench mark disability as per the rules. The RPWD Act, 2016/DoPT instructions as applicable in this regard will be strictly followed.
- v. The cut-off date to determine the maximum age limit, essential qualification & experiences will be **counted as on the last date of submission of 'On-line application', i.e., XX.XX.2026.**
- vi. The period of experience wherever prescribed shall be counted after obtaining the prescribed essential qualifications.

2. ELIGIBILITY CRITERIA:

3. IMPORTANT NOTE TO THE CANDIDATES:

- i. All the posts carry usual allowances as admissible to Central Government Employees of similar status as stationed at AIIMS, Mangalagiri.
- ii. **Application Process:-**The aspiring applicants satisfying the eligibility criteria in all respect can submit their application only through **ONLINE** mode. The On-line registration of application is made available on AIIMS, Mangalagiri official website i.e., www.aiimsmangalagiri.edu.in.
- iii. Candidates must fill all the fields of online application form **correctly**. There is no provision for correcting the details after submission of online application form. Request for change in any information at later stage will not be considered.
- iv. *Candidates who wish to apply for more than one post should apply separately for each post and pay the applicable fee for each post through online/digital mode only.*
- v. For filling up of Online application, candidates must have the following pre-requisites ready.
All necessary documents to be uploaded as single PDF:
 - (a) Valid e-mail-id.
 - (b) Scanned Passport size photograph of candidate
 - (c) Scanned Signature of the candidate
 - (d) Date of Birth certificate/10th/Matriculation Certificate.
 - (e) All necessary Educational Certificates as per qualification criterion
 - (f) Caste Certificate (if any)
 - (g) PWBD Certificate (if any)
 - (h) Any other details/documents required as per the advertisement
- vi. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must be fulfilling all eligibility criteria as on the closing date of applications failing which their application will be rejected. In case it is found that they are not fulfilling any of the criteria at any stage, their candidature will summarily be rejected at any stage.
- vii. The candidate must ensure that their photo and signature should be clearly visible in preview at the time of filling of application in online mode.
- viii. The On-line application will be closed on the last date of the receipt of application.
- ix. The candidature of such applicants who fails to complete the online application submission by the stipulated date and time will be treated as incomplete and no correspondence in this regard will be entertained.

4. METHOD OF SELECTION:

- i. The mode of Selection will be done on the basis of performance of candidate in written test in the order of merit subject to qualifying the 'Skill Test' (if conducted) and fulfilling the eligibility criteria by candidates during document verification.
- ii. Skill test, if decided, will be conducted only for shortlisted candidates (in the order of merit to a certain extent with reference to the number of vacancies). It will be qualifying in nature. The date and details of skill test will be notified on the website of AIIMS Mangalagiri in due course.
- iii. Syllabus & Scheme of examination for each post will be notified in due course of time on the institute website.

5. AGE RELAXATION: -

- i. Crucial date to determine eligibility in terms of the age of candidates will be the closing date of online registration as mentioned in the advertisement or any subsequent notices published on website.
- ii. SC/ST/OBC candidates who opt to apply for unreserved vacancies will not be eligible for age relaxation or relaxation in cut-off marks. Further, reserve category candidates (SC/ST/OBC) who become eligible by age relaxation applicable in their case will be considered only for reserved seats of the category to which they belong even if they have the merit to be considered as UR.
- iii. In pursuance of guidelines contained in DOPT OM No. 1667569393892 dated 06.09.2022, the age concession to the persons with disability shall be admissible irrespective of the fact whether the post is reserved for person with disability or not, **provided the post is identified suitable for relevant category of disability.**
- iv. PWBD candidates with disabilities mentioned in Section 34 (1) of Rights of Persons with Disability Act, 2016, and as identified by the Institute for the advertised posts as above, provided they have benchmark disability of equal to or more than 40%.
- v. Age relaxation is permissible to various applicants is as under : -

Age relaxation to any other category will be as per the Government of India rules.		
Candidates belonging to SC/ST/OBC category who are also coming under the category of Ex-servicemen or PwBD or Govt. employees or other above-mentioned categories will be eligible for grant of cumulative age-relaxation under both categories, if they apply for the posts reserved for their category.		
All the above-mentioned relaxations in upper age limit shall be permissible only on fulfillment of terms and conditions mentioned in the relevant rules.		

NOTE-I: Ex-servicemen who have already secured employment in civil side under Central Government on regular basis after availing of the benefits of reservation given to Ex-Servicemen for their re-employment are **NOT** eligible for claiming benefits of reservation under EXS category. However, they are eligible for age relaxation as per rules.

NOTE-II: The period of "Call up Service" of an Ex-Serviceman in the Armed Forces shall also be treated as service rendered in the Armed Forces for purpose of age relaxation, as per rules.

NOTE-III: For any serviceman of the three Armed Forces of the Union to be treated as Ex-Serviceman for the purpose of securing the benefits of reservation, he must have already acquired, at the time of submitting his/her application for the Post, the status of ex-serviceman and /or is in a position to establish his acquired entitlement by documentary evidence from the competent authority that he would complete specified term of engagement from the Armed Forces within the stipulated period of one year from the CLOSING DATE FOR RECEIPT OF APPLICATION or otherwise than by way of dismissal or discharge on account of misconduct or inefficiency.

EXPLANATION: An 'ex-serviceman' means a person –

(i) Who 'has served in any rank whether as a combatant or non-combatant in the Regular Army, Navy and Air Force of the India Union, and

(a) Who either has been retired or relieved or discharged from such service whether at his own request or being relieved by the employer after earning his or her pension; or

(b) Who has been relieved from such service on medical grounds attributable to military service or circumstances beyond his control and awarded medical or other disability pension; or

(c) Who has been released from such service as a result of reduction in establishment; or

(d) Who has been released from such service after completing the specific period of engagement, other than at his own request, or by way of dismissal, or discharge on account of misconduct or inefficiency and has been given a gratuity; and includes personnel of the Territorial Army, namely, pension holders for continuous embodied service or broken spells of qualifying service; or

(e) Personnel of the Army Postal Service who are part of Regular Army and retired from the Army Postal Service without reversion to their parent service with pension, or are released from the Army Postal service on medical grounds attributable to or aggravated by military service or circumstance beyond their control and awarded medical or other disability pension; or

(f) Personnel, who were on deputation in Army Postal Service for more than six months prior to the 14th April, 1988; or

(g) Gallantry award winners of the Armed forces including personnel of Territorial Army; or

(h) Ex-recruits boarded out or relieved on medical ground and granted medical disability pension.

NOTE-IV: AGE CONCESSION IS NOT ADMISSIBLE TO SONS, DAUGHTERS AND DEPENDENTS OF EXSERVICEMEN.

NOTE-V: A Matriculate Ex-Serviceman (includes an Ex-Serviceman, who has obtained the Indian Army Special Certificate of education or corresponding certificate in the Navy or the Air Force), who has put in not less than 15 years of service as on closing date for receipt of application with Armed Forces of the Union shall be considered eligible for appointment to the Group "C" posts being advertised through this examination. Thus, those Non-Graduate Ex-Servicemen who have not completed 15 years of service as on the closing date for receipt of application or would not complete 15 years of service within the time limit specified in Note-III are not eligible to apply for this examination.

6. GENERAL INSTRUCTIONS:

- i. **Date(s) of valid OBC(NCL) certificate:** Candidates applying under OBC category must produce the valid caste certificate in the format provided by the DoP&T vide O.M No. 36036/2/2013-Estt. (Res.) dated 30.05.2014 and further clarification issued by DoP&T OM No. 36011/1/12-Estt.(Res.) dated 14.03.2016. The certificate must mention the non-creamy layer status of the applicant (Non-creamy layer status issued by an authority mentioned in DOPT Office Memorandum no. 36012/22/93-Estt. (SCT) dated 8.9.1993). The OBC applicants who belong to the 'Non-Creamy Layer' and whose caste appears in the Central List of the OBCs (notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes available at the website <http://ncbc.nic.in>, shall be eligible to be considered under the OBC category (Validity period of OBC Certificate in respect of non-creamy layer status of the applicants as per DOPT Office

Memorandum No. 36036/2/2013- Estt. (Res-I) dated 31 March 2016). The validity of the non-creamy layer certificate should **issued on or after 01st April, 2026 to last date of application**. If the applicant does not have the OBC non-creamy layer certificate valid at the time of registration, the applicant must upload the previously issued (older) OBC non-creamy layer certificate with the acknowledgement slip of the OBC non-creamy layer certificate application for renewal. However, at the time when asked to submit/upload the valid certificate, the applicant must produce the applicable valid certificate within the date as applicable along with old certificate. This additional certificate (if any) must have a reference of his/her already issued original caste certificate.

- ii. **Date(s) of valid EWS certificate:** - The vacancies advertised under EWS Category are as per the instructions issued by DoPT, Ministry of Personnel, Public Grievances & Pension, Govt. of India, vide OM. No. 36039/1/2019-Estt (Res), dated 31.01.2019. Application under EWS category will be considered subject to submission of Income and Assets certificate on a prescribed format issued by the competent authority and subject to verification of genuineness of the certificate by the issuing authority. In pursuance to DoP&T OM No. 36039/1/2019-Estt (Res), dated 31.01.2019, a EWS certificate issued in prescribed format for employment in Central Government on the basis of income of the financial year **issued on or after 01st April, 2026 to last date of application**.

*Language of Certificate should be in Hindi/English Language and in prescribed format for central Government. Candidates who fail to produce valid category certificate OBC/EWS/SC/ST/PwBD etc during document verification or as and when required to produce the same, the candidature will be cancelled.

Any EWS certificate issued beyond above said dates will be treated as invalid.

- iii. **All candidates are advised to obtain required valid category certificate in advance to avoid cancellation of candidature at any stage of the recruitment process.**

- iv. Candidates who have claimed the reservation category and failed to produce a valid category certificate as applicable as per published criteria the candidature shall be cancelled in the reserved category, and allocated seats shall be forfeited.

- v. Reservation for PwBD will be as per the guidelines /Instruction contained in DoP&T OM No. 36035/02/2017-Estt (Res) dated 15.01.2018 with regard to reservation for persons with disabilities. Only such persons would be eligible for reservation under PwBD quota in service/posts who suffer from not less than 40% of physical disability. Person who wants to avail the benefit of reservation would have to submit a Disability Certificate as issued by a Competent Authority in prescribed format. However, the candidature of PwBD applicant is subject to evaluation by a Medical Board duly constituted by the Executive Director of respective AIIMS or by the respective institute. This Medical Board will evaluate suitability of candidates for the post he/she is being considered for. All the instructions of Govt. of India as amended and as applicable in this matter will be followed.

- vi. Ex-servicemen (Ex-SM) who have already secured employment in civil side under Government in Group 'C' or 'D' posts on regular basis after availing the benefit of reservation giving to ex-servicemen for their reemployment are not eligible for reservation in Ex-SM category. However, such candidate can avail of the benefit of reservation Ex-SM for subsequent employment, if he/she immediately after joining civil employment, gives self-declaration cum under taking to the concerned employer about the various vacancies for which he had applied for before joining the initial civil employment as mentioned in the DOPT OM dated 14/08/2014.

- vii. A Matriculate Ex-Servicemen (non-graduate Ex-Serviceman, who has obtained the Indian Army Special Certificate of Education or corresponding certificate in the Navy or the Air Force) who has put not less than 15 years of service with the Armed Forces of the Union shall be considered eligible for appointment to the reserved vacancies for Ex-SM in Group 'C' posts.

- viii. **Qualification and Experience:** Qualification and experience as prescribed may be relaxed in exceptional cases at the discretion of the Competent Authority. The experiences will be counted as on the last date of submission of 'On-line application'.

- ix. Candidates applying for **Group B & C posts need not to send hard copies**. However, **they must keep a PDF copy and/or print out of online application form with them**. It will be required with some other documents in support of their eligibility during document verification (DV) or whenever asked for.

- i. The candidate can pay the prescribed application fee through DEBIT CARD/CREDIT CARD/ NETBANKING. Transaction / Processing fee, if any, as applicable, will be payable to the bank by the candidate.
- ii. Application fee once remitted shall not be refunded under any circumstances.
- iii. Candidates applying in more than one post have to apply separately for each post by paying the examination fee separately for each post.
- iv. **Application fee, once remitted, shall not be refunded under any circumstances even if rejection of application due to ineligible for that applied post.**
- v. Applications without the prescribed fee would not be considered and summarily rejected.
- vi. **Application Fees of SC/ST candidates who appear in the Examination/Interview will be refunded in their source (debited) account after the declaration of results in due course of time.**

8. The applicants already in Government service shall have to produce **No Objection Certificate (NOC)** from their present employer at the time of Document verification. Therefore, while applying for the post, candidates have to take prior permission from their employer in case of Government service.

9. **The decision of the AIIMS Mangalagiri in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, mode of selection, conduct of Screening Test, examination centers etc. will be final and binding on the candidates and no enquiry / correspondence will be entertained in this regard.**

10. *No TA/DA will be paid for appearing Computer based test/ Skill test/at any stage of selection process.*

11. *In the event of tie in scores of candidates in CBT/ examinations, merit will be decided by applying following criteria, one after another in the order given below, till the tie is resolved:-*

- a) *By using marks secured in concerned Subject of respective post: candidate with high score in concerned subject specific for the post (if any) in CBT will be placed higher in the order of merit.*
- b) *By using number of wrong answers: candidate with less wrong answers (negative marks) in CBT will be placed higher in order of merit.*
- c) *By date of birth: older candidate will be placed higher in the order of merit.*
- d) *By alphabetical order in which the names of the candidates appear.*

12. OTHER CONDITIONS

- i. The All India Institute of Medical Sciences Mangalagiri is an autonomous body established by an Act of the Parliament.
- ii. Service under the Institute is governed by AIIMS Act and the Rules & Regulations framed there under.
- iii. **Probation period:** The period of probation is two years.
- iv. **Medical Fitness:** Appointment of selected candidates is subject to his/her being declared medically fit by the competent Medical Board.
- v. The applicants, who do not have requisite qualifications / experiences as advertised as on the last date for submission of applications, will not be considered. However, in case they are called for Screening Test (Computer Based Test) and appeared for the test does not confer any rights for selection in case they are found not meeting eligibility criteria later on.
- vi. Incomplete application(s) will be summarily rejected. Applications received after the last date of submission of application will not be considered.

- vii. The period of experience wherever prescribed shall be counted after obtaining the prescribed essential educational qualification.
- viii. The employees of the Institute will be governed by the New Pension Scheme as per the provision contained in the Ministry of Finance, Department of Economic Affairs (ECB&PR Division). Notification No.5/7/2003-ECB&PR dated 22.12.2003.
- ix. The post(s) is/are whole time and will not engage in any trade or business or undertake any employment full-time or part-time while in the service of the Institute without the explicit permission of the Director or the Officer authorized by him/her in this behalf.
- x. AIIMS Mangalagiri reserves the rights to increase or decrease the number of vacancies.
- xi. Candidates should note that their candidature will remain provisional till the veracity of the document submitted by them is verified by AIIMS, Mangalagiri.
- xii. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of offer of appointment letter, the institute reserves the right to modify/withdraw any communication made to the candidate.
- xiii. While every effort will be made to provide residential accommodation to the staff appointed at the Institute subject to availability but in view of the paucity of the residential accommodation in the campus it may not be possible to provide accommodation in every case. In the event that no accommodation is provided, necessary H.R.A. as admissible to Central Government Servants of similar status stationed at Mangalagiri, Guntur (Dist), Andhra Pradesh will be provided.
- xiv. Canvassing of any kind will be a disqualification.
- xv. The candidate should not have been convicted by any Court of Law.
- xvi. In case any information given or declaration by the candidate is found to be false or if the candidate has willfully suppressed any material information relevant to this appointment, he/she will be liable to be removed from the service and any action taken as deemed fit by the Appointing Authority.
- xvii. The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice. Any corrigendum / addendum/ amendment to this advertisement and further details about Screening Test (Computer Based Test)/ Skill test will only be posted in our website. Therefore, candidates are advised to regularly visit our website for any updates about this advertisement & selection process.
- xviii. The decision of the Competent Authority regarding CBT, verification of documents and selection would be final and binding on all candidates. No representation/correspondence will be entertained in this regard.
