Executive Director, AIIMS Nagpur invites application in prescribed format from Indian National for the post of Senior Resident as per Residency Scheme of Govt. of India. The post of SR is a **tenure post for duration of maximum 03 years**.

DETAILS

1. Age and Experience will be counted as on the closing date of receipt of application i.e 17/09/2026.
2. Selection will be made on the basis of interview conducted at AIIMS Nagpur. The date of interview will be notified on AIIMS Nagpur website. The decision of Executive Director, AIIMS in this regard shall be final and binding. The interview may be spilled over to next day. Therefore, Candidates should be prepared to be available for next day also, if necessary.
3. In case large numbers of applications are received, short listing of candidates for interview will be done based on their qualification, additional qualification, experience etc., or through a written test.
4. The candidates who wish to appear for the interview may please make payment online as furnished above and send copy of the payment receipt along with application and all relevant copies of certificates, by Google form <https://forms.gle/Di3JuZ9vzKQF7Nuh9> to on/before by 17/09/2026 by 5 pm.
5. The candidates must bring the filled-in application form (Annexure I) along with all the original certificates and one set of self-attested photocopy of all the certificates on the scheduled date of interview. In case the original certificates have been submitted to the parent institute, the candidate must bring the original holding certificate.
7. Candidates who wish to apply for more than one post should apply separately for each post.
8. Only those candidates who have been declared successful in their qualifying degree exam and will be completing their tenure for the same on or before the closing date of application will be eligible.

9. In cases where result of qualifying exam is declared after the closing date of application, their candidature will stand cancelled and no claim for selection on the basis of interview will be considered.
10. The above vacancies are provisional and subject to variation. The Executive Director, AIIMS, Nagpur reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules/circulars and requirements. The reservation will be followed as per Government of India Rules.
11. The aspiring applicants satisfying the eligibility criteria in all respect can appear in the interview.
12. The decision of Executive Director, AIIMS Nagpur in this regard shall be final and binding. The offer of appointment when made will be provisional and subject to verification of credentials (Educational & Personal) by competent authority. The vacancies are provisional and subject to variation. The Executive Director, AIIMS, Nagpur reserves the right to vary the vacancies including reserved vacancies. No correspondence whatsoever would be entertained in this regard.

14. Those who are working in Central/State Government/Semi Government/ Autonomous Institution must submit a "NO OBJECTION CERTIFICATE" from the employers at the time of interview.
15. Self-Attested photocopies of Degrees, Certificates, Mark sheets, Age proof, Caste certificates etc. may be annexed to the hard copy of the application and the same shall be produced in original along with photocopy for verification **at the time of interview.**
16. **Caste/Category Certificates:**

(A) OBC Category

- i. The vacancies are being advertised in financial year **2026-2027**, therefore, valid NCL-OBC certificate issued during the period **from 01.04.2026 to 31.03.2027** will be considered valid. Candidature who have OBC-NCL certificate issued before or after this period (i.e **01.04.2026 to 31.03.2027**) will not be considered valid for this advertisement.
- ii. Candidates applying under OBC category must produce the valid caste certificate in the format provided by the DoP&T vide O.M. No. 36036/2/2013-Estt. (Res.) dated 30.05.2014 and further clarification issued by DoP&T OM No. 36036/2/2013-Estt(Res-I) dated 31.03.2016.
- iii. **Certificate must be valid for employment in Central Government Institutions.** OBC candidate's eligibility will be based on Castes borne in the Central List of Govt. of India. **Their Sub-caste should also match with the entries in Central List of OBC, failing which their candidature as OBC candidate will not be considered.** The OBC certificate should clearly show that the applicant does not belong to the Creamy Layer.

(B) EWS Category

- i. The vacancies advertised under EWS Category are as per the instructions issued by DoPT, Ministry of Personnel, Public Grievances & Pension, Govt. of India, vide OM. No. 36039/1/2019-Estt (Res), dated 31.01.2019.
- ii. Application under **EWS category will be considered subject to submission of Income and Assets certificate on a prescribed format issued by the competent authority** and subject to verification of genuineness of the certificate by the issuing

authority. As per DoP&T OM No. 36039/1/2019- Estt (Res), dated 31.01.2019, the crucial date for submitting income and asset certificate by the candidate is the closing date for receipt of application for the post, except in cases where date is fixed otherwise.

17. **For eligibility to applying for these posts upper age limit as on closing date will be 45 years.**
18. Age limit refers to completed age as mentioned in eligibility criteria, in years as on closing date.
19. The upper age limit for candidates with DM/M.Ch degree applying for these posts will be 45 years. The age limit is further relaxable for SC/ST candidates, OBC candidates & OPH candidates as below.
20. Age relaxation of 5 years for SC/ST, 3 years for OBC candidates. No age relaxation would be available to SC/ST/OBC candidates applying for unreserved vacancies.
21. In the case of Persons with Disability (PWD) candidates, age relaxation up to maximum period of 10 years for General Category, 13 years for OBC category and 15 years for SC/ST category candidates.
22. **For Persons with Disability (PWD): 4% of the total posts will be horizontally reserved for Pwd Candidates with bench mark disability as per Reservation Rules. The RPWD Act/DoPT instructions as applicable in this regard will be strictly followed.**

TERMS & CONDITIONS

1. Vacancies arising out of non-filling/resignation may be filled in a subsequent notified date through rolling advertisement.
2. The candidate who is already in government service shall submit 'No Objection Certificate' from the present employer at the time of Interview.
3. Canvassing of any kind will lead to disqualification. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
4. The appointment shall be as per Govt. of India's Residency Scheme. The appointment can be terminated at any time, on either side, by giving one month's notice or by paying one month's salary, without assigning any reason or failure to complete the period of three months to the satisfaction of competent authority. The appointee shall be on the whole time appointment of the AIIMS and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract. He/She is expected to conform to the rules of conduct and discipline as applicable to the institute employees. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
5. The total residency period is of 3-year duration. If the candidate has worked as a senior resident in any Govt. medical institution, whether on regular or ad-hoc / Contract basis, the duration of Senior Residency already done will be reduced from the 3 years tenure to be offered.
6. **The initial tenure of appointment shall be for a period of one year, which may be extended up to a maximum of three years, subject to the approval of the Competent Authority and satisfactory performance of the candidate.**
7. Applicants should not have completed 3 years Senior Residency under Residency Scheme in any Govt. medical institution, whether on regular or on ad-hoc / Contract basis. The duration of Senior Residency already done will be reduced from the 3 years tenure to be offered.
8. If an appointee wishes to apply somewhere else or resign within the first 03 (three) months of joining, then neither he/she will be issued a No Objection Certificate (NOC) nor he/she will receive any Relieving Letter or Experience Certificate.
9. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
10. The candidate should not have been convicted by any Court of Law.

11. In case of any information given or declaration by the candidate is found to be false or if the candidate has will-fully suppressed any material information relevant to this appointment, he/she will be liable to be removed from the service and any action taken as deemed fit by the appointing authority.
12. The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
13. Incomplete applications in any aspect will be summarily rejected.
14. The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
15. Leave entitlement of the appointee shall be governed in terms of instructions contained in DoPT& T's O.M. No.12016/3/84/Estt.(L) dated the 12th April,1985 as amended by OM No.12016/1/96/Estt.(L) dated the 5th July, 1990.
16. All disputes will be subject to jurisdictions of Court of Law at Nagpur.
17. The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
18. Appointment of selected candidates is subject to his/her being declared medically fit by competent Medical Board
19. Name of the shortlisted candidates will be displayed in the institute website. No separate Individual intimation will be sent. Besides, all information will also be provided through the Institute website only. The Institute will not be responsible in any manner if a candidate fails to visit / access the website in time. 20. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the institute reserves the right to modify/withdraw/cancel any communication made to the candidate.
21. The applicant will be responsible for the authenticity of submitted information, other documents and photograph. Submission of any false and/or suppression/concealment of facts shall lead to rejection/ cancellation of selection/recruitment.
