Online applications are invited from Indian Citizens, as per Government of India Residency Scheme, for the tenure posts of Senior Residents/Senior Demonstrators in various Departments/Specialties of AIIMS, Awantipora, for a maximum period of three years. The applications are being invited by AIIMS, Vijaypur, Jammu, on behalf of AIIMS, Awantipora.

1. **ONLINE APPLICATION:** Please fill the online application carefully. Any amendment / rectification / change / editing is NOT allowed in Name / Date of Birth / Subject applied / Category i.e. SC / ST / OBC(NCL) / UR / PwBD / EWS status etc. Applicants may note that no correspondence will be entertained in this regard.
2. **ELIGIBILITY NORMS:** Based on the information provided in the online application, candidates are provisionally invited to present themselves in person for the interview without any scrutiny of eligibility. However, on the day of interview, documents to determine eligibility w.r.t. to essential qualification(s), age, category, experience, wherever applicable, NOC etc. will be scrutinized by the Institute's scrutiny committee. **Only after the satisfaction of Scrutiny Committee w.r.t his/her eligibility, a candidate will be allowed to appear in the interview for the post.**
 - a) **Cut-off date to determine the eligibility is 27.08.2026 (Thursday).** To be eligible for selection for these posts, the candidate should pass the qualifying degree examination by **27.08.2026 (Thursday)** & the result should be declared to this effect on or before this date. The tenure of qualifying degree should also be completing latest by **27.08.2026 (Thursday).**
 - b) Only those candidates who have been / are declared successful in their qualifying degree exam/viva i.e. DNB/MD/MS/Ph.D. etc. (as applicable) and completing their tenure for the same on or before **27.08.2026 (Thursday)** will be eligible to be considered for these posts.
 - c) Candidate who has appeared for exam / viva voce of qualifying degree and his/her result is yet to be declared then the applicant will be allowed to appear in the interview purely provisionally and subject to the condition that the result should be available by **27.08.2026 (Thursday)**
 - d) In cases where result of qualifying degree / exam is declared after **27.08.2026 (Thursday)**, the candidature will stand cancelled and no claim for selection on the basis of Interview allowed provisionally will be considered.

If ineligibility is detected at any stage, candidature of the candidate will be cancelled without any notice.

3. **CATEGORY CERTIFICATE:**

- a) Candidates applying under OBC category must produce the valid caste certificate in the format provided by the DoP&T vide O.M No. 36036/2/2013-Estt. (Res.) dated 30.05.2014 and further clarification issued by DoP&T OM No. 36011/1/12-Estt.(Res.) dated 14.03.2016. The certificate must mention the non-creamy layer status of the applicant (Non-creamy layer status issued by an authority mentioned in DOPT Office Memorandum no. 36012/22/93-Estt. (SCT) dated 15.11.1993). The OBC applicants who belong to the 'Non-Creamy Layer' and whose caste appears in the Central List of the OBCs (notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes available at the website <http://ncbc.nic.in>, shall be eligible to be considered under the OBC category (Validity period of OBC Certificate in respect of non-creamy layer status of the applicants as per DOPT Office Memorandum No. 36036/2/2013-Estt. (Res-I) dated 31 March 2016). The validity of the non-creamy layer certificate shall be issued from **1st April**

2026 to 27th August, 2026 (Last date of Online Application) valid for Financial Year 2026-2027.

If the applicant does not have the OBC non-creamy layer certificate valid for the financial year 2026-2027 at the time of filing of application form, the applicant must upload the previously issued (older) OBC non-creamy layer certificate with the acknowledgement slip of the OBC non-creamy layer certificate application for renewal. However, at the time of Document Verification/Interview, the applicant must produce the applicable certificate valid for financial year (2026-2027) within the date as mentioned above as applicable. This additional certificate (if any) must have a reference of his/her already issued original caste certificate.

- b) Candidates applying under EWS category must possess valid EWS certificate issued on or after 01 April, 2026. It must be in Hindi/English Language and valid for employment in Central Govt. Institution. ***As per guidelines, an EWS post is not carried forward or considered as backlog vacancy in case it remains unfilled, therefore candidates from other category may be allowed provisionally to apply for the said post subject to the condition that he/she will be considered for that post as a UR candidate only if EWS category seat is otherwise not filled.***

4. **APPLICATION FEE:** Rs. 1500/- (Non-refundable) for General/OBC category candidates, Rs 1000/- (non-refundable) for SC/ST/EWS category. No fee for PwBD candidates.

5. **RESERVATION:**

- a. Reservation for SC, ST, OBC, EWS & PwBD has been provided in the posts in accordance with Rules.
- b. Reservation for Persons with Bench-mark Disabilities [PwBD] candidates having not less than 40% disability is 4% which will be provided on horizontal basis to Persons with Bench-mark Disabilities [PwBD] candidate in their respective categories. The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions and countersigned by Medical Superintendent/CMO/Head of Hospital/Institution.

6. **UPPER AGE LIMIT:**

- a) The upper age limit for applying these posts is **45 years** as on last date of filling of online application form.
- b) Age relaxation will not be applicable to SC/ST/OBC candidates applying for UR vacancies.
- c) The maximum permissible relaxations are:
- i) SC/ST candidates: **5 years**
 - ii) OBC candidates: **3 years**
 - iii) Persons with Bench-mark Disabilities [PwBD] General Category: **10 years**
 - iv) Persons with Bench-mark Disabilities [PwBD] OBC Category: **13 years**
 - v) Persons with Bench-mark Disabilities [PwBD] SC/ST Category: **15 years**
 - vi) The upper age limit in case of Ex-serviceman and Commissioned Officers including ECOs/SSCOs/Government servants shall be relaxed by 5 years in addition to the relaxation above, subject to the condition that on the closing date for receipt of applications, the continuous service rendered in the Armed Forces by an Ex-serviceman is not less than six months after attestation. This relaxation is also available to ECOs/SSCOs who have completed their initial period of assignment of five years of

Military Service and whose assignment has been extended beyond five years as on closing date and in whose case the Ministry of Defence issues certificates that they will be released within one month of Selection from the date of receipt of offer of appointment.

Note: Ex-Serviceman who have already secured regular employment under the Central Govt. in a Civil Post are permitted the benefit of age relaxation as admissible for Ex-servicemen for securing another employment in any higher post or service under the Central Govt. However, such candidates will not be eligible for the benefit of reservation, if any for ex-servicemen in Central Govt. Jobs.

7. GENERAL CONDITIONS:

- a. All applicants are advised to read the Prospectus carefully before starting online registration and ensure that no column is left blank. Once the application form is submitted by the candidate, a copy of it is available for printout in the candidate's portal account. **Applicants must download and take a print out of the filled up Application Form, self-attest every page including attachments and submit it to the Scrutiny Committee on the day fixed for Interview. Please retain a copy of application form till the completion of the recruitment process.**
- b. Candidates who are in-service in any Govt. Hospital/Institutions/Govt. Organization are required to submit their application through proper channel. Alternatively, **he/she must produce No Objection Certificate (NOC) from his/her employer/competent authority on the date of Interview** failing which they may not be allowed to appear in interview.
- c. All candidates are advised to be alert and check AIIMS, Jammu website <https://www.aiimsjammu.edu.in/> regularly. Any corrigendum or revision of the advertisement or any other information regarding this recruitment will be posted on the official website of AIIMS, Jammu only. AIIMS, Jammu will not be responsible for any issue/delay in accessing information / updates by the candidate through the website. Selection of applicants is subject to the verification of eligibility, documents in original etc. as per criteria applicable.
- d. Concealment of any fact(s) w.r.t. to candidature viz essential qualification, age, category, etc. shall lead to cancellation of candidature after appointment / termination of service with disciplinary action. If it is brought to the notice of authorities at any stage that the candidate had not submitted application through proper channel, then candidature will stand cancelled and in case of selected candidate, services may be terminated immediately.
- e. Those who have completed 3 years Residency under Central Residency Scheme are not eligible to apply. Total tenure of Senior Residency (Non-Academic) is 3 years. This includes any period spent as a Senior Resident (Non-Academic) in the same specialty in any other teaching institution prior to joining AIIMS, Awantipora. A candidate who has already rendered his/her services as Senior Resident in any Institute/Hospital of Govt. / Public Sector Undertaking / Autonomous Bodies for a certain period, the balance period will be considered for appointment at this Institute, in a manner that the total period of Senior Residency shall not exceed beyond 03 years.
- f. The performance of appointee may be reviewed by a committee duly constituted by the Executive Director on completion of one year tenure and further extension beyond 1st year or 2nd year may be based on the recommendations of the said review committee. In case the performance is not satisfactory, then further extension may not be considered.
- g. Competent Authority of AIIMS, Awantipora reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India Rules/Circulars and requirements or otherwise.



8. **DETERMINATION OF MERIT:** The selection of candidates will be based purely on interview basis. The Interview will carry 100 marks. The merit list(s) for all categories i.e. SC/ST/OBC/UR/EWS shall be prepared on the basis of interview marks only. All Tie cases (more than one candidate having same marks) will be resolved on the basis of date of birth. Older candidate (earlier date of birth) will be ranked above younger candidate.
9. **SELECTION PROCEDURE:**
- Day wise Interview schedule will be uploaded separately on the AIIMS, Jammu website after the last date of application form.
 - A Candidate can apply only in any one Specialty out of the Specialties as enlisted. In case, a candidate wishes to apply for more than one post/speciality, he/she is required to fill up application form separately and by paying application fees, as applicable.
 - The candidates are required to report for the interview at 9.30 AM at the venue of Interview i.e Board Room, Academic Block, AIIMS Vijaypur Jammu, 181134. After 11.30 AM, the attendance will be closed and no candidate may be entertained.
 - Candidates are required to bring **original certificates (along with TWO sets of self-attested Photocopies)** of following documents for verification. Only those candidates whose certificates are found to be in order shall be permitted to appear for the Interview
 - Date of Birth (i.e. High School/Higher Secondary Certificate/Birth Certificate);
 - Qualifying degree (MBBS / BDS / MD / MS / MDS / Ph.D. / M.Sc. / B.Sc. / DM / M.Ch. / others / as applicable);
 - Valid Permanent/Provisional Registration Certificate issued by MCI or DCI/State Medical or Dental Council/DMC;
 - SC / ST / OBC / EWS / PwBD certificate - valid for central government jobs/PwBD;
 - No objection certificate from current employer (wherever applicable) at the time of Interview; &
 - Completion of tenure and passing proof
 - Identity Proof (Aadhar Card, PAN Card, Driving Licence, Passport etc.)
 - After filling available posts all remaining otherwise eligible candidates called for interview shall be kept in the waiting list, if any, which will be valid for 6 months or till next recruitment whichever is earlier. Any vacancy arising because of non-joining by selected candidates in this selection or by resignation of candidate(s) who had joined after selection in this session may be offered to the candidate from the waiting list according to his/her merit/category.
 - Final Result will only be available on AIIMS website at <https://www.aiimsjammu.edu.in/>.
 - The candidate must submit registration with MCI or DCI/State Medical or Dental Council/DMC, as applicable, at the time of joining the post after selection.
 - In case of any discrepancy, the decision of the Executive Director & CEO of the Institute shall be final in the matter of selection of candidates and no appeal will be entertained in this regard.
 - Selected candidates must join within 15 days or on or before the date stipulated in the letter of selection, failing which the selection shall stand cancelled/withdrawn.
 - The selected candidates must bring the original documents for verification at the time of joining. Without original documents, no candidate is allowed for joining.
 - The rules are subject to change in accordance with the decision of the Institute to be taken from time to time.
 - Any dispute in regard to any matter referred to herein shall be subject to the jurisdiction of High Court of Jammu & Kashmir and Ladakh only.

11. LEAVES: As per residency scheme 1992, leave entitlement of Senior Residents is same as of temporary government servants. Temporary government servants are governed by Central Civil Services (Leave) Rules, 1972. Accordingly, the leave encashment will be given as per the CCS (Leave) Rules, 1972.
