SELECTION CRITERIA:

i. The Online application form will be available at the Institute's website, www.aiimsjammu.edu.in, under "Open Jobs". The last date of submission of the application form online is **23rd March 2026 (Monday), 05:00 PM**.

ii. A list of candidates found provisionally eligible will be uploaded on the official website of AIIMS Jammu.

iii. The applicant will be responsible for the authenticity of the information, other documents, and photographs submitted. If the candidate wants to apply for more than one post, a separate application must be submitted for each post.

iv. Mere possession of the prescribed qualifications and experience does not mean that the candidate will be called for an interview. In case of large number of applications, candidates may be shortlisted based on merit needed for the Project.

v. If the number of applications for each post exceeds 10, then the candidates will be shortlisted. Shortlisting of candidates will be made based on past academic performance, research, field and public health experience.

vi. The candidates falling in the merit may be called in a ratio of 10:1 for the interview or as decided by the competent authority.

vii. Selection of the shortlisted candidates will be based on scores obtained in the interview.

*In case of a tie in the final marks obtained, seniority on the basis of date of birth will be considered for selection. **AIIMS Vijaypur, Jammu reserves the right to cancel/modify the recruitment process at any time, at its discretion.** Only shortlisted candidates will be intimated for an interview by a call letter through email. Interviews will be conducted in person at AIIMS Vijaypur, Jammu Campus.*

Syllabus for assessment:

The topics of assessment will focus on Health Policy and Systems research, Mental Health, Reproductive and Child Health, Research Methodology, Basic Epidemiology, and Project Management. In addition, the assessment will include data management, analysis and reporting.

Place of posting: -

Selected candidates are expected to work from AIIMS Vijaypur, Jammu campus. However, the engaged staff is expected to do extensive travel in the Samba district/ICMR headquarters in the interest of research work.

Terms and conditions of appointment: -

1. The appointment is purely on CONTRACT BASIS which can be extended depending on candidate's performance, project requirement and availability of fund. If the contract is not extended further, the same will lapse automatically. The appointment can also be terminated at any time, by either side, by giving one month's notice or by paying one month's salary without assigning any reason. Candidates should note that their appointment will be for the Project only, and they will NOT be treated as regular employees of AIIMS Jammu for any purpose.
2. No other/ additional allowances other than the consolidated salary mentioned will be admissible. The appointee shall NOT be entitled to any of the benefits available to other employees of AIIMS Jammu appointed on a regular basis.
3. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
4. The appointee shall not have any right or claim to an appointment, extension, or absorption in AIIMS Jammu on any post.
5. The appointee shall be on a whole-time appointment for the project concerned, shall not accept any other assignment paid or otherwise, and shall not engage himself/herself in private practice of any kind during the period of the contract.
6. No TA will be admissible for attending the interview and for joining the duties in case of selection.
7. Candidates employed in government or other funded research projects must provide a "No Objection Certificate" from their employer.
8. Leave entitlement of the appointee shall be governed as per ICMR guidelines.
9. If any declaration given or information furnished by him/her is found to be incorrect/ false or if he/she is found to have willfully suppressed any material or information, he/she will be liable for removal from service and also such other action as may be deemed necessary by the Competent Authority.
10. If any candidate is found canvassing for his/her selection, he/she will be disqualified from the selection process.
11. The competent authority's decision regarding the candidate selection will be final, and no representations in this regard will be entertained.
12. The final result will be declared on the website of AIIMS Jammu, and the selected candidate will be informed through email.
