AIIMS Mangalagiri is a healthcare Institute of National Importance, established by the Ministry of Health & Family Welfare, Government of India under the Pradhan Mantri Swasthya Suraksha Yojna (PMSSY). AIIMS Mangalagiri invites applications from the eligible candidates for the post of Senior Residents/Senior Demonstrators for a period of maximum 03 years for the following departments.

The aspiring applicants satisfying the eligibility criteria in all aspects can apply. *The applicant needs to fill & upload the application form through the below mentioned Google-form for the interview.*

I. Upper Age Limit: 45 years (*Closing date of applications*)

Age Relaxation:

- a. The age relaxation for SC/ST candidates is up to a maximum period of 05 (Five) years and for OBC candidate up to a maximum period of 03 (Three) years for the respective posts.
- b. In case of candidates with Bench mark disability (PwBD) - age relaxation is provided up to a maximum period of 10 years for General Category, 13 years for OBC category and 15 years for SC/ST category.

II. Pay Scale:

- a. **For Medical Candidates:** As per 7th CPC, Pay Level-11 of Pay Matrix with the entry pay of Rs. 67,700/- plus NPA and other Allowances
- b. **For Non-Medical Candidates (*M.Sc with Ph.D*):** Rs. 56,100 in Level-10 under 7th CPC plus Other Allowances.

III. Method of Selection: The selection will be on the basis of the interview only.

Note: *If no. of applied candidates is more, a screening test based on MCQs in the subject concerned will be conducted, followed by the interview for the shortlisted candidates.*

IV. Reservation criteria:

- **The reservation for OBC/EWS/SC/ST** candidate is as per Central Govt. rules and 4 % for PwBD candidates (on horizontal basis).
- **Applicants applying for the posts reserved for OBC** must obtain certificate of OBC (non-creamy layer) in the prescribed format issued by Competent Authority. OBC candidate must ensure that they have a valid OBC (non-creamy) layer certificate as on the cut-off date (**issued on or after 01st April 2026**). Applicants should ascertain that they belong to the reserved categories (caste) enlisted in the Central List for the Other Backward Classes. OBC candidate(s) should not belong to Creamy Layer and their sub-caste should match with the entries in Central List of OBC, failing which their candidatures will not be considered under any of the applied reserved category post(s).
- **Reservation for Economically Weaker Sections (EWSs)** shall be applicable as per Govt. of India, Office Memorandum No. 36039/1/2019-Estt (Res) DoPT dated 19th January, 2019 and 31st January, 2019. EWS candidate must ensure that they have a valid EWS certificate as on the cut-off date (**issued on or after 01st April 2026**). EWSs Candidates are required to attach certificate issued by the competent authority in the format prescribed as per guidelines of Govt. of India. In case suitable Economically Weaker Section (EWSs) candidates are not found, these posts will neither be carried forward nor considered as backlog vacancies. Therefore, Unreserved (UR) candidates are also provisionally allowed to apply against the posts reserved for EWS and they may be considered in case suitable EWSs candidate are not found to fill up these posts reserved for EWSs.
- **For SC, ST, OBC & EWS** – Certificate should be issued by Tahsildar or above rank authorities as prescribed by Govt. of India in the prescribed format of State/Central Government.
- **Person with benchmark disability (PwBD) candidate(s)** will be allowed in accordance with Ministry of Social Justice and Empowerment's, Notification No. 16- 15/2010-DD.III dated 29th July, 2013 as amended from time to time, in the above recruitment process. Further, only such persons would be eligible for reservation under PwBD quota in service/posts who suffer from not less than 40% of physical disability. Person who wants to avail the benefit of reservation would have to submit a Disability Certificate issued by a competent authority in prescribed format.

V. Application Procedure:

The duly filled and **signed original application form** must be produced at the time of interview along with One (1) set of Self Attested photocopies of Age proof, Mark sheets, Degree certificates, Registration certificates, Caste certificate, PwBD certificate (if applicable) etc. The same MUST be produced in original for verification at the time of interview.

- Annexure-I & II:** Filled in Hard copy of the Application and Proforma/ Check list are to be submitted during documents verification which shall take place before the interview.

- The link can also be copied and pasted on the address bar of any web browser for submission of application. Candidate has to fill Google Form, and need to submit their scanned copy of application forms in prescribed format along with necessary documents and transaction details only through above link provided.
- Executive Director, AIIMS, Mangalagiri reserves the right to cancel the advertisement at any point of time without assigning any reason there of or fill up less/more number of posts as advertised depending upon the Institutional requirement.
 - The candidates are required to produce all the Original certificates i.e., Internship Completion Certificate, MBBS degree certificate, Qualifying degree (MBBS/MD/MS/MDS/DNB/DM/M.Ch/MSc/PhD), Medical registration, Date of Birth Certificate/ 10th Standard Certificate, Caste Certificate, etc. at the time of Document verification.
 - Application Fee:**
General/EWS/OBC Category: Rs. **1500/-** and SC/ST category: Rs.**1000/-** to be paid through NEFT/UPI in the given bank account. The Application fee is non-refundable. No application fee is to be deposited for PwBD (Persons with Benchmark Disabilities) candidates.

- Candidates have to pay fees separately, if he/she is applying for more than one department as per the Essential Qualification of the post.**
- Applicants working in Central/State Government/Semi Government/ Autonomous Institution must submit a “**NO OBJECTION CERTIFICATE**” (NOC) from the employers at the time of interview clearly stating that the candidate will be permitted to join AIIMS Mangalagiri in the event of selection. The candidate will be allowed to appear for interview only on production of original NOC.
- One set of self attested photocopies** of all essential qualifications, Degrees, Age proof, Caste certificate etc. may be annexed to the hard copy of the application and the same shall be produced in **original** along with 1 photocopy for ‘Documents verification’ at the time of interview.
- The decision of Competent Authority, AIIMS Mangalagiri** shall be final and binding. The offer of appointment when made will be provisional and subject to verification of credentials (Educational & Personal) by competent authority.
- Based on the verification of original documents etc. the Screening Committee may short-list Candidates for interview.

VI. Terms & Conditions:

1. Age and other qualifications/Experience will be counted as on the Closing date of application (**crucial date**).
2. Only those candidates who have been declared successful in their qualifying degree examination and will be completing their tenure for the same on or before crucial date will be eligible.
3. The prescribed qualification is minimum and merely possessing the same does not entitle any candidate for selection.
4. Canvassing information of any kind will lead to disqualification; incomplete applications will not be considered and will be REJECTED. No interim correspondence shall be entertained.
5. The appointees shall be granted leave in accordance with the Institute rules/ instructions issued by the Government of India from time to time. Leave entitlement of the appointee shall be governed in terms of instructions contained in DoPT & T's O.M.No.12016/3/84/Estt.(L) dated the 12th April,1985 as amended by OM No.12016/1/ 96/Estt.(L) dated the 5th July, 1990.
6. Private practice of any type is strictly prohibited.
7. He / She may work in shifts and can be posted at any place in the Institute as per the discretion of the Medical Superintendent/Dean/Director.
8. He/ She is expected to abide by the rules of conduct and discipline as applicable to the Institute employees.
9. In case, any information given or declaration by the candidate is found to be false or if the candidate has willfully suppressed any information relevant to this appointment, he/she will be liable to be removed from the service and action will be taken as deemed fit by the Competent Authority.
10. The decision of the Competent Authority regarding selection of candidates will be final and no representation will be entertained in this regard.
11. The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
12. All disputes will be subject to jurisdictions of High Court, Andhra Pradesh.
13. **NOC certificate will not be given within one month of joining to the post and no experience certificate will be given for candidates resigning within 1 month after joining.**
14. Candidates working in Govt. / Semi-Govt., PSU should apply through proper channel only. The in-service candidates will not be permitted for examination / Interview, without "No Objection Certificate" from the employer. In this connection, it is mentioned that as per the terms and conditions of 'Residency Scheme', their engagement is to be regulated as per the CCS (Temporary Service Rules).
15. The appointment shall be as per Govt. of India's Residency Scheme. The appointment can be terminated at any time, on either side, by giving one month's notice or by paying one month's salary, without assigning any reason. The appointment can also be terminated for failure to complete the period of three months to the satisfaction of competent authority. The appointee shall be on the whole time appointment of the AIIMS for a period of 12 months at a time and continued up to 3 years based on the recommendation of HOD and discretion of Competent Authority. He/ She shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
16. **On selection, the candidates will be given 24 days' time to join the post at AIIMS, Mangalagiri. In exceptional situations (with reasonable justification), extension may be granted by the Competent Authority for a period of 07 days. No further extension will be permitted thereafter.**
17. *If the selected candidate does not join within the stipulated time as mentioned in the offer of appointment, the offer of appointment stands cancelled and the post will be offered to waitlisted candidate, if any. If there is no waitlisted candidate, the post is considered as vacant and will be advertised in the next cycle of the rolling advertisement.*

18. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
19. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
20. The candidate should not have been convicted by any Court of Law. In case any disciplinary proceedings are pending in the previous place/s of work, the candidate shall suitably inform in writing to AIIMS Mangalagiri at the time of verification of original documents.
21. There is no provision displaying marks/separate marks of written test (if applicable)/Interview and also for re-checking/re-evaluation. Please note that no query in this regard will be entertained.
22. Appointment of selected candidates is subject to his/her being declared medically fit by the competent Medical Board.
23. All information will be provided through the Institute website only. The Institute will not be responsible in any manner if a candidate fails to visit/access the website in time.
24. No travelling or other allowances will be paid to the candidate for attending the screening test/interview and joining the post.
25. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the Institute reserves the right to modify/withdraw/cancel any communication made to the candidate.
26. The applicant will be responsible for the authenticity of submitted information, other documents and photograph. Submission of any false and/or suppression /concealment of facts shall lead to rejection/cancellation of selection/recruitment.
27. *Candidates should keep in mind that their turn for interview might be delayed depending upon the number of applicants.*
28. All corrigendum/addendum shall be published on the Institute website.
