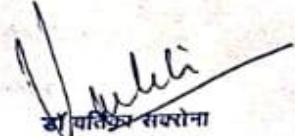

1. Candidates meeting the age criteria and possessing the required qualification, experience, etc. and willing to work for the above-mentioned projects may apply and fill the Application Form in the prescribed format only. There is no need to send hard-copy of any application form/documents at this stage.
2. Late and incomplete applications or applications not submitted in the prescribed format will not be considered.
3. The above position will be filled purely on temporary **CONTRACT** appointment basis.
4. The rates of emoluments/stipend shown in this advertisement are as per the guidelines and as per the sanction.
5. Cut-off date for age limit will be the date of Walk-In-Interview i.e. date of interview.
6. Age relaxation is admissible in respect of SC/ST/OBC/PWD candidates as per government rules.
7. Qualification & experience should be in relevant discipline/field and from an Institution of repute. Experience should have been gained after acquiring the minimum essential qualification.
8. Mere fulfilling the essential/educational qualification does not guarantee the selection.

14. Candidates who fail to bring the original certificates at the time of joining and if any discrepancy is found in the documents such candidates will not be allowed to join the selected contract post and the position will be offered to the waiting list candidates.

Contract can be terminated forthwith or before expiry of the notice period by making payment of a sum equivalent to one-month contractual amount.
