

GOVERNMENT OF ANDHRA PRADESH MEDICAL AND HEALTH SERVICES RECRUITMENT BOARD

- 1. Applications are invited from qualified persons online on APMSRB website (https://apmsrb.ap.gov.in/msrb) for the posts of Hospital Administrator (Managers) under the control of Director of Medical Education, A.P., Vijayawada.
 - (1.1) The online application will be available on the web portal (https://apmsrb.ap.gov.in/msrb/) from 00.01 AM on 17.11.2025.
 - (1.2) Last date for submission of ONLINE application is 11.59 PM on 30.11.2025.
 - (1.3) Applications submitted online only will be accepted.
- 2. Filling up of the posts of Hospital Administrator (Managers) under the control of Director of Medical Education, A.P., Vijayawada on Contract basis total posts in No. 08 (Eight Only).
 - (2.1) The number of vacancies is subject to variation on intimation being received from the department concerned. Addition or deletion of vacancies if any, can be done up to the declaration of result.
 - (2.2) The selected candidates are not eligible for private works.

3. Selection procedure

- (3.1) Applicants will be selected based on 100 points of which:
 - (3.1.1) Maximum of 65% will be awarded for percentage of marks obtained in qualifying exam.
 - (3.1.2) CGPA or Grade Points into percentage of marks the weightage for academic shall be calculated for the 75 points in terms of Govt., Circular Memo.No.01/HM&FW/2022, HM&FW Dept., Dated: 06.09.2022.

- (3.1.3) Maximum of 15 Marks will be awarded for Computer skills i.e., Computer Literacy and Proficiency with high level of familiarity with commonly used packages like MS Word, Excel, Power Point & Web surfing to search relevant data & Documents.
- (3.1.4) Interview: 20 Marks, Fluency in Telugu and English, Knowledge in Hospital Administration and good communication skills both in speech and writing etc., will be evaluated in interview.
- (3.1.5) In absence of Marks Memos of any of the above course, decision of the administration is final.
- (3.2) If more than one applicant scores same marks, then the person with higher age will be assigned better rank.
- 4. Merit list will be displayed on the APMSRB website.
- 5. Before applying for the posts online, applicants are requested to keep the soft copy (PDF) of the following documents ready for uploading:

Candidates migrated from Telangana shall submit certificate of Local candidature as per GO No 132 & 133 Dated: 13.06.2017. In absence of the suitable certificate, the candidate will be considered as Non-Local.

- Backward Classes Welfare (F) Dept., Dated: 10.11.2023 issued by the competent authority of Andhra Pradesh Government.

8. FEE:

(8.1) Application fee for OC - 1000/-

(8.2) For SC, ST, BC, EWS, Differently abled

and Ex-Servicemen - 750/-

(8.3) Applicants belonging to other states are treated as OC and are not exempted from payment of Fee concession.

9. Age:

(9.1) Upper age limit is 42 years.

(9.1.1) Shall not have completed 42 years as on 26.08.2025. Relaxations will be as follows:-

(9.1.2) For SC,ST,BC, EWS candidates : 05 (Five) years

(9.1.3) For Ex-Service Men : 03 (Three) years in addition to

the length of service in armed forces.

(9.1.4) For differently abled persons : 10 (Ten) years & Maximum age

limit is 50 years with all relaxations

put together.

10. Mode of Fee Payment:

(10.1) For payment of fee through the online through payment gateway i.e., Net Banking, Credit Card, Debit Card and Mobile wallet payment, an additional page of the application form will be displayed, wherein candidates may follow the instructions and fill in the requisite details to remit payment.

- (10.2) After submitting the payment information in the online application Form, please wait for the intimation from the server, DO NOT PRESS BACK OR REFRESH BUTTON, in order to avoid double charge.
- (10.3) If the online transaction has been successfully completed final registration number will be generated. Candidates should note the same for future reference.
- (10.4) Candidates should carefully fill in the details in the On-Line application at the appropriate places and click on the "SUBMIT" button at the end of the Online application format. Before presenting the "SUBMIT" button, candidates are advised to verify each and every particular

filled in their application. The name of the candidate or his/her father/husband's name etc., should be recorded correctly in the application as it appears in the certificates. Any change / alternation found may disqualify the candidature.

- (10.5) Candidates are advised in their own interest to apply on-line Fee much before the closing date and not to wait till the last date to avoid last minute internet connectivity issues.
- (10.6) APMSRB will not be responsible for delayed submission or remitting of payment.

11. PROCEDURE FOR APPLICATION:

- (11.1) Application has to be made online on APMSRB website (https://apmsrb.ap.gov.in/msrb) only.
- (11.2) Applicants should upload all required certificates (original certificates have to be uploaded for verification at the time of scrutiny before finalizing the selection list).
- (11.3) Applications once submitted online shall be final and no changes shall be permitted thereafter.
- (11.4) Upon submission of online form, Notification wise Application Number shall be generated. The same may be used for any future reference.
- (11.5) Applicant must compulsorily fill-up all relevant columns of the application form carefully. The applicant alone shall be responsible for information provided by them and decisions taken by APMSRB based on the same.
- (11.6) Incomplete / incorrect application form will be rejected. The information if any furnished by the applicant subsequently in any form will not be entertained by the APMSRB under any circumstances.
- (11.7) The applicant should not furnish any particulars that are false, tampered, fabricated, or suppress any material information while submitting online application. The applicant shall be liable for legal action in such cases.

12. RESERVATIONS: -

(12.1) The Rule of Reservation is applicable as issued by state government from time to time.

- (12.2) Horizontal reservations for women will be followed in this recruitment, in terms of G.O.Ms.No.77 General Administration (Ser.D) Department Dated:02.08.2023.
- (12.3) The Reservation for 'Meritorious Sports Persons' is applicable as per the amendments made to State and Subordinate Service Rules (G.O.Ms.No.77 General Administration (Ser.D) Department Dated: 02.08.2023 or as may be revised by the government from time to time. The proforma for obtaining sports certificates are given at Annexure III. Certificates which are not in the prescribed proforma will not be accepted.
- (12.4) Economically Weaker Sections: The EWS reservation is applicable as per G.O.Ms.No.24 General Administration (CABINET-II) Dept., Dt.23/02/2023 and G.O.Ms.No.77 General Administration (Ser.D) Department Dated:02.08.2023.
- (12.5) Reservation for benchmark disabilities:
 - (12.5.1) As per G.O.Ms.No.77 General Administration (Ser.D) Department Dated:02.08.2023, the posts notified herein are exempt from the following benchmark disabilities:
 - (i) Blindness and low vision
 - (ii) Deaf and hard of hearing
 - (iii) Autism, Intellectual Disability, Specific Learning
 Disability and Mental Illness
 - (iv) Multiple Disabilities
 - (12.5.2) Providing 4% reservation for persons with locomotor disability (a type of benchmark disability) is mandated by Section 34(1) of India's Rights of Persons with Disabilities Act, 2016, which requires appropriate governments to reserve not less than four percent of total vacancies in government establishments for persons with benchmark disabilities, including locomotor disabilities. This reservation applies to the total number of vacancies in a cadre, whether the posts are identified for people with disabilities or not.
 - (12.5.3) Physically Challenged applicants who are claiming reservations under disability quota must note that they will be referred to State Medical Board (Appellate Medical

- Authority) after completion of certificate verification. The report of the Medical Board is final.
- (12.5.4) Guidelines for evaluation of various disabilities and procedure for certification are mentioned in G.O.Ms.No.31, WD, CW & (DW) Dept, Dt:01- 12-2009.
- (12.6) In terms of G.O.Ms.No.77 General Administration (Ser.D) Department Dated:02.08.2023, Two percent 2% reservation shall be provided to Ex-Servicemen(Doctors) in direct recruitment. Out of two percent (2%), one percent of posts shall be given to women and if no women Ex-servicemen candidate is available, two percent (2%) of reservation shall be filled up with men. who served in armed forces on temporary basis.

13. COMMUNITY CERTIFICATE:

- (13.1) Applicants belonging to ST are required to produce Community Certificate issued by the competent authority of Government of Andhra Pradesh.
- (13.2) Applicants belonging to Schedule Classes are required to produce Community Certificate (SC-I, SC-II and SC-III) issued by the Competent Authority of Government of Andhra Pradesh Read Go.Ms.No.46, General Administration (Ser-D) Dept., Dated: 19.04.2005 and G.O. Ms No.7, Social Welfare (CV) Dept., Dated: 18.04.2025.
- (13.3) Applicants belonging to Backward Classes are required to produce Community Certificate (BC-A, BC-B, BC-C, BC-D & BC-E) issued by the Competent Authority of Government of Andhra Pradesh Read G.O. Ms.No.25 Backward Classes Welfare (F) Dept., Dated: 10.11.2023.
- (13.4) Applicants claiming Backward classes reservation should produce "latest Non- Creamy Layer" certificate issued by competent authority of Andhra Pradesh government. If applicants fail to upload 'Non-Creamy Layer' certificate, they will be treated as OC category.
- (13.5) Applicants belonging to Economically Weaker Section (EWS) for claiming EWS Reservation should produce "Income & Asset Certificate" issued by competent authority of Government of Andhra Pradesh for **current financial year**. Read G.O. Ms.No.24, General Administration (Cabinet-II) Dept., Dated: 23.02.2023.

- (13.6) Certificates issued by competent authorities of Government of Andhra Pradesh will only be considered.
- (13.7) Applicants belonging to states other than Andhra Pradesh are not entitled to any kind of reservation.

14. RESERVATION TO LOCAL CANDIDATES

(14.1) LOCAL CANDIDATURE

- Candidates who are Local to Andhra Pradesh are only eligible for the posts reserved for local category. (Candidates who studied from 4th Class to 10th Class in the State of Andhra Pradesh and candidates who migrated to any part of Andhra Pradesh from the State of Telangana within a period of 3 years from 2nd June 2014. (As per G.O.No.132 GAD Dt.13-6-2016 & G.O.Ms.No.133 GAD Dt.13.06.2016) are considered as Local).
- The Residence Certificate/Nativity/Domicile Certificate issued by MRO/ Tahsildar will not be allowed for Local consideration without mentioning the G.O.No.132 GAD Dt.13-6-2016 & G.O.Ms.No.133 GAD Dt.13.06.2016 for the candidate who studied in the state of Telangana before bifurcation.
- "Local Candidate" means a candidate for direct recruitment to any of the post in relation to those Local areas where he/she has studied in Educational Institution(s) for not less than four consecutive academic years prior to and including the year in which he/she appeared for SSC or its equivalent examination. If however, he/she has not studied in any educational Institution during the above four years period, it is enough if he/she has resided in that area which is claimed as his/her local area during the above said period.
- (14.2) Residence certificate will not be accepted, if a candidate who studied in any Educational institutions up to S.S.C. or equivalent examination, such candidates have to produce study certificates invariably.
- (14.3) Each of the following zones comprises the District mentioned against each Zone.

- **NOTE:** The candidates claiming reservation as Local candidates should enclose the required certificates issued by the concerned authorities. Subsequent production of the certificate will NOT be entertained under any circumstances.
- (14.4) Local reservation is only for providing Zonal representation. The candidates will be posted in any vacancy in the State as this is a State Cadre post.
- (14.5) Reservations to differently abled, are subject to their eligibility to the posts which shall be subject to special rules / adhoc rules governing the posts and in terms of G.O. Ms. No. 77, GAD (SER-D) Dept., Dated: 02-08-2023.
- (14.6) All are informed that the various conditions and criterion prescribed herein are Governed by the General rules of A.P. State and Subordinate Service Rules, 1996 read with the relevant specific rules applicable to any particular service in the Departments, any guidelines or clarification is based on the said rules, and in case of any necessity, any matter will be processed as per the relevant general and special rules, cited as in force.

15. GENERAL PROVISIONS

- (15.1) Required original certificates should be submitted at the time of verification of certificates or whenever called for. Failure to produce the required certificates will lead to disqualification.
- (15.2) **Important:** The claim of the applicants with regard to the date of birth, educational qualifications and community etc., are accepted provisionally on the basis of information furnished by them in their application form and is subject to verification and satisfaction of the APMSRB. Mere inclusion of the name of an applicant in a Merit List will not confer on the applicant any right for appointment. The candidature is therefore, provisional at all stages and the APMSRB reserves the right to reject candidature at any stage of the selection even after declaration of results, if any mistake is noticed at a later date.
- **16.** Printout of downloaded application form as well as original certificates /documents as mentioned at Para (5) have to be submitted at the time of certificate verification.

17. DISQUALIFICATION FOR APPOINTMENT:

Any applicant can be disqualified at any stage as perRule-12(4) of Andhra Pradesh State and Subordinate Service Rules.

18. DEBARMENT:

- (18.1) All desirous and eligible candidates shall apply online after satisfying themselves that they are eligible as per the terms and conditions of this recruitment notification. Any application sent through any mode other than the prescribed online mode will not be entertained under any circumstances. Submission of the application form by the candidate is an authentication that he/she has read the notification and shall abide by the terms and conditions laid down there under.
- (18.2) Applicants should make sure of their eligibility to the posts applied for and that the declaration made by them in the application form regarding their eligibility is correct in all respects. Any applicant furnishing incorrect information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable to be debarred from appearing for any of the examinations conducted by the APMSRB, and for summary rejection of candidature for this recruitment.
- (18.3) The Board is vested with the duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process. Any attempt by anyone causing or likely to cause breach of this duty or by any action which violates or is likely to violate fair practices followed and ensured by the Board will be sufficient cause for rendering such action as ground for debarment and penal consequences as per law and rules shall be involved as may be decided by the APMSRB.
- (18.4) If any applicant is or has been found impersonating or resorting to any other irregular or improper means in connection with his / her candidature for selection or obtaining support of candidature by any means, such an applicant may in addition to rendering himself/ herself liable to criminal prosecution, will be debarred permanently from any exam or selection.
- (18.5) If an applicant himself/herself or through relations or friends or any others has canvassed or endeavored to enlist for his/her candidature, whether from official or non-official sources, for appointment to any State Service or Subordinate Service shall be disqualified.

- Candidates, who claim for VH/MH/HH/OH vacancy, must submit Disability Certificate to that extent, issued by the concerned Medical board or SADAREM.
- Social status Certificate in case of SC (Latest Sub Caste classification Scheduled Castes into three Groups Certificate) / ST /BC (Latest Sub Classification Certificate) OBC certificate not accepted / EWS (Latest 2025-26 Certificate) issued by the competent authority. If social status certificate is NOT submitted, then such candidate is treated as OC.
- Certificate of at least 3 years of Post qualification experience working in private or Government Hospitals out of which.
- 2 years of work experience in Managerial roles in Hospitals or the Specialization in Health Care Quality.

NOTE:

The applications submitted without the required certificates and incomplete applications will be rejected summarily.
