They will have to carry the same ID card in original along with the admit card to the examination centre. **Candidates failing to carry their ADMIT CARD will not be allowed to appear in the examination.** The particulars of candidate such as name, father's name etc., indicated in Photo Identity Documents of candidates should match with admit card of the candidate issued by the Board.

The candidate shall clearly indicate **their preference of posts as well as Department/Office while filling through online application.** **Candidates will be allowed to mark their preference only against the vacancies for which they are eligible as per the details provided in the application form and the eligibility criteria mentioned in this advertisement.** Applicants are advised to carefully think and indicate their order of preference. - An 'Ex-Serviceman (Ex-SM)' means a person who has served in any rank whether as a combatant or non-combatant in the Regular Army, Navy and Air Force of the Indian Union.

NOTE:

4.1. As per the NOTIFICATION vide No.HOME-11011 (13)/57/2025/9941, Dated 05th September 2025, ONE- TIME RELAXATION of the Upper Age Limit as one time measure will be granted to those candidates who had appeared in the written examination dated 13/07/2025 vide Advertisement No.09/2020 for the post codes 65/20 [Constable (GD) Civil Police Male], 66/20 [Constable (GD) Civil Police Female] & 67/20 [Constable IRBn (Band/ Bugler)] conducted by the Arunachal Pradesh Staff Selection Board in respect of Constable (Civil Police, Arunachal Armed Police Battalion, Indian Reserved Battalion) to enable them to appear for the vacancies for the posts of Constables in the said examination.

4.2. A separate annexure with the name of the candidates those had appeared in the written examination dated 13/07/2025 will be uploaded in the website in due course.

4.3. Accordingly, the ONE TIME AGE RELAXATION is restricted to Post Code 5/26 [Constable Band (IRBn)], 6/26 [Constable Bugler (IRBn)], 8/26 [Constable Civil Police (Female)] and 9/26 [Constable Civil Police (Male)] of the instant advertisement. The relaxation will not be applicable for Post Code 7/26, 10/26 and 11/26.

5. ELIGIBILITY CRITERIA:-

- The candidate must be a citizen of India.
- The educational qualification, age, experience as stipulated in the advertisement shall be determined as on the closing date of submission of application i.e., on dated **10.04.2026**.

6. SCHEME OF EXAMINATION:-

The scheme of examination will consist of 3 stages (Stage-I, Stage-II & Stage-III) for Post Code-5/26 to 10/26 and Stage-I & Stage-II for Post Code- 11/26.

6.1. Stage- I: Objective Type Multiple Choice Questions

6.2. Syllabus:

Constable Band (IRBn) (5/26), Constable Bugler (IRBn) (6/26), Constable IRBn (7/26), Constable Civil Police (Female) (8/26), Constable Civil Police (Male) (9/26), Fireman (10/26) & Special Tiger Guard (STPF) (11/26),

(a) General Awareness – 50 marks (25 questions of 2 marks each)

Syllabus: - Questions will be designed to test the ability of the candidate's General Awareness of the environment around him/her and its application to society. The questions will be designed to test knowledge of Current Events and of such matter of everyday observation as may be expected of an educated person. The test will also include questions relating to History, Polity, Constitution, Sports, Art & Culture, Geography, Economics, Everyday Science, Scientific Research, National/International Organizations /Institutions, etc. State Specific questions may also be asked.

(b) General Intelligence & Reasoning Ability - 50 marks (25 questions of 2 marks each)

Syllabus: -The syllabus of General Intelligence & Reasoning Ability includes questions of both verbal and non-verbal types. Test may include questions on analogies, similarities, differences, space visualization, problem solving, analysis, judgment, decision making, visual memory, discrimination, observation, relationship concepts, arithmetical reasoning, verbal and figure classification, arithmetical number series, etc. The test will also include questions designed to test the candidate's abilities to deal with abstract ideas and symbols and their relationship, arithmetical computation and other analytical functions.

(c) Arithmetical & Numerical Ability – 50 marks (25 questions of 2 marks each)

Syllabus: - The test of Arithmetical and Numerical Abilities will cover Number Systems including questions on Simplification, Decimals, Data Interpretation, Fractions, L.C.M, H.C.F, Ratio & Proportion, Percentage, Average, Profit & Loss, Discount, Simple & Compound Interest, Mensuration, Time & Work, Time & Distance, Tables & Graphs.

(d) Test of English Language and Comprehension – 50 marks (25 questions of 2 marks each)

Syllabus: - Questions in this component will be designed to test the candidate's understanding and knowledge of English Language and will be based on spot the error, fill in the blanks, synonyms, antonyms, spelling/ detecting misspelled words, idioms & phrases, one word substitution, improvement of sentences, active/ passive voice of verbs, conversion into direct/ indirect narration, shuffling of sentence parts, shuffling of sentences in a passage, cloze passage & comprehension passage.

NOTE:

- 6.2.1. A candidate must secure a minimum of 33% or more marks in aggregate in the written examination paper. Candidates securing less than 33% of marks in aggregate shall be deemed not eligible for selection. There is no negative marking.**



6.3. Stage-II: Physical Standard Test (PST), Physical Efficiency Test (PET) and Trade Test

- i. The candidates for all **post codes 5/26 to 11/26** will have to qualify PST and PET as mentioned against each post code of this advertisement.
- ii. The candidates for post code 5/26 & 6/26 will have to qualify Trade Test
- iii. **The total number of candidates shortlisted for stage-II (PST, PET & Trade Test) will be in 1:3 ratio subject to the candidates securing a minimum of 33% marks in aggregate in the written examination paper.**
- iv. The Ex-Servicemen candidates are exempted from appearing the Physical Efficiency Test (PET) and Trade Test. However, they will have to appear and qualify the Physical Standard Test (PST).

6.4. Stage-III: Medical Fitness Test

- i. The candidates for **post codes 5/26 to 10/26** will also have to qualify the medical fitness test as mentioned against each post code of this advertisement.

NOTE:

6.4.1. Stage-II (PST, PET & Trade Test) and Stage-III (Medical Fitness Test) shall be qualifying in nature only.

6.4.2. The final merit shall be prepared on the basis of merit-cum-preference in objective type written examination only.

6.4.3. Other details, if any, will be informed through the official website.

- The shortlisted candidates will be required to submit legible self-attested copies of the documents and Admit Card at the time of verification of documents *(any information contained in the attached certificates shall not be considered unless it is claimed in the application form)*.
 - Shortlisted candidates will have to upload copies of the above-mentioned documents on the APSSB portal when notified to do so. - 8.1. There is no provision for re-evaluation /re-checking of Answer Sheet /Answer Scripts in respect of the examinations conducted by APSSB.
- 8.2. The APSSB reserves the right to cancel/withdraw any question/questions from the Test.
- 8.3. The Board makes the provisional selection of the candidates on the basis of information provided in the application and documents/certificates provided by the candidate at the time of submission of documents and recommends the same to the indenting/ user department. Further, the Appointing Authority i.e., the indenting/user department verifies and satisfies itself about the authenticity of documents/certificates and eligibility as per the Recruitment Rules before finally appointing the candidate(s). Therefore, the provisional selection of a candidate does not confer upon him/her any right of appointment unless the Appointing Authority is satisfied, after such inquiry as may be considered necessary, that the candidate is suitable in all respects for appointment to the post.

9. CENTRES OF EXAMINATION:-

i. A candidate must give option for 03 (three) centres, in the order of priority, from the under mentioned list of centres. No request for change of centre will be considered later under any circumstances. Hence, the candidates should select the centres carefully, and indicate the same correctly in their applications:

ii. The Board will endeavour to accommodate the candidates in centres opted by them. However, the Board reserves the right to cancel any Centre and ask the candidates of that centre to appear from another centre. Board also reserves the right to divert candidates of any centre to some other centre to take the examination without citing any reasons.

10. GENERAL INSTRUCTIONS FOR CANDIDATES: -

i. The vacancies published are provisional and subject to change. The Board reserves the right to increase or decrease the vacancies for any post in any category due to administrative reasons or in public interest. In case the vacancy position is reduced to any number or even withdrawn by the user department, the Board shall not be liable to compensate the applicant for any consequential damage/loss.

ii. The Board reserves the right to reject the candidature of any candidate at any stage of recruitment.

iii. The Board reserves the right to cancel a part or entire process of examination or a part of it due to administrative reason(s) and in case of unfair means, cheating or other irregularities / malpractice noticed by the Board. The Board also reserves the right to cancel or set up a new examination centre and divert the candidates to appear at that examination centre, if required. **No request for change in date, time and centre of exam will be accepted under any circumstances.**

iv. The Board reserves the right to change or make amendment in the examination scheme at any time before the examination, if so required.



v. The candidature of the candidate to the written examination is provisional and subject to the outcome of any direction/decision/order/pronouncement of any Court of Law and mere issue of Admit Card or appearance at the examination does not entitle him/her to any claim for the post.

vi. **No request or representations will be entertained for issuance of admit cards after closing date for download of admit cards.**

vii. The applicants are advised to fill up the application form carefully. They will not be allowed to edit/modify the details after the closing date. Application with incomplete or invalid details will be summarily rejected.

viii. In case an applicant applies multiple forms for the same post, only the latest application form shall be considered by APSSB.

ix. Abbreviations used are denoted as under: APST - Arunachal Pradesh Scheduled Tribe, UR – Unreserved, Ex-SM - Ex-Servicemen, IRBn- Indian Reserved Battalion, STPF – Special Tiger Protection Force.

x. Use of Calculator, Laptop, Palmtop, other digital instrument/Mobile/Cell Phone/Pager/ Watches etc is/are not allowed. In case any candidate is caught / found in possession of any gadget/instrument, he/she would be debarred from the examination and legal proceedings shall also be initiated against the candidate.

xi. Candidates are advised not to bring any of the above gadgets in the exam centre as no arrangements for keeping/security of these items would be available at the centre.

xii. If any candidate uses offensive/abusive/foul language/obscene picture, he/she will be liable for necessary penal action under relevant provision of law.

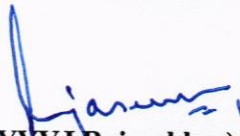
xiii. All candidates have to download their respective ADMIT CARD from the website **www.apssb.nic.in**. No individual ADMIT CARD will be sent to any candidates.
