5. RULES OF RESERVATION

Rule of Reservation will be followed as per the A.P State and Subordinate Service Rules, 1996, read with the relevant Specific Rules applicable as per Presidential order.

6. HOW TO APPLY

12.	The persons seeking the benefit of reservations under EWS category shall obtain the necessary EWS certificate issued by the Tahsildar concerned and enclose along with application form. (as per G.O.Ms.No.73, GA(Ser-D) Dept., Dt.04.08.2021.) (for all posts if applicable)

NOTE: 1. Application which are not having up to date renewals of respective Council/Board will be summarily rejected

2. If attested copies of Caste certificate/Physically handicapped certificate/ Ex-Servicemen certificate not enclosed, the candidate will be treated under Open Category.

3. If Certificate copy of study certificates i.e., IV to SSC is not enclosed, the candidate will be treated as Non-Local.

4. If attested copies above are not enclosed, the application will be summarily rejected.

7. Conditions on Appointment:

The candidate selected and appointed on contract basis shall not be regarded as a member of the service in which the post to which he/she is appointed, is included, and shall not be entitled by reason only of such appointment, to any preferential right to any other appointment in that or any other service. The department or the person may revoke the contractual appointment or discontinue the contract by giving one month's notice in writing on either side. This contract would automatically cease to operate on lapse of contract period and both parties will be discharged of their respective obligations and liabilities without any formal or informal communication.

8. Fee:-

Applicant must enclose a demand draft of Rs. 100/- (Rupees One Hundred Only) in favour of "The District Coordinator of Hospital Services, East Godavari, Rajamahendravaram" payable at Rajamahendravaram towards application processing fee. If candidate is eligible for more than one post is required to enclose demand draft for each post and apply for each post separately.

9. DEBARMENT

1. Candidates should make sure of their eligibility to the post applied for and that the declaration made by them in the format of application regarding their eligibility in all respects. Any candidate furnishing incorrect information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable to be debarred from recruitment conducted by the department and summarily rejection of their candidature for this recruitment and future recruitments.
2. The department is vested with conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by any one causing or likely to cause breach of this duty in such manner or by such action as to violate or likely to violate the fair practices followed and ensured by the Department will be sufficient cause for rendering such questionable means as ground for debarment.

10. DEPARTMENT'S DECISION IS FINAL

The decision of the department/Dist. Selection Committee pertaining to the application and its acceptance or rejection as the case may be, and conduct of counselling and at all consequent stages culminating in the selection or otherwise of any candidate shall be final in all respects and binding on all concerned under the powers vested with it. The department/DSC also reserves its right and modify regarding terms and conditions laid down in the notification for conducting the various stages up to selection duly intimating details thereof to all concerned as warranted by any unforeseen circumstances arising during the course of this process.
