### ADVERTISEMENT

The Arunachal Pradesh Public Service Commission invites online application from Citizens of India for filling up of 08 (eight) posts of Inspector (Legal Metrology & Consumer Affairs), under the Department of Legal Metrology & Consumer Affairs, Govt. of Arunachal Pradesh in the Pay Matrix Level- 6 (Rs.35,400 – Rs. 1,12,400) ,Group-B (Gazetted) Non-Ministerial.

## (A) HOW TO APPLY

- Before filling the Online Application Form for the post advertised, a candidate must mandatorily register for <u>ONE TIME REGISTRATION (OTR)</u>.
- (2) Those who have already registered in OTR need not register again and they can directly login to fill up online form using the same user ID and password.
- (3) Candidates are required to apply online on <a href="https://appsc.gov.in">https://appsc.gov.in</a>. Detailed instructions for One Time Registration (OTR) and Online Application are available on the APPSC website (<a href="https://appsc.gov.in">https://appsc.gov.in</a>). The applicants are advised to submit only single application, however, if due to any unavoidable situation, he/she submits another/multiple applications, the application with the highest Registration ID (RID) will be accepted by the Commission. Therefore, the highest RID application should be complete in all respects. The fee paid against one RID shall not be adjusted against any other RID.
- (4) Applicants in Government Service should also apply directly on the APPSC website. Such applicants have to upload a copy of intimation submitted to their respective Heads of Department or NOC issued by the department.

NOTE: The online application submission link shall be active from 1100 hours on 25.07.2024 till last date of submission i.e. before 1700 hours on 23.08.2024 on the APPSC website.

## (B) EDUCATIONAL QUALIFICATION

Bachelor's Degree in Engineering/Technology in Mechanical/Electrical/Civil/Electronics & Communication Engineering or B.Sc. with Physics from a recognized University.

Candidates who have appeared in the Final Year Examination of the Qualifying Degree are also eligible to apply. However, their candidature will finally be accepted on production of proof of having passed the qualifying examination in original on or before the date of interview so fixed by the Commission failing which they will not be allowed to appear in the Interview/Viva Voce.

#### (C) AGE LIMIT

Not exceeding 35 years of age as on 23.08.2024. However, the upper age limit is relaxable in accordance with the orders issued by the Government of Arunachal Pradesh from time to time.

#### (E) SCANNED DOCUMENTS AND INFORMATION TO BE UPLOADED

- (1) Signature of the candidate on white paper with black ink pen(40-50 kb in jpg format).
- (2) Latest/Recent color passport size photo (40-100 kb in jpg format). The photograph is to be in white background, front faced and without headgear and sunglasses.
- (3) Self-Attested photocopy of Bachelor Degree certificates and Mark Sheets issued by the Registrar/Assistant Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain degree.
- (4) Self-Attested photocopy of Matriculation Certificate for proof of age issued by the Board only will be accepted.



(5) Self-Attested Photocopy of APST certificate for APST candidates and Aadhar Card/PRC/EPIC for other applicants.

## (F) APPLICATION FEE

- Candidates are required to pay fee of ₹150/- (Rupees One Hundred Fifty) only for APST candidate and ₹200/- (Rupees Two Hundred) only for other Applicants.
- (2) PwD candidates are exempted from payment of application fee as per Section 19 of the Arunachal Pradesh Rights of Persons with Disabilities Rules, 2018.

## (G) LAST DATE FOR SUBMISSION OF APPLICATION: 21/08/2024 (1700 Hours)

### (H) INTERVIEW/VIVA-VOCE:

Eligible candidates will have to produce the above-mentioned (at Point E) Certificates/Documents and Mark Sheets in **original** at the time of interview, failing which he/she will not be allowed to appear in the interview.

#### NOTE:

- In case the number of applicants is more than the desired ratio, the Commission may conduct a Recruitment Test to shortlist the candidates which will be notified to the candidates separately.
- (2) Recruitment Test, if conducted shall be Subjective/Objective type examination on concerned subject.
- (3) The decision of the Commission as to the eligibility or otherwise of candidate for admission to Recruitment Test/Written Exam/Interview/Selection will be final and no correspondence or personal enquiry will be entertained.
- (4) Date for the Recruitment Test, Written Exam & Interview of the eligible candidates will be notified separately.
- (5) The selection will be provisional subject to verification of requisite documents/ qualifications by the indenting department.
- (6) In case of PwD candidates, the selection process will be as per the Rights of Persons with Disabilities Act, 2016 and Arunachal Pradesh Rights of Persons with Disabilities Rules, 2018 as amended from time to time.
