The Arunachal Pradesh Public Service Commission invites application for filling up of **22 (Twenty Two)** posts of Section Officer through Limited Departmental Competitive Examination (LDCE) from the Grade of Assistant Section Officer (ASO), Arunachal Pradesh Civil Secretariat for filling up of following posts of Section Officer Group-B (Gazetted) in the Pay Matrix in Level-8 (₹47,600/- to 1,51,100/-) as admissible under rule.

The post wise vacancy detail is tabulated below:

(A) ELIGIBILITY

- A. Bachelor Degree/ Graduation in any subject from recognized University.
- B. Minimum 05 years of regular service in the grade of ASO.
- C. Possessing at least 5 (five) "Very Good" consecutive APAR grading for the last 05 years.

(B) HOW TO APPLY

- (1) Application Form is available for download in the APPSC website <https://appsc.gov.in>. The duly filled-in application form must be recommended by the Cadre Controlling Authority along with details of the APAR grading of last five consecutive years.
- (2) Only applications nominated by the Cadre Controlling Authority with at-least **five** 'Very Good' consecutive APAR grading of last 5 (five) years shall be considered.
- (3) The duly filled-in application forms nominated by the Cadre Controlling Authority must also enclose the documents listed herein at (E).
- (4) All such duly nominated applications must be submitted in the office of APPSC on or before **30th October, 2025 (Thursday) by 3:00 pm** through Cadre Controlling Authority.

(C) METHOD OF SELECTION

The eligible candidate will have to appear in written examination in the following subjects followed by Viva-Voce to be conducted by the Arunachal Pradesh Public Service Commission.

Note: In order to qualify for interview, candidates must score an aggregate of 33% of the total marks in the written examination comprising of three papers, subject to condition that the candidate scores at least 20% in each Subject/ Paper of the written examination.

In case the number of applicants is more than the desired ratio, the Commission may conduct a Recruitment Test, the details of which will be notified separately.

(D) Candidates are required to pay fee of ₹150/- (Rupees One Hundred Fifty) only for APST candidate and ₹ 200/- (Rupees Two Hundred) only for other candidate in form of Treasury challan payable to Secretary, APPSC, Itanagar under Head of Account - 0051, 102 - State PSC.

(E) DOCUMENTS REQUIRED TO BE SUBMITTED ALONG WITH THE APPLICATION FORM

1. Latest/Recent color passport size photo. The photograph is to be in white background, front faced and without headgear and sunglasses.
2. Self-Attested photocopy of Degree certificates and Mark Sheets issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain degree.
3. Self-Attested photocopy of Matriculation Certificate for proof of age issued by the Board.
4. Self-Attested Photocopy of APST certificate and copy of PRC/Aadhar Card in case of General candidates.
5. Self- Attested photocopy of appointment order to the post.
6. Treasury challan of amount deposited as fee.

(F) LAST DATE FOR SUBMISSION OF APPLICATION: 30th October, 2025 (Thursday)

NOTE:

- (1) The decision of the Commission as to the eligibility or otherwise of candidate for admission to written examination/interview or selection will be final and no correspondence or personal enquiry will be entertained.
- (2) Date for Written Examination is scheduled on **28th November 2025 (Friday)**. Date of Interview of eligible candidates shall be intimated separately.
- (3) Eligible candidates will have to produce the above-mentioned (at Point E) Certificates/Documents and Mark Sheets in original at the time of interview, failing which he/she will not be allowed to appear in the interview.
- (4) The Selection will be provisional and subject to verification of requisite documents/ qualifications by the indenting department.
