**2. ESSENTIAL EDUCATIONAL QUALIFICATION:**

**Deputy Engineer (Electronics):** Candidates should have completed B.E / B.Tech / AMIE / GIETE / B.Sc Engineering (4 year course) in Electronics / Electronics & Communication / Electronics & Telecommunications / Communication/ Telecommunication from a recognised Institute/University. General / OBC / EWS candidates should have secured first class and SC / ST / PwBD candidates should have secured pass class.

**Deputy Engineer (Mechanical):** Candidates should have completed B.E / B. Tech / AMIE / GIETE / B.Sc Engineering (4 year course) in Mechanical from a recognised Institute/University. General / OBC / EWS candidates should have secured first class and SC / ST / PwBD candidates should have secured pass class.

Candidates having essential educational qualification with other disciplines will not be considered.

In case there is no mention of specialization in the qualifying degree as required in the essential educational qualification, candidates are required to submit a certificate from their University/Institute with a clear mention to their specialization in the qualifying degree.

**3. TERMS OF ENGAGEMENT:**

The selected candidates will be engaged initially for a period of Five years which may



be extended up to Two years (Maximum tenure of 7 years) based on requirement and individual performance.

#### 5. REMUNERATION

The selected candidates will be inducted in the Pay Scale of Rs. 40,000-3%-1,40,000.

**Method of selection:** Selection will be through Computer based test and interview. The assessment weightage will be 85% and 15% for Computer based test and interview respectively.



Candidates who meet the eligibility criteria and whose online applications have been accepted will be provisionally shortlisted for Computer based test. The eligible candidates will be required to appear for Computer based test for 85 marks consisting of:

**Part I: General Awareness:** 15 Marks – comprises 15 questions of general mental ability and aptitude to logical reasoning, analytical, comprehension ability, basic numeracy, data interpretation skills and general knowledge

**Part II: Technical / Trade Aptitude:** 70 marks – comprises of 70 questions Technical/Professional knowledge Test having specific questions from respective degree.

#### Minimum qualifying marks in Computer based test:

Obtaining minimum qualifying marks in the Computer based test does not confer any right or claim by the candidate for being shortlisted for the interview, as the same is related to number of positions, reservation position, marks scored and subject to meeting the eligibility criteria.

Candidates passing the Computer based test will be shortlisted for Personal Interview based on the performance in the Computer based test in the ratio of 1:5. #### 7. HOW TO APPLY:

- Candidates who meet the above requirement may fill in the application form using online link provided in BEL Website ([www.bel-india.in](http://www.bel-india.in)). Online link will be open to apply from 07.03.2025.
- Before applying for the post, the candidates should ensure he/she fulfills the eligibility criteria mentioned in the advertisement. No manual / paper application will be entertained. No hard copy application will be accepted.

#### GENERAL INSTRUCTIONS:

Candidates who meet the eligibility criteria and whose online applications have been accepted will be provisionally shortlisted for the Computer based test. However, the candidature of the applicant will be provisional and subject to verification of Certificates/Testimonials submitted by him/her.
