OTHER ALLOWANCES:

Selected candidate will be inducted in the pay scale as indicated as above in the table. In addition to Basic Pay of Rs. 40,000/-, other allowances like Dearness Allowance, House Rent Allowance, 35% of the Annual Basic Pay as Perquisites, Performance Related Pay (PRP), Group Life Insurance, Medical reimbursement, Provident Fund, NPS, Gratuity etc. as per the Company's rules, will be part of the remuneration package.

AGE CRITERIA:

The upper age limit indicated above in the table is for candidates belonging to UR category. For candidates belonging to PwBD category having minimum 40% disability or more will get 10 years relaxation on the age limit mentioned above. For the Ex-Servicemen relaxation in age will be as per Government guidelines.

In case of non-availability of the date of birth in the Matriculation / Higher Secondary school certificate, Birth certificate issued by Competent Authority will be considered.

Where reservation is not available for specific category, candidates may apply under General category provided they meet the minimum eligibility criteria specified for General Category as on 01.07.2026.

Qualification:

Full time Bachelor's Degree in Law (LLB / BL) from recognized Indian University. General candidates should secure First class and PwBD candidates should secure pass class in Bachelor's Degree in Law (LLB / BL).

Please Note:

- a. Candidates whose discipline / specialisation mentioned in their relevant Degree Certificates do not tally with the discipline / specialisation prescribed in the advertisement will not be considered for selection.
- b. In case of CGPA or credits system of assessments, the candidates are required to attach the formula for conversion of CGPA / Credits to percentage in accordance with the respective University norms.

METHOD OF SELECTION:

The candidates meeting the eligibility criteria mentioned in the advertisement will be shortlisted for the Written Test and those who qualify in the Written Test will be provisionally shortlisted for Interview in the ratio of 1:5.

The minimum qualifying mark is 35% for General candidates and 30% for PwBD candidates in both Written Test and Interview separately.

Selection will be based on the performance of the candidate in both the Written Test and Interview. The weightage for Written Test is 85 marks and Interview is 15 marks.

The venue of the written test is Bengaluru only. The exact date and time will be communicated to the e-Mail Id furnished by the candidate.

HOW TO APPLY:

- a) Candidates who meet the above mentioned criteria are required to download the Application Form provided in the website with this advertisement.
- b) The duly filled in application along with the self-attested photocopies of the below mentioned documents / enclosures are to be sent through post:
 - SSLC / SSC / 10th Standard marks card (as proof of Date of Birth).
 - LL.B / B.L Degree certificate (as applicable). In case of CGPA / OGPA / Grade-point, the candidates are required to indicate the formula for conversion of CGPA / Credits to percentage in accordance with the respective University norms.
 - Final consolidated marks sheet & Degree Certificate (In case the final degree certificate is yet to be awarded, the candidate is required to mandatorily submit the final year mark sheet. If available, the Provisional degree certificate to be submitted).

- Caste / Tribe Disability certificate in case of candidates belonging to SC / ST / PwBD are required to submit the certificate in the prescribed format.
- Physical copy of payment receipt of SBI Collect (online mode / through SBI Branch).
- Identity Proof (Aadhar Card/Driving License/Voter ID/Passport / PAN Card).
- Additional Certificates, if any.

- Candidates are requested to read the details and screenshots for making the payment.

- Candidates have to enter the “SBI Collect Reference No.” generated after payment in the Application Form.
- Candidates may go through all instructions and eligibility criteria carefully before remitting Application Fee and submitting the application.

be considered under general standard of merit and no relaxations (except payment of application fee for SC / ST / PwBD candidates) shall be available for the candidates.

8. The Caste / Tribe / Disability Certificate should be strictly in the format available on the BEL website failing which, candidates will be considered under “UR” category, provided they are otherwise meeting all other criteria stipulated for General candidates.
9. Request for change of mailing address / E-mail Id / Category / Degree as declared in the application form will not be entertained.
10. **Travelling Allowance (TA) at Interview stage:** Outstation candidates will be reimbursed to & fro rail fare by shortest route either from the correspondence address or from actual place of departure whichever is less, on production of tickets / supporting documentary proofs in respect of onward journey.
