**Upper Age Limit:** Upper age limit is 32years as on 01.05.2022.

**Relaxations:**The upper age limit will be relaxable for ST candidates by 5 years. For candidates belonging to PwBD category having minimum 40% disability or more will get 10 years' relaxation in addition to the relaxation applicable to the categories mentioned above.

**Terms of Engagement & Remuneration:**

**Project Engineer-I** will be engaged initially for a period of Three years which may be extended upto a maximum of Onemore year (total Maximum tenure of 4 years)based on project requirement and individual performance. Candidates will be paid a consolidated remuneration of Rs. 40,000/-, Rs. 45,000/- Rs. 50,000/- and Rs. 55,000/-during the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> year of contract respectively.

However, if any candidate has completed three years of tenure as a Trainee Engineer in BEL and has applied for Project Engineer post he/she will be directly inducted as Project Engineer–II. The remuneration of such candidates will be Rs.45.000/- for the 1<sup>st</sup> year, Rs. 50,000/- for 2<sup>nd</sup> year and Rs.55,000/- for the 3<sup>rd</sup> year. The overall tenure will be limited to 3 years only.

**Qualification:** Full time BE/B.Tech course from reputed Institute/University in the following Engineering disciplines –Electronics/Electronics & Communication/ E&T/ Telecommunication.

Minimum Percentage of Marks in BE/B.Tech:

**Post Qualification Experience as on 01.05.2022** :Candidates should possess minimum two years' relevant industry experience.

The relevant post qualification industry experience shall be in the following areas:

**Electronics:** Candidates preferred having experience in Surveillance/Information Technology/Network Projects. Preference is given to candidates having relevant certificates in the above mentioned areas.

**Please Note:**

- i. Candidates possessing Industrial experience only need to apply.
- ii. Academy/Teaching/Research work experience will not be considered as relevant industrial experience.
- iii. Candidate should possess Experience certificates/Documents issued by the previous and present employer clearly indicating period of employment and post held.
- iv. The decision of the Selection Committee with respect to industrial experience will be final. Work experience indicated without supporting documents will not be considered and is liable to be rejected/cancelled without any prior intimation.

**SELECTION PROCEDURE:**

- Selection will be through a Written Test for shortlisted candidates, followed by an Interview, only for those candidates who qualify in the Written Test. **The venue for the Written Test / Interview will be intimated later.**
- 85% Marks will be allotted for the written test and 15% have for the interview. Candidates who pass the written test will be called for interview in the ratio of 1:5 in the order of merit.
- The names of candidates shortlisted for Written Test/Interviews and final selections will be notified on our Company's website.
- Please note that Written Test/Interview call letters will be sent through email only.

**HOW TO APPLY:** Interested candidates meeting all the criteria mentioned above, should submit the application in the form appended to this advertisement and send the applications through post, **super scribing on the envelope the post applied for.**

**Candidates are required to enter all information correctly in the application form as changes shall not be permitted after forwardal of the application form.**

**Documents to be submitted at the time of submitting the application:**

- ii. B.E/ B.Tech. Degree certificate (as applicable). In case of CGPA or credits system of assessments, the candidates are required to indicate the formula for conversion of CGPA/ Credits to percentage in accordance with the respective University norms.
- iii. Final consolidated marks sheet.
- iv. Caste / Community/ Disability certificate in case of candidates belonging to ST/EWS/PwBD respectively. Candidates claiming reservation under any of the above categories are required to submit the certificate in the prescribed format.
