**1. REQUIREMENT OF PROJECT ENGINEER - I & TRAINEE ENGINEER-I / OFFICER-I:**

**NOTE:** Relaxations & Concessions will be applicable to candidates belonging to OBC-NCL/SC/ST/PwBD as per Government directives.

**AGE AS ON 01.01.2025:** The upper age limit will be relaxable for SC, ST candidates by 5 years and for OBC candidates by 3 years. Candidates belonging to Persons with Benchmark Disability (PwBD) category having minimum 40% disability or more will get 10 years' age relaxation in addition to the relaxation applicable to the categories mentioned above.

SSLC/SSC/ISC Marks Card or any other valid document will be considered as proof of Date of Birth.

**2. TERMS OF ENGAGEMENT & REMUNERATION:**

a) **Project Engineer-I** will be engaged for an initial period of 3 years, which may be extended up to maximum of ONE YEAR (Maximum tenure of 4 years) based on project requirement and individual performance. Candidates will be paid a consolidated remuneration of Rs.40,000/- per month for 1<sup>st</sup> year, Rs.45,000/- per month for 2<sup>nd</sup> year, Rs.50,000/- per month for 3<sup>rd</sup> year and in the event of extension of contract Rs.55,000/- per month for the 4<sup>th</sup> year.

- b) **Trainee Engineer-I / Officer-I** will be engaged for an initial period of 2 years, which may be extended up to maximum of ONE YEAR (Maximum tenure of 3 years) based on project requirement and individual performance. Candidates will be paid a consolidated remuneration of Rs.30,000/- per month for 1<sup>st</sup> year, Rs.35,000/- per month for 2<sup>nd</sup> year and in the event of extension of contract Rs.40,000/- per month for the 3<sup>rd</sup> year.

However, if any candidate has completed three years of tenure as a Trainee Engineer in BEL and is selected for the post of Project Engineer against this advertisement, he/she will be directly inducted as Project Engineer-II. The remuneration of such candidates will be Rs.45,000/- per month for the 1<sup>st</sup> year, Rs.50,000/- per month for 2<sup>nd</sup> year and Rs.55,000/- per month for the 3<sup>rd</sup> year. The overall tenure will be limited to 3 years only.

- c) In addition to the remuneration indicated above, a consolidated amount of Rs.12,000/- per year will be paid towards expenses like insurance premium, attire allowance, stitching charges, footwear allowance etc. The additional amount shall be paid in two installments. First installment will be processed in the first month's salary after joining and the second installment will be paid on completion of 6 months from the date of joining.
- d) **Retention Bonus for Project Engineers:** Project Engineers who join as Project Engineer-I and complete overall tenure of 4 years will be entitled for Retention Bonus of Rs. 25,000/- for every completed year. However, the retention bonus will be payable at the end of 4 years i.e., Rs. 1,00,000/-.

Retention Bonus will also be extended to Project Engineers / Officers who have advanced from Trainee Engineer role provided they complete overall tenure of 4 years in Project Engineer/Officer role. However, the retention bonus will be calculated for the tenure in Project Engineer role.

**Note:**

- a) B.E./B.Tech/B.Sc Engg (4-year course) with **PASS CLASS** from a recognized University / Institution in the relevant discipline are eligible.
- b) Candidate must possess all years / semester marks sheet and degree certificate. In case of CGPA grading, conversion certificate to substantiate the claim shall be attached and has to be indicated in the application form.
- c) In case there is no mention of specialization in the qualifying degree as required in the minimum essential educational qualification, candidates are required to submit a certificate at the time of interview from their University/Institution/College with a clear mention to their specialization in the qualifying degree.
- d) Candidates having indicated qualification with other disciplines will not be considered.

**4. POST QUALIFICATION EXPERIENCE (AS ON 01.01.2025):**

4.1 Minimum of 2 years of post qualification relevant industry experience is mandatory to apply for the post of Project Engineer-I.

4.2 Please note the following:

- a) Teaching/Research work, experience in non-profit organization, internship/project work placements which are part of academic curriculum will not be considered as experience. Work experience prior to completion of the relevant Graduation will not qualify as relevant Post Qualification Experience.
- b) Candidate should possess Experience Certificates/Documents issued by the previous and present employer clearly indicating period of employment and post held.
- c) One year completed Apprenticeship Training will be considered as experience.
- d) The Cutoff date for deciding the maximum permissible age and experience (Post Qualification Experience) shall be as on 01.01.2025. In order to compute post qualification experience starting from the month immediately succeeding the month of final examination in which candidate acquire the essential educational qualification shall be considered. Wherever specific relevant experience is prescribed, Experience certificates / Document issued by the employer clearly indicating the specific area of experience should be enclosed.
- e) Extensive travel to field locations all over India for installation, field testing and trials.
- f) The decision of the Selection Committee with respect to relevance of work experience will be final. Work experience indicated without supporting documents will not be considered and is liable to be rejected / cancelled without any prior intimation.

**5. SELECTION PROCESS & MODE OF SELECTION:**

a) **TRAINEE ENGINEER - I / OFFICER-I:**

- i. Candidates meeting the stipulated eligibility criteria specified in the advertisement, will be called for Written Test and candidates shall be selected in the order of merit i.e., category-wise, discipline-wise. The written test shall be conducted for **100 marks**.
- ii. The minimum qualifying marks required for suitability for different categories of candidates are as under:

- iii. The question paper will include **negative marking of 1/4 mark** for each wrong response.

b) **PROJECT ENGINEER-I:**

- i. The selection for the post of Project Engineer shall be through written test followed by interview for shortlisted candidates.
- ii. The minimum qualifying marks required for suitability for different categories of candidates are as under:

- iii. Candidates meeting the stipulated eligibility criteria specified in the advertisement, will be called for a Written Test (Objective Type).
- iv. The assessment weightage will be 85% and 15% for written test and interview respectively.
- v. The venue for the Written Test and Interview will be in Chennai.

## **6. HOW TO APPLY:**

- b) Candidates are required to enter all information correctly in the online application form and verify the same before submission, as changes shall not be permitted after submission of the application form.

## **7. APPLICATION FEE:**

- a) **Project Engineer - I:** General, EWS and OBC candidates are required to remit an amount of Rs.472/- (Application fee-Rs.400/- plus 18% GST)
- b) **Trainee Engineer-I / Officer-I:** General, EWS and OBC candidates are required to remit an amount of Rs.177/- (Application fee-Rs.150/- plus 18% GST)
- c) The application fee should be remitted through SBI Collect link provided. Candidates are requested to read the details and screenshots for making the payment. Candidates applying for both Project Engineer-I and Trainee Engineer-I / Officer-I posts are required to remit the fee separately for each post.
- d) Candidates can also make the payment by approaching SBI Branch. Candidates should select SBI branch in the payment option and download pre-printed challan generated through SBI Collect and deposit the application fee (as applicable) plus applicable bank charges in any SBI Branch. The candidate should ensure to obtain the seal and signature of the bank official.
- e) General, OBC-NCL and EWS candidates have to enter the "SBI Collect Reference No." generated after payment, in the Online Application Form. **SC/ST/PwBD Candidates are exempted from payment of application fee.**
- f) Candidates may go through all instructions and eligibility criteria carefully before remitting Application Fee and submitting the application. Fee once paid will not be refunded. Applications of candidates, who do not remit the prescribed application fee, will not be considered.

Caste / Tribe / Community / Disability / Economic status certificate in case of candidates belonging to SC / ST / OBC (NCL) / PwBD / EWS respectively. Candidates claiming reservation under any of the above categories are required to submit the certificate in the prescribed format. The formats of various certificates are provided as links to the advertisement. Candidates belonging to OBC (NCL) category should produce the certificate issued on or after 01.01.2024. - d) The posts indicated above may vary based on the actual requirement at the time of selection.
