**2. Age limit:**

The upper age limit indicated is for candidates belonging to General & EWS Category. The upper age limit will be relaxed by 3 years for OBC (NCL) candidates, 5 years for SC/ST and 10 years for PwBD candidates (having minimum 40% disability), in addition to the relaxation applicable to OBC (NCL)/SC/ST candidates).

**3. Period of contract:**

For Project Engineers initially for a period of Three (3) Years from the date of joining. However, the same may be extended upto a maximum of One more year (Maximum tenure of 4 years including the initial period) depending on the progress of the project and performance of the candidate.



#### 4. Remuneration:

**Project Engineer- I:** An all-inclusive consolidated remuneration of Rs. 40,000/- per month for the 1<sup>st</sup> Year of engagement and an increase of Rs.5000/- for every year of extension of contract.

**In addition to the above:**

- Consolidated amount of Rs 12,000/- per year** will be paid towards insurance premium, attire allowance, stitching charges, footwear allowance, etc. will be paid for Project Engineer.
- Area Allowance:** In order to compensate the hardship faced by Engineers/Officers who are posted outside the Unit / Regional Office locations of BEL, Area allowance shall be paid to such Engineers/Officers on monthly basis at the rate of 10% of the consolidated remuneration.
- Retention Bonus for Project Engineer/Officer:** Project Engineers/Officers who join as Project Engineer-I/Officer-I and complete overall tenure of 4 years will be entitled for Retention Bonus of Rs. 25,000/- for every completed year. However, the retention bonus will be payable at the end of 4 years i.e., Rs. 1,00, 000/-.

**Note:Teaching/Academic/Research work will not be considered as relevant post qualification industrial experience. experience in non-profit organizations and internship placements which are a part of academic curriculum will not be considered as experience.**

#### **SELECTION PROCEDURE:**

##### **a) MODE OF SELECTION:**

The Mode of Selection shall be through PRE- REGISTERED WALK-IN SELECTION in and around Project locations. The details of the venue, date and time of selection where the walk-in selection will be held will be published in BEL website career section along with the list of candidates who meet all the criteria as laid in the advertisement. Also e-mail will be sent to the



registered e-mail address indicating the venue, date & time of the selection to all shortlisted candidates.

The candidates meeting the qualifying criteria as specified in the advertisement shall mandatorily register through the Microsoft Office Form. Written test will be conducted for 85 marks for candidates meeting the stipulated eligibility criteria. Candidates passing the written test will be shortlisted for the interviews based on the above, in the ratio of 1:5. The schedule of the interviews will be provided in the written test call letter.

### **HOW TO REGISTER:**

### **STEPS TO FILL THE ON-LINE APPLICATION:**

- Candidates are required to fill in the necessary fields in the ONLINE form (Microsoft Office form) in the link provided/QR code provided in the advertisement and also published on the website. Submit the application form by clicking submit response.
- Save the response and take print of the application form duly filled in all aspects. Carry the printout of the filled in Application form with 2 recent passport size colour photograph along with relevant documents mandatorily to the selection centre on the day of pre registered walk- in selections which will be intimated at later stage on your registered email ID.

#### **b) Selection of Project Engineers:**

- Selection will be through a Written Test for shortlisted candidates, followed by an Interview, only for those candidates who qualify in the Written Test. **The venue for the Written Test / Interview will be intimated later.**



- 85% Marks will be allotted for the written test and 15% Marks for the interview. Candidates who pass the written test will be called for interview in the ratio of 1:5 in the order of merit in each role in each category.
- The names of candidates shortlisted after final selections will be notified on our Company's website.

In case of CGPA or credits system of assessments, the candidates are required to attach the formula for conversion of CGPA/ Credits to percentage in accordance with the respective University norms issued from the University. In the event of failing to do so the candidature will be cancelled.**
- All semester Marks Sheets/Final consolidated marks sheet.
