Should be Retired Railway employee having worked as Traffic Inspector/Station Manager in Railway establishments, should have experience in preparing the station working orders and safety manuals, temporary working instructions, should have knowledge of manual setting and locking of all points, arranging foot patrolling of the track and ensuring the section is clear and free from any obstruction for safe passage of train over the route before authorizing any movement. Knowledge of procedure for obtaining Power block and safe movement of train during non-interlocked working.
