However, if the number of eligible applications received is large/less, then Bank reserves the right to change the shortlisting criteria/selection process including multiple rounds / multiple stages. Bank may, at its discretion, consider conducting of Multiple Choice/Descriptive/ Psychometric Test / Group Discussion/Interviews or any other selection/shortlisting methodologies for different positions / scales.
