Bihar Rural Livelihoods Promotion Society (BRLPS), also known as JEEVIKA, is an initiative of the Government of Bihar aimed at addressing rural poverty by enhancing the social and economic empowerment of the rural poor through self-managed community institutions and sustainable livelihood opportunities. Currently, BRLPS is implementing several interventions under NRLM and SJY. To support its diverse programme interventions and meet emerging organizational requirements, BRLPS intends to empanel Specialized professionals across various thematic areas. The empanelled professionals will provide domain-specific technical expertise and professional support for assignments, capacity building, advisory services, and other specialized work as and when required by the Society. For this BRLPS needs to empanel reputed and experienced professionals in the field as specified hereunder.

Sl. No.	Area/Field	Eligibility Criteria
1.	Engineering Works	Eligibility: B.Tech/B.E./B.Sc. Eng. in Civil/Mechanical Engineering from any recognized University/Institution. Desirable Expertise: - Relevant experience in civil construction, multi-storey buildings, infrastructure development, structural works, quality assurance. - Relevant experience in mechanical engineering, operation, maintenance, commissioning and troubleshooting of machinery, project execution, process, supervision, or consultancy services. - Technical Competencies would be required in mechanical operation and maintenance of rotating equipment such as pumps, fans, blowers, compressor, gearboxes, conveyer, elevator and motors. Utility system including preventive predictive and breakdown maintenance planning. Root cause failure analysis (RCFA) and optimisation of mechanical system. Preparation of maintenance schedule, SOPs, Technical specification and inspection report. Safety management and statutory compliances related to mechanical equipment. Experience in institutional, rural development, industrial, or public infrastructure projects shall be preferred. - Working knowledge of AutoCAD, STAAD, Primavera or other relevant engineering/project management software; and digital reporting tools will be desirable advantage.
2.	Architecture	Eligibility: Bachelor of Architecture (B.Arch) or a Master of Architecture (M.Arch) from any recognized University/Institution. Desirable Expertise: Relevant experience in Architect engineering infrastructure development, project execution, supervision or consultancy services. Experience in structural systems, environmental studies, design theory, and building construction.
3.	Registration & Compliances	Eligibility: PGDM/PG in cooperative management/social work/ Rural Management/ Rural Development from any recognised University/Institution. Graduate degree shall be considered for the Government officials retired from BCEO/DCEO or AR. Desirable Expertise: - Relevant experience in community institution building and PRI convergence. Experience working with government systems preferred. - Strong knowledge of the Cooperative Act, statutory compliance and governance systems. - Experience in registration processes of SHG federations/CLFs/Community Institutions. - Capacity building and training module development expertise. - Liaison skills with cooperative department and district authorities.
4.	Health and Nutrition	Eligibility: M.Sc. in Clinical Nutrition & Dietetics, or MBBS with MD/MS in Obstetrics & Gynaecology, Community Medicine, General Medicine, or a PG Diploma in Endocrinology/Cardiology, or any other relevant postgraduate qualification from a recognized University/Institution. Desirable Expertise: - Relevant professional experience in clinical nutrition, public health, reproductive and child health (RCH), RTI/STI, maternal health, non-communicable diseases (NCDs), or related healthcare programmes. - Experience in providing technical support, capacity building, and implementation of health and nutrition interventions. Sound knowledge of maternal and reproductive health, nutrition, diabetes, hypertension, cardiovascular diseases, and public health programmes. - Experience working with government health systems, development partners, or large-scale public health programmes shall be preferred. - Registered Dietitian (RD) from a recognized statutory/professional body shall be preferred, wherever applicable.

5.	FNHW	Eligibility: PG Degree/Diploma in Rural Development/Development Management/Social Work/MA in sociology from a recognised institution. Desirable Expertise: • Relevant experience in training, content development and capacity building on Food Nutrition Health & WASH intervention in the field of Health, Nutrition and Sanitation • Good Communication & documentation skills is essential.
6.	Trainer on FNHW	Eligibility: Post Graduation in any discipline from a recognized university. Required Expertise: • Experience in Training & Capacity Building on Food Nutrition Health & WASH intervention, as well as conducting classroom training of community cadres/Staff/Dev. Professional. • Preference will be given to candidates having experience in SRLM/NRLM FNHW Strategy. • Excellent Facilitation, Presentation & Communication skills in Hindi & English languages. • Ability to prepare training reports/ Prepare Presentation.
7.	LoKOS (Lok-Operating System)	Eligibility: PG Degree/Diploma/Programme in Rural Development/Development Management/Social Work from a recognised Institutions. Desirable Expertise: • Relevant experience in NRLM/SRLM Programme. • Experience Should be in working on LoKOS or similar MIS Platform of NRLM. • Besides above experience in imparting training of LoKOS or MIS application is essential.
8.	HR Disciplinary/ Legal/Audit Compliances	Eligibility: MBA/PGDM with specialization in Human Resource Management (HRM)/Personnel Management/Industrial Relations/Labour & Social Welfare or allied disciplines recognized University/Institution. Desirable Expertise: • Relevant experience in Labor law and subject matter expert in Human Resource and personnel management.
9.	HR-MIS	Eligibility: Master's in computer applications, Information Technology, Computer Science, Data Science, Statistics, or any other relevant discipline from a recognized University/Institution. Desirable Expertise: • Relevant professional experience in Human Resource Information Systems (HRMIS), HR analytics, MIS management, or HR data administration. • Experience in designing, implementing, and managing HRMIS, employee databases, and digital HR processes. • Proficiency in Artificial Intelligence (AI), MS Excel (advanced functions), MIS reporting, dashboards, and data analysis tools. Knowledge of Power BI, SQL, or ERP/HRMS applications shall be preferred.
10.	Training & Capacity Building	Eligibility: MBA/PGDM with specialization in Human Resource Management (HR), Learning & Development, Organizational Development, Training & Development, Labour & Social Welfare, Personnel Management, or Industrial Relations or allied disciplines recognized University/Institution. Desirable Expertise: • Relevant experience in RTI/POSH ACT (ICC)/Knowledge of Labour Law/ Labour Act/Employee Compensation Act/ rules related to society. • Ability to develop training Modules/prepare presentation/ Work as trainer.
11.	Community Finance	Eligibility: M. Com from a recognized university/Institution. Desirable Expertise: • Person has worked in accounting. Bookkeeping and Audit in any Institution/Organisation. • He/she must have a basic knowledge of computer. This will help in supporting implementation of different digital Applications like Audit Module/ Lokos application/other MIS Module for Transaction etc. • Retired Banker will be an added advantage.
12.	Media/ Video Development	Eligibility: Postgraduate Degree or higher professional qualification in Journalism, Mass Communication, Film Production, Digital Media or a related field from a recognized University/Institution. Desirable Expertise: • Relevant professional experience in journalism, media, creative writing, editing, content development, or publication management. • Experience working with national or regional newspapers, electronic media, All India Radio, FM Radio, or other reputed media organizations. • Excellent command of written and spoken English, with strong editing, proofreading, and publication management skills. • Experience in developing high-quality communication materials, editorials, impact stories, reports, speeches, and other official publications.
13.	Design & Stitching	Eligibility: Postgraduate in Textile Engineering /Fashion Technology/Apparel Design or equivalent from a recognized University/Institution. Desirable Expertise: • Relevant experience in garment manufacturing, stitching unit promotion, skill development, Garment/uniform/Dress production, quality control, and market linkage.
14.	Food & Beverages (DKR)	Eligibility: Postgraduate in Hotel Management/Hospitality Management from a recognized University/Institution. Desirable Expertise: • Relevant experience in Hotel, Restaurant, food chain, hospitality industry. Canteen, café, Didi ki Rasoi, and similar experience.

15.	PMFME	Eligibility: MBA/PGDM/Rural Development/ Development Management/MSW/Master's/ Graduate in Food Technology, Food Processing/ MBA/M.Tech/Master's in branding packaging. Desirable Expertise: Relevant experience in Pradhan Mantri Formalisation of Micro Food Processing Enterprise (PMFME) /Food Processing/MSME projects, DPR preparation, credit linkage, FPO/SHG enterprise promotion, value chain development, and Government schemes, and similar experience.
16.	Incubation/ Enterprise Development	Eligibility: MBA/PGDM/Rural Development/Development Management/Labour & Social Welfare/MSW/MBA/M.Tech/PGDM in Entrepreneurship/Innovation Management or equivalent. Desirable Expertise: Relevant Experience in start-up incubation, enterprise incubation, business mentoring, entrepreneurship development, innovation ecosystem, capacity building, convergence with incubation centres, and implementation of Government/Development sector incubation programmes, or similar experience.
17.	One Stop Facility Centre	Eligibility: MBA/PGDM /Rural Development/Development Management/MSW/MBA (Finance)/M.Tech/PGDM or equivalent. Desirable Expertise: Relevant Experience in enterprise financing, One Stop Facility (OSF), credit linkage, business counselling, DPR preparation, bank coordination, financial inclusion, enterprise promotion under Government/NRLM/MSME programmes, and similar experience.
18.	Marketing & Branding	Eligibility: MBA/PGDM /Rural Development/Development Management/MSW/MBA (Marketing)/PGDM in Marketing/Brand Management/Graduate in Marketing, Design, Branding or equivalent. Desirable Expertise: Relevant Experience in marketing, branding, product development, packaging, digital marketing, e-commerce, market linkage, brand promotion, exhibition management, rural enterprise marketing, and similar experience.
19.	Veterinary Intervention	Eligibility: Post Graduate degree in M.V.Sc degree or B.V.Sc & A.H. degree with relevant experience in Livestock sector. Graduate degree shall be considered for Retired Central/State Government officials. Desirable Expertise: - S/he should have experience of providing training, treatment of Small Ruminant, having worked on preventive health/Ethno veterinary services of small ruminant. - S/he should be willing to travel to remote locations districts / blocks / villages for training and Demonstration.
20.	Natural /Organic Farming	Eligibility: PG in Agriculture/ Management/allied science from a recognized University/Institution. Desirable Expertise: Relevant experience in Natural/Organic farming/agriculture and allied sectors, sustainable livelihoods, project implementation, capacity building, or consultancy services.
21.	Procurement	Eligibility: B.Tech/B.E./Diploma/PG Diploma in Materials Management from a recognized University/Institution. Desirable Expertise: S/he should have experience the field of materials management/Supply chain Management (Procurement, Stores management & Inventory management including logistics matters) mainly procurement of goods &/or services through tendering on GeM/CPP portal as per Govt. guidelines/GFR. Experience in any ERP environment will have an added advantage.
22.	External relation and fund utilization	Eligibility: Postgraduate degree in Social Work/Rural Management/Rural Development. Desirable Expertise: Post-qualification relevant work experience at State or central government program in fund management, external department relation, UC / AC DC bill adjustment etc. Retd Govt. employee will be given added advantage.

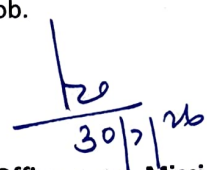
- Interested Professionals who fulfils the eligibility criteria specified against the requisite field are required to submit their updated Resume/CV in the prescribed format (available on the BRLPS website: www.brlps.in) by email to recruitment@brlps.in, with the subject line "CV for Empanelment of Professionals in BRLPS".
- Last Date for submission of Resume/CV is up to 17 / 08 / 2026.
- Candidates must clearly indicate in their Resume about their preferred district(s) for extending services. In case the candidate is willing to be work anywhere in the State of Bihar, they should explicitly mention "Willing to work anywhere in Bihar".
- Hard copies of certificates/mark sheets are not required to be submitted by post to the BRLPS.
- Persons who had been separated from the organisation on disciplinary grounds, need not apply as their candidature will not be considered.
- This empanelment will be valid till 2 years from the date of publication of the list of empanelment.
- The selected Professionals will be empanelled with BRLPS and their services may be utilized as and when required in a time-bound manner.
- Minimum five years of relevant professional experience is required for consideration of CVs for empanelment.

9. Retired officials from Government/PSUs/Society/officials/Bankers/ Doctors having graduate or equivalent degree are also eligible to apply.
10. The honorarium will be paid as per the decision approved by the Competent Authority. No request for change in the approved category or honorarium shall be entertained for the entire period of empanelment. Any Claim for remuneration based on Degree or experiences will not be entertained.
