Applications are invited from the male and female ST candidates only belonging the state of Mizoram (Domicile) for the post of Constable(General Duty) in Border Security Force (BSF) in the Level -3 (Rs.21,700 – 69,100) in the pay matrix as per 7th Central Pay Commission plus usual and admissible allowances to Central Govt. employees from time to time. In addition, Ration allowance, Medical Assistance, Uniform allowance, Free accommodation, LTC etc. as admissible to Central Govt. employees. The post has all India liability and selected candidates can be posted anywhere in India and abroad. They will be governed under relevant BSF Act and Rules as well as CCS(Conduct) Rules as amended from time to time. The selected candidates will be governed by the New Contributory Pension Scheme (NPS), which came into effect from 1st January 2004 or the Unified Pension Scheme (UPS), as per option exercised by the candidate.

### 5. <u>ELIGIBILITY CONDITIONS</u>

- a) Age :- Between 18-28 years (including 5 years relaxation) as on 01.08.2025 i.e. candidates must have born not earlier than 02.08.1997 and not later than 01.08.2007.
- b) Education: Minimum 10th class at the time of Recruitment.

ii) Physical Efficiency Test (PET)

(i) Male - 5 KMs in 24 minutes.

(ii) Female 1.6 KMs in 8.30 minutes.

iii) Incentives/ bonus marks for NCC certificate holders shall be as under:-

a) 'C'.Certificate :- 5% of maximum marks of the examination.

b) 'B' Certificate :- 3% of maximum marks of the examination.

c) 'A' Certificate :- 2% of maximum marks of the examination.

Note:- Candidates who wish to be considered against vacancies reserve or seek age relaxation must submit requisite certificate from the Competent Authority as per prescribed format. Otherwise, their claim for Schedule Tribe (ST) status will not be entertained and their candidature/applications will be rejected. The caste of the candidates who claim to be belonging to ST category should be enlisted in the central list of Mizoram issued by the prescribed authority.

#### 7. MEDICAL STANDARD

The candidates will be medically examined in terms of guidelines for recruitment Medical Examinations in CAPFs and AR issued vide MHA UO No. A-VI-1/2014/Rectt(SSB) dated 20.05.2015, MHA OM No.E-32012/ADG(Med)/DME&RME/DA-1/2020(Part file)/1166 dated 31.05.2021 and subsequently amended from time to time.

#### Eye Sight:

i) The minimum distant vision should be 6/6 and 6/9 both eyes without correction i.e. without wearing glasses.

iii) The candidates must not have knock knee, flat foot, varicose vein or squint in eye/eyes and they should possess high colour vision. They must be in good mental and physical health and free from any physical defect likely to interfere with the efficient performance of the duties.

The application forms should be enclosed with the following documents:-

- i) Candidates have to fill up the application form only in English or in Hindi language.
- ii) Self-attested copies of certificates/testimonials as proof of education as well as date of birth.
- iii) Self-attested copy of Caste Certificate (ST) issued by the prescribed authority.
- iv) Self-attested copy of Domicile certificate and any one of the identity proof i.e. Aadhar card, Voter ID or Ration Card Etc.
- v) Form as per <u>Annexure-II</u> (copy enclosed) for issue of Admit card duly filled with a passport size photograph alongwith the application form be submitted.
- B) INCOMPLETE APPLICATION WILL BE SUMMARILY REJECTED AND NO CORRESPONDENCE ON THIS WILL BE ENTERTAINED.
- C) Admit Card with roll number and general instructions for appearing to the selection process will be issued to the eligible candidates after successful submission and registration of their application forms at the Examination centers. They will be called to appear for the selection test at the PST/PET center on the subsequent day/days. No TA/DA is admissible for the candidates.

### 11. RECRUITMENT PROCESS VIZ PHYSICAL STANDARD TEST (PST), PHYSICAL EFFICIENCY TEST (PET) AND WRITTEN TEST

Candidate who have been issued Admit Cards will report at the PST & PET center on the given date and time to undergo the following process:-

- a) All eligible candidates will be asked to go through the Height Bar and thereby, candidates with lesser height will get eliminated.
- b) Those candidates who qualify the Height Bar will be subjected to 5 KMs race (for Male) and 1.6 KMs race (for Female) to be completed within 24 minutes and 8.30 minutes respectively.
  - c) Physical efficiency tests will be only qualifying in nature and it will not carry any marks. If the qualifying candidates are more than the vacancy, merit of the candidates will be decided during final result/selection.
  - d) Testimonials of the candidates will be checked after the identification process and eligible candidates will go to the next step.
  - e) Candidates who are found eligible on screening of testimonials will be screened first for height, chest and weight (weight will not be a disqualification at the stage of PST). However, it will be assessed for disqualification during medical examination (with reference to height/age standard chart) measurements.

- f) The candidates who qualify on the PST & PET will be required to appear for the written test.
- g) The written test will consist of only one paper OMR based objective type multiple choice questions. The question paper will be of 100 marks comprising of 100 questions. The duration of question paper will be 02 hours.
- h) The standard of question paper will be of 10th standard.
- i) The question papers written examination will be set to assess the general awareness/ general knowledge, knowledge of elementary mathematics, analytical aptitude and ability to observe and distinguish patterns and to test the basic knowledge of the candidate in Hindi & English languages only.
- j) The cut off percentage of marks for qualifying for all candidates will be 20%. Only those candidates who have scored above cut-off marks, will only be called for medical examination.

#### 11. MEDICAL EXAMINATION

Candidates declared qualified in the written test will be shortlisted for appearing in Medical Examination Test, in proportionate to the available vacancies. Medical Examination will be conducted as per BSF Medical Manual, Uniform guidelines issued vide MHA UO No. A-VI-1/2014/Rectt(SSB) dated 20.05.2015, MHA OM No.E-32012/ADG(Med)/DME&RME/DA-1/2020(Part file)/1166 dated 31.05.2021 and subsequent instructions for conducting medical examination issued by ADG(Medical), CAPFs.

- (i) <u>Candidates reporting at the PST & PET centers after 18.09.2025</u> for registration of their applications, will not be entertained.
- (ii) Incomplete application form will be rejected straightway.
