Filling of the post of Administrative officer in CGST & Central Excise, Raigad Commissionerate on deputation basis-reg.

In pursuance of the Board's letter F.No.A-26017/91/2017-Ad.II.A dated 16.03.2022 and CGST & Central Excise, Mumbai Zone letter F.No.II/13-CCA-04/GST-MZ/DEP/AO/2022/926 dated 28.04.2022; this office propose to fill posts of Administrative officer by way of deputation. The details are as under:-

The above post will be filled up by way of deputation as per under mentioned eligibility criteria as prescribed in the Ministry of Finance, Department of Revenue, Central Board of Indirect Taxes & Customs, Administrative Officer, Group 'B' post Recruitment Rules, 2020, which is as under:

Deputation:

Officers of the Central Government or State Government or Union territories:

- (a) (i) holding analogous posts on regular basis in the parent cadre or Department; or
 - (ii) with five years regular service in the grade rendered after appointment thereto on regular basis in level-6 in pay matrix(Rs. 35400-112400) or equivalent in the parent cadre or Department.
- (b) Possessing the following education qualification and experience:
 - (i) Bachelors degree from a recognized University or Institute.
 - (ii) Two years experience in Accounts, Administration, Establishment work in a Government Office or Public Sector Undertaking or Autonomous body or statutory body.

Note 1: The period of deputation including the period in another ex-cadre post held immediately

preceding this appointment in the same or some other organization or department of the Central

Government, shall ordinarily not exceed five years or extended as per the guidelines issued by

the Government of India from time to time.

Note 2: The departmental officer in the feeder category who are in the direct line of promotion

shall not be eligible for consideration for appointment on deputation. Similarly, deputationists

shall not be eligible for consideration for appointment by promotion.

Note 3: The Maximum age limit for appointment by deputation shall not be exceeding fifty six

years as on the closing date of receipt of application.

3. It is requested that the applications of willing and eligible officers may be forwarded to

this office with particulars viz name, address, education qualification, date of birth, present

posting, date from which the present post is held, scale of pay, ACR grading of last 05 years and

also 'No Objection Certificate' and 'Vigilance Clearance'. The willing and eligible officers are

requested to send their application through proper channel addressed to 'The Commissioner,

CGST & Central Excise, Raigad, Plot No. 1, Sector -17, Khandeshwar, Navi Mumbai- 410206".

No advance copy will be entertained.

4. The officers who are selected would be normally appointment for a period of 03 years &

will also be eligible for Deputation Allowance as applicable. They will not be allowed to

withdraw their name and will also not be relieved till the expiry of tenure of three years. If the

performance & conduct of the officer is not found to be satisfactory during his/ her tenure in this

Commissionerate, the officer will be repatriated to the parent Commissionerate/ Directorate even

before completion of the deputation period.

5. It is requested that this circular may please be brought to the notice of all the formations

under your jurisdiction.

6. The last date of receipt of application is 30 days from the date of publishing of this

circular.
