**Essential Qualifications as prescribed by UGC**

**Eligibility (A or B) :**

**A.**

i) An eminent scholar having a Ph.D. degree in the concerned/allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in UGC Regulations, 2018.

ii) A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor/Professor, and / or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate.

**OR**

**B.**

An outstanding professional, having a Ph.D. degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above) / industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience

1.A minimum of 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed) at the Master's level shall be the essential qualification for direct recruitment of teachers and other equivalent cadres at any level.

2. A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differently abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d)including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.

3.A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September, 1991.

4.A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by recognized university, at the Master's level shall also be considered valid.

5.The Ph.D. Degree shall be a mandatory qualification for appointment to the post of Professor.

6.The time taken by candidates to acquire M.Phil. and / or Ph.D. Degree shall not be considered as teaching/research experience to be claimed for appointment to the teaching positions. Further the period of active service spent on pursuing Research Degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience for the purpose of direct recruitment/ promotion.

### **Essential Qualification -II**

Masters Degree in Law and PhD in concerned/allied/relevant area.

### **General Information**

(1) Applications should be routed through proper channel only.



(2) The prescribed essential qualifications are the minimum and mere possession of the same does not entitle candidates to be called for interview. Where the number of applications received is large and/or where it will not be convenient or possible to interview all the candidates, the University at its discretion may restrict the number of candidates to a reasonable limit on the basis of higher qualifications/experience than that prescribed in the advertisement.

(3) The period of deputation will be initially for a period of one year or till a permanent Professor joins the concerned Department whichever is earlier.

***(4) Changes in Regulations on qualifications, experience, age, calculation/application of API Scores, etc. issued by the UGC subsequent to this notification will become mandatory from the respective dates of effect prescribed.***

(5) The University reserves the right to -

(a) not to fill up any or all posts advertised.

(b) Offer a post at a lower/higher level than notified, depending upon the qualifications, experience and performance of a candidate

(c) relax any of the desirable qualifications/experience at its discretion for reasons to be recorded.

(6) The qualification prescribed shall be as on the last date of receipt of application.

(7) Outstation candidates (beyond 20 km) belonging to SC/ST/DA categories called for interview will be reimbursed single second-class railway fare from station to station towards journey expenses on production of ticket/proof and proof of category.

(8) Selection will be made on the basis of candidates' performance at the interview. The University may utilize seminar and/or colloquium as a method of selection.

(9) The pay and allowances will be governed strictly as per the government of India Rules prescribed for deputation.

(10) No interim queries regarding test/interview/selection will be entertained.

(11) Canvassing in any form will be a disqualification.

(12) In case of any disputes, any suits or legal proceedings against the University, the jurisdiction shall be the Hon'ble High Court of Kerala.

(13) Interested persons should apply along with two recent passport size photographs, photo copies of all supporting documents.
