Emoluments	-	Rs.30,000/- per month (Consolidated)
Essential Qualification	-	Graduate or Postgraduate in Fish Processing/ Post-harvest technology in fisheries/ Industrial Fisheries Technology/ Food Science & Technology.
Desirable	-	Candidates with working experience in the fish product development, packaging and fish quality and safety evaluation are preferred. Candidates with relevant scientific research publication in the above area are desirable. Candidates should be willing to travel independently anywhere in India, as required by the project.
Age limit	-	Candidates should be above 21 years and maximum of 45 years as on date of interview. Age relaxation as per rules.

1. Registration will begin at 9.00 am and will close at 10.00 am
2. **Date & Time of Interview: 18.12.2025 at 10.30 a.m.**
3. Age limit (as on 18.12.2025): Age relaxation of 3 years for OBC candidates and 5 years for SC/ST candidates is permissible.
4. Candidate should possess 1st class or 60% marks or equivalent overall GPA.
5. Candidates are required to submit detailed bio-data (in the enclosed format) affixing a recent passport size photograph along with attested copies of all the Certificates in support of their claims regarding age, educational qualifications, experience, Scheduled Caste/ Scheduled Tribe/OBC etc. **The original certificates shall be produced for verification before the interview.**
6. **The recruitment will be held in strict compliance with the ICAR O.M. dated 04.12.2020 & 07.12.2023.**
7. The selected candidate will be recruited on contract basis under ICAR norms. The post is purely temporary correspondence will be entertained from the candidates for selection/ appointment.
8. The selected Young Professional is entitled for 08 days CL and 02 days RH in a calendar year on pro rata basis as per the ICAR OM dated 04.12.2020.

9. The candidate attending the interview should ensure that they fulfill all the eligibility conditions. No correspondence will be entertained from the candidates for selection/test/appointment.
10. Candidates already employed should submit "No Objection Certificate" from the present employer while attending the interview.
