The present assignment is purely temporary in nature.

Selected candidate has to conduct experiments in laboratory, pilot plant and also in the recycling industries when deputed. He/she has to generate data, report to supervisors during experiments and pilot plant trials. He/she has to strictly adhere to safety requirements. The selected candidate has to travel anywhere in the country as and when required. One of the selected candidate may be deputed at MeitY, New Delhi, if required.
