**B. General Instructions to the Applicants:**

1. The candidate must be a citizen of India.
2. All educational qualifications must be from a recognized Board/University/Centre only. 3. Each post carries retirement or terminal benefits as per Government of India norms and as applicable/adopted by the Centre from time to time.
4. Relevant experience gained after obtaining the minimum qualifying degree only will be considered.
5. Applicants must ensure, before applying, that they possess the minimum essential qualifications and experience prescribed for the post. Qualification must be obtained from a recognized University/Centre. Eligibility with respect to age, qualification and experience shall be determined as on the last date of receipt of application.
6. The Centre reserves the right to restrict the number of candidates for written / skill tests/interviews to a reasonable limit based on qualifications, level, and relevance of experience higher than the minimum prescribed in the advertisement. The Centre also reserves the right NOT to fill any of the post(s) advertised.
7. The prescribed Essential Qualification and Experience indicated are a bare minimum; mere possession of the same will not entitle applicants to be called for Test[s] and/or Interview. 10. In case of any inadvertent mistake is committed in the process of selection, which may be detected at any stage, even after the issue of the appointment letter, the Centre reserves the right to modify/ withdraw/ cancel any communication made to the candidates.
11. Direct recruitment to all the positions shall be made on probation for one year/two years, as per the Recruitment Rules. Probation may be extended, if necessary, as per norms.
