1. The position is purely temporary, time-bound and co-terminus, the selected candidates shall not claim for regular appointments at ICAR-CMFRI.
2. Young Professional-I will be hired on a monthly consolidated emolument of ₹. 25,000/- (Rupees Twenty-Five Thousand only).
3. Age limit: 21 - 45 years, as on date of interview (Age relaxation SC/ST/ OBC/PWD/ Women and other exempted categories as per ICAR / GOI guidelines).
4. All the relevant testimonials in original (date of birth, degree certificate, experience certificate, etc.) required to be shown with a set of self- attested copies of all the certificates by the candidates for verification as & when instructed.
5. The candidates having edge over others on possession of essential and desirable qualifications will be short-listed and called for interview.
6. No TA/DA/ any other expenses will be paid for attending the interview.
7. Concealing of the facts or canvassing in any form shall lead to disqualification or termination of the candidate. The decision of the Director, ICAR-CMFRI will be final and binding in all respects.
