The CSIR-Traditional Knowledge Digital Library (CSIR-TKDL) Unit is a constituent of Council of Scientific and Industrial Research (CSIR), an autonomous body with the Department of Scientific and Industrial Research (Ministry of Science and Technology). It is engaged in protection and preservation of India's vast traditional knowledge present in ancient texts by digitizing the information into modern languages in a structured format. The key objective is to prevent misappropriation of Indian traditional knowledge through wrong acquisition of intellectual property rights.

The engagement under projects is purely temporary, time-bound and on contract basis. The engagement is initially up to 31st March 2025 and maximum until 31st March 2027 *i.e.*, co-terminus with the tenure of projects. The extension of tenure beyond 31st March 2025 will be subject to progress review by Review Committee at the end of the financial year or earlier, as deemed necessary. Job Requirement:

For all posts preference will be given to those with proficiency in applicable domain, working knowledge of computers and commonly used software packages.

General Instructions:

- (b) Candidates who wish to apply for more than one post need to apply separately for each position / post code.
- (c) Incomplete applications or applications received through any other mode will not be accepted.
- (d) Candidates must fill complete details related to their educational qualification, experience, etc.
- (e) Candidates are required to upload scan copy of following original documents while applying online, failing which their candidature will be summarily rejected- Certificates establishing (i) Educational Qualifications (matriculation onwards); (ii) Age; (iii) Reservation/Statutory Category (in case SC/ST/OBC/PWD/EWS candidates); (iv) Experience Certificate, if any; (v) Publications/Patents, if any (vi) detailed biodata.
- (f) After submission of the application, candidates are advised to keep with them the generated Application No. for future correspondence.
- (g) Candidates must fulfil the essential criteria and other stipulated criteria as on 17 January 2025.
- (h) Candidates should be present in-person at CSIR-TKDL Unit, 14, Satsang Vihar Marg, Qutub Institutional Area, New Delhi – 110067 for a written test/interview at the above-mentioned date and time. The results of the written test will be declared on the same day. The interviews of shortlisted candidates will take place in hybrid mode (offline and online) on the day of written test or another day, as informed after the written test. If committee so desires, the candidates will be asked to give their interviews in person and will be informed accordingly. The candidates are requested to wait for result of written examination/instructions unless informed otherwise.
- (i) The candidates must carry with them original certificates/testimonials at the time of written test along with two copies of self-attested photographs and a set of selfattested copies of certificates/testimonials in support of age, qualification, marks obtained, experience, if any, etc. The candidates must also carry a copy of their biodata neatly typed on A4 paper.
- (j) The candidates belonging to reserved/statutory categories must bring their original certificate of categories to which they belong in the prescribed format issued by the competent authority (along with self-attested copies of the same).
- (k) In case the final certificates reflect CGPA/SGPA/OGPA Grades, the candidate should convert the same into an equivalent percentage as per the approved formula of the University in the online form, and a copy of such conversion must be uploaded while submitting online form.
- (1) If currently employed, then the candidate will have to furnish <u>No-Objection Certificate</u> from the current employer at the time of joining.

Note:

- 9. The project staff may be required to travel as per need.
- 10. Reservation (SC/ST/OBC/PwD/EWS) will be applicable as per CSIR/Govt. of India rules on the subject.
- 11. Head, CSIR-TKDL Unit reserves the right to increase/decrease the number of positions and also cancel the engagement process for the positions mentioned above at any stage of the engagement process.
