

NOTE CONTINUED:

As per the instructions of the Chairman / Collector and District Magistrate, Guntur the following procedure for the recruitment and Notification and schedule for recruitment here with submitted for approval vacancies in the District Health and Family Welfare Society, Guntur.

Procedure of the Recruitment:

1. The posts should be advertised by the District Health and Family Welfare Society (NTEP) in at least two leading News papers published in the district. Applications will be received through online and shortlisted based on the qualification in the CTD guidelines to the fulfillment of eligibility criteria.
2. Local Candidates should be selected.
3. The District Health and Family Welfare Society should maintain Roster points to fill up the posts and such roster points to be mentioned in the Notification, which roster point is going to fill up in each category to be shown in the notification.
4. Candidates removed from any District Health and Family Welfare societies like District Health and Family Welfare Societies, District Health and Family Welfare Societies (RNTCP), etc., will not be considered and their applications will be rejected.
5. As there is no definitive selection criteria the recent issued guidelines for recruitment by the State Government may be accepted for selection if approved by the Chairman. Selection procedure will be made by adopting the Government of Andhra Pradesh G.O.MS. No. 105 HM&FW (B.2) Department, Dated 16.07.2013 read with G.O.MS. No. 163 dated 12/09/2018.

Merit Candidates will be selected as per the following criteria:

CRITERIA	WEIGHTAGE (Total Marks 100)
Aggregate of Marks obtained in all the years in the qualifying examination	75%
Weightage for experience of Government service including contract service and outsourcing.	Upto 15% (i) @ 2.5 marks per six months in Tribal Area (ii) @ 2.0 marks per six months in Rural Area (iii) @ 1.0 marks per six month in urban areas
Weightage for No. of years since passing qualifying examination	Upto 10 marks @ 1.0 marks per completed year after acquiring requisite qualification


