Note:-The candidates selected on adhoc basis against reserved seat will be appointed for a period of 44 days extendable upto a maximum period of 01 year or till the regular candidate joins whichever is earlier.

Qualification: - MBBS from recognized university/institution and must possess valid Registration Certificate from Delhi Medical Council. The candidate having completed compulsory rotatory internship within 02 years of date of interview shall be given preference.

Pay Scale:- As per pay matrix of level 10 (Rs.56,100 - 1,77,500/-) plus allowances as admissible under the rules.

Age:- 30 yrs for General (5 yrs relaxable for SC/ST,3 yrs relaxable for OBC and 5 yrs extra relaxable for physically handicapped candidate) as on date of interview.

Tenure:- The maximum tenure of junior residents (MBBS) is for a period of one year only including any service rendered as junior resident earlier on ad-hoc/regular basis in any recognized institution. The appointment will be initially for 6 months or on prorata basis that can be extended further upto a maximum period of 1 yr subject to satisfactory work and conduct report from concerned Incharge and vigilance clearance.

For physically handicapped candidate relaxation is admissible as per Govt of India rules upon submission of Handicapped Certificate from the competent authority.

- Candidates are required to bring all original certificates and testimonials along with two recent passport size photographs on the date of interview.
- Appointment shall be subject to medical fitness and verification of certificates.
