SCREENING & SELECTION PROCESS

On the day of selection, applications and the certificates of the candidates will be screened to ascertain their eligibility for the post applied. - a) Latest Passport size colour photograph in .jpg/.jpeg format of not more than 75 KB size
 - b) Signature in .jpg/.jpeg format of not more than 25 KB size
