2 (I) **Eligible candidates will appear in the Interview through video conferencing only and therefore they should forward their CV/ Bio-data in the format provided at Annexure-I alongwith self attested certificate in proof of education/ experience/ age/ caste etc. through e-mail at shama@eis.ernet.in by 03:00 pm on 08th July 2020.**

(Shortlisted candidate will be informed by return email indicating tentative time enabling them to attend the interview through video conferencing on the day of interview mentioned above. (Candidates intend to appear in the interview through VC should must have Whatsapp/ Google meet or any other such facility to interact through VC)

3. The appointment against the above mentioned positions shall be purely on contract basis on consolidated pay for a fixed duration and against specific approved projects.
4. Upon Selection of candidate, the candidates would be appointed initially for a period of one year, which may be extended up-to a maximum of project duration (Not exceeding three years) and or curtailed based on the performance and requirement of the project. Further, incumbents so engaged under a particular project can be transferred to another project during or on completion of the project in which he/she originally deployed, in the organizational interest.

5. Candidates presently working in a Government / Semi-Government / Public Sector Undertaking / Autonomous Body are required to e-mail a "No Objection Certificate" from their present employer at the time of interview/test etc., if called for, failing which they will not be permitted to attend the interview.
6. The date for determining the upper age limit, qualifications and /or experience shall be date of walk in interview. Person below the age of 18 years are not eligible for consideration of selection.
7. Experience means post qualification experience and it will be counted after attaining minimum qualification as prescribed above.
8. Essential qualifications as prescribed above should be a full time regular course(s) from AICTE/UGC approved/recognized University/Deemed University/Institutes.
9. Monthly remuneration will be subdivided / bifurcated as per applicable finance norms of ERNET India.
10. Reservation and relaxation as admissible for SC/ST/OBC/EWS will be applicable as per the Govt. of India norms, as applicable to ERNET India.
