- The doctors will be empanelled on the basis of the eligibility criteria, capitation fees offered by the applicant.
- ii) A list of empanelled doctors as L1, L2 and 13 (as per requirement) shall be prepared based on % of CGHS package/procedure rate in the increasing order.
- iii) L1 empanelled doctor from the list shall be called for the professional services. However, If the first (L1) doctor on empanelment is not available then the next empanelled doctor on the panel may be called up based on the urgency of procedure.
- iv) If the empanelled doctor does not provide the post-operative care after the procedure, Medical Superintendent may call next empanelled doctor for the same and proportionate deduction shall be made from the first empanelled doctor who had performed the procedure.

2. Terms and conditions

- i) The Appointing Authority reserves the right to cancel the offer/advertisement without assigning any reason thereof.
- ii) The empanelled doctor shall sign the acceptance of offer letter.
- iii) **Age limit-** Candidate should not be more than 70 years on the date of interview, an intimation of which will be sent through email and mobile number.

3. Duties & Responsibilities of empanelled doctor

- i) The empanelled doctor, whenever called for, will provide the professional services to the ESIC beneficiaries at ESIC Hospital as per terms and conditions based on offer of professional fees linkedto CGHS package/procedure.
- ii) The empanelled doctor shall also provide post procedure care with minimum of two visits per day (one in morning and another in evening), till the patient is discharged.
- iii) The empanelled doctor will be available round the clock for professional services.

iv) ESIC may shift the patient to higher centre in case of emergency or exigency and when the situation arises in order to save the life of the patient.

5. Agreement & Applicability of laws
