Child Psychologist:

A. Academic qualification to be eligible for engagement is given below:

- M.A/M.Sc. in Psychology with M. Phil in Clinical Psychology from a recognized University or equivalent.
- At least 2 years' experience in Child & Adolescence mental health.

Desirable: - Ph.D. in Clinical Psychology from a recognized University or Institution.

B. Age Limit: Between 21-35 years as on date of reporting for interview.

B. Pay & Allowances:

Consolidated Remuneration - Rs. 47,838/- . No other allowances in any form shall be admissible. Private practice of any kind will not be allowed. The above engagement will be for a maximum period of **one year** or appointment of regular incumbents whichever is earlier.

General Terms and Conditions for Child Psychologist

Terms of Contract:

1. **Child Psychologist** - The Contractual engagement will be for a maximum period of **one year** or appointment of regular incumbents whichever is earlier.
2. The Child Psychologist will be entitled for leave as per the Contractual Labour [Regulation & Abolition Act] 1970.
3. Rules for Reservation will be implemented as per Govt. of India instructions.
4. The Appointment shall not confer any right or preference for regular appointment.
5. No claim for any service benefits like PF, Pension, Gratuity, Medical allowances, Medical benefits, Seniority, Promotion etc. will be admissible.
6. Candidate must be registered with State Medical Council/NMC as applicable, before joining the post.
7. Candidate in the Government Service should submit "No Objection Certificate from the employer at the time of Interview.
8. The candidates who are already employed must produce relieving order from the previous employer at the time of joining.
9. No TA/DA will be admissible for interview or joining.
10. ESI Corporation may increase or decrease or cancel filling up of any or all posts without assigning any reason at the discretion of the Appointing Authority.
11. The DEAN has the discretion to increase/decrease the number of vacancies depending on actual requirement or to cancel this recruitment or to withdraw offer of appointment.
12. The Child Psychologist so selected will be required to submit acceptance/consent letter in writing before appearing for medical examination.
13. The doctors at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of the notice period.
14. The absence from work for a period of fifteen days without proper permission of the competent authority will amount to voluntary abandonment of engagement and automatic termination. The Medical Officers are required to mark attendance manually as well as on Aadhar Enabled Bio-metric Attendance System (AEBAS) daily during scheduled working days.
15. They will also be required to attend emergency, floor duty and other clinical duty as assigned by the Competent Authority.
16. They will also be required to perform duties in other departments as assigned by the competent authority.

17. Selected candidates will have to join duty on or before the date indicated in the offer of appointment/engagement likely to be issued.
18. The Child Psychologist so engaged will be required to enter into a contractual agreement for the purpose on a **stamp paper of Rs.100/-**
