4. Terms of Contract:

- (i) The contractual engagement may be terminated/ discontinued from either side giving one-month prior notice to this effect without assigning any reason. In case of spot resignation, one month's salary is to be deposited to ESIC Account through Challan.
- (ii) Accommodation for Junior Residents is compulsory in the Campus.
- (iii) Submission of marital status and declaration of having only living spouse in case of married individual and taking oath of allegiance/ faithfulness to the to the Constitution of India.
- (iv) He/ She will be required to attend emergency duties as assigned by the competent authority besides departmental duties and other duties assigned to him/ her.
- (v) He/ She will be entitled to avail 2 (Two) days off for each completed calender month and it can be carried over for a maximum period of up to 4 (Four) days for two consecutive months.
- (vi) Other terms and condition will be applicable as issued by Competent Authority from time to time.
- (vii) Selected candidates may be posted in any department.


