**GENERAL INSTRUCTIONS TO CANDIDATES AND MATHOD OF APPLICATION TO  
APPEAR IN WALK IN INTERVIEW**

1. The number of vacancies may be changed without any prior notice.
2. No TA/DA will be admissible either for the 'Walk- in- interview' or for joining the post.
3. The Competent Authority reserves the right to fill up all or not to fill up any post or cancel any vacancy/interview at any stage.
4. The selected candidates will have to join on or before the stipulated date given in offer of appointment.
5. The selection is subject to the candidates providing their medical fitness Certificate issued by appropriate competent authority.
6. Candidates must be registered with Medial Council of India before joining the post.
7. The candidate who is in the Service should submit "No Objection Certificate" from the employer at the time of interview.
8. **The selected candidate will have to furnish a DD/Bankers Cheque for an amount of Rs. 30,000/- (Rupees Thirty Thousand Only) drawn in favour of 'ESIC fund A/c No 1' payable at Raipur, towards security deposit.**
9. Candidate seeking reservation benefits for SC/ST/OBC/EWS must ensure that they are entitled to such reservations as per eligibility prescribed in the Notice. 
1. Selected candidates will have no claim for regularization of the service in the hospital or No claim for any service benefit like, PF, Pension, Gratuity, medical Allowance, Seniority, and Promotion.
2. The appointee shall not claim any right or preference for regular appointment.
3. In case regular candidate joins, the appointment shall be terminated as per the condition of the contract.
4. Must be available on call 24x7, if he/she is drawing/opted for emergency call charges.
5. The Specialist shall be responsible for all cases undergoing treatment under his supervision in his speciality.
6. Private practice of any kind will not be allowed for full time contractual engagements.
7. The posts are contractual and the contractual engagement may be terminated / discontinued by either side giving one month prior notice to this effect without assigning any reason.
8. In case of selection, the candidate has to enter into an agreement with Medical Superintendent, ESIC Hospital, Raipur on Non-judicial stamp paper of Rs 100/- ,Upon joining, the selected candidate has to submit a security deposit of Rs. 30,000/- (Rupees Thirty Thousand Only) as Demand draft in favour of 'ESIC Fund Account No.1' payable at Raipur, which is refundable after successful completion of contract and production of 'No dues certificate'.
