Subject:- Filling up of various Group B & C posts in the Food Safety and Standard Authority of India (FSSAI) through transfer on deputation (including short term contract) on Foreign Service terms-reg.

Food Safety and Standards Authority of India (FSSAI) is a Statutory Authority set up under the Food Safety and Standards Act, 2006 for laying down science based standards for articles of food and to regulate their manufacture, storage, distribution, sale and import, to ensure availability of safe and wholesome food for human consumption.

2. FSSAI proposes to fill-up **various Group B & C** posts on deputation (including short- term contract) on foreign service terms basis as per the details contained in **Annexure-I**. A brief description of duties attached to the post is contained in **Annexure-II**. Applicants fulfilling the eligibility criteria as on closing date of applying online, shall apply online on the link available under the tab '**jobs@fssai(careers)**' on the FSSAI website i.e. www.fssai.gov.in commencing from **30.05.2026 to 19.06.2026**. **The cut-off date for ascertaining eligibility will be closing date of applying online i.e. 19.06.2026. The applications submitted within due date through FSSAI's online portal only will be considered.**

3. The departmental officers in the feeder cadre category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation.

4. The hard copy of online application form duly certified by the employer along with "**Certificate by the employer/Cadre Controlling Authority**" in the prescribed format as attached and other supporting certificates/documents (Integrity certificate, vigilance clearance, major/minor penalty imposed during the last ten years and up to-date duly certified photocopies of detailed APARs for the last 5 years) **must reach through proper channel to Administrative Officer, Recruitment Cell, FSSAI Headquarters, Room No. 312, 3rd Floor, FDA Bhawan, Kotla Road New Delhi by 13.07.2026** for further necessary action, failing which the candidature may be cancelled.

5. All appointments made on deputation on Foreign Service Terms including short term contract in the Food Authority under these regulations shall be for a period **not exceeding one/two/three years depending upon the posts** in the first instance, which may be extended **subject to availability of vacancy** as per guidelines issued by the Government of India at the discretion of the Competent Authority which shall be based on the performance appraisal of the deputationists and in consultation with the parent department. The deputation in the Food Authority on this post is exempted from rule of immediate absorption. The terms of deputation including pay of the officials selected on deputation will be governed by provisions laid down in the Department of Personnel and Training's Office Memorandum No.6/8/2009-Estt. (Pay II) dated 17th June, 2010 and other orders/guidelines issued in this regard from time to time. The maximum age limit for appointment on deputation shall be **56 years** on the last day of receiving of the online applications.

6. Officials of PSE, PSU, Autonomous Bodies etc. where salaries are paid on IDA basis may kindly refer to the IDA-CDA Equivalency issued by FSSAI as per **Annexure- III** for ascertaining their eligibility for various posts on Deputation.

7. The applicants are further informed that once application is submitted, they will not be allowed to withdraw their candidature subsequently.

8. The vacancies shown in the advertisement are indicative which may increase or decrease at the discretion of the Competent Authority. The Food Authority reserves the right not to fill up all or any of the vacancies or to cancel the advertisement at any stage without assigning any reason. OFFICE MEMORANDUM

Sub: IDA-CDA equivalency for various posts of FSSAI on DR and Deputation Basis

The equivalence of CDA vis-à-vis IDA pay scale for the purpose of recruitment on DR and Deputation basis was issued by FSSAI in the past and same has been available on FSSAI website under FAQs on FSSAI Recruitment.

2. The issue regarding equivalence of pay scales has been deliberated by the committee constituted by FSSAI and taking into consideration the equivalence of pay between CDA and IDA Pay scales adopted by other Public Sector Enterprises/ Undertakings/ Autonomous Bodies such as WCD/DOPT, NHAI, Indian Railway Stations Development Corporation Ltd., FCI and UIDAI, the committee has recommended the equivalent pay scale as indicated at para 3 below.

3. The recommendations of the Committee have been approved by the Competent Authority and accordingly, in supersession of the earlier equivalency, the following revised equivalence of CDA vis-à-vis IDA pay scales are being adopted in FSSAI for future recruitments.
