MINIMUM ESSENTIAL EXPERIENCE:

Minimum MBBS with completed internship and registration with Medical Council of India. Preference will be given to candidates possessing Diploma in Industrial Medicine or Certificate of Training in Industrial Health for a period of Minimum 03 months duration.

EMOLUMENTS & OTHER CONDITIONS:

1. Engagement is full time, temporary and on contract basis and will have initial period of engagement for not more than one year. Based on the performance, period of engagement may be extended further on a yearly basis. However, the maximum period of contract engagement should not exceed 03 years. Increment will be given on extension of services after completion of one-year engagement.

- 2. Consolidated Monthly fee of **Rs. 93,000/-** (Ninety-Three Thousand) will be paid per month.
- 3. Annual monthly increment of **Rs.2800/-** will be given on extension of contract (if any) after completion of one-year engagement.
