**PARA-1:**

Applications are invited through off-line mode (Physical applications) from eligible candidates for various posts to work purely on Contract basis in Govt. Teaching General Hospital, Machilipatnam of Krishna District.

The candidate is required to download the application forms from website (<https://krishna.ap.gov.in/>) and the application form along with necessary documents shall submit in-person/by Registered post from **12.05.2026 to 22.05.2026 from 11 AM to 03.00 PM on working days only 22.05.2026** is the last date for submission of applications in-person/registered post). This DSC is not responsible for postal delay if any and applications received after **05.00 PM of 22.05.2026** will not be accepted in any circumstances.

The filled applications along with necessary documents shall be submitted at office of the **Govt. Teaching General Hospital, Machilipatnam, Krishna.**

Selection to the posts will be on the basis of final general merit cum rule of reservation. The applicant should visit the **Krishna** District official website regularly to keep himself/herself updated until completion of the recruitment process. The website information is final for all correspondence. No individual correspondence by any means will be entertained under any circumstances.

All desirous and eligible candidates shall apply after satisfying themselves as per the terms and conditions of this recruitment notification. Submission of application forms by the candidate is considered that he/she has read the notification and shall abide by the terms and conditions laid down there under.

**PARA:3::Reservations:**

To fill up the vacancies as shown above in Krishna District as per Merit cum RoR under the administrative control of DME, AP, Vijayawada according to the G.O.Ms.No.77, General Administration (Services-D) Dept., Dt:02.08.2023 Govt of AP and G.O.Ms.No.7, Social Welfare (CV) Dept., Dt:18.04.2025 Govt. of AP.

**PARA:4::Age:**

Upper age limit is 42 years. Age will be reckoned as on 31.07.2025 as per G.O.Ms.No.105 GA (Ser-A) dept., dated.27.09.2021 with relaxations as applicable. Relaxations will be as follows:-

- a. For SC, ST, BC and EWS candidates: 05 (Five) years.
- b. For Ex-service Men: 03 (Three) years in addition to the length of service in armed forces.
- c. For differently abled persons: 10 (Ten) years.
- d. Maximum age limit is 52 years with all relaxations put together.

**PARA:5::Fee:**

Applicant must enclose a demand draft towards application processing fee in favor of “**Hospital Development Society, Govt. Teaching General Hospital Machilipatnam**” (if candidate is eligible for more than one post is required to enclose demand draft for each post and apply for each post separately) as given below:

**PARA:6::Important note on Recruitment process and procedure of selection:**

The recruitment will be processed as per this notification and as per the rules and instructions issued by the Government and also as decided by the **District Selection Committee, Krishna** from time to time in terms of respective Special Rules/Adhoc Rules governing the recruitment and the related G.Os, rules etc., are applicable.

The various conditions and criteria prescribed herein are governed by the AP State and Subordinate Rules 1996 read with the relevant special rules applicable to any particular services in the departments. Any guidelines or clarifications are based on the said rules, and in case of any necessity any matter will be processed as per the relevant General and Special Rules as in force.

The selection to this recruitment will be based on the merit given below;

Note-1:The maximum weight age as mentioned at point- (02) for Government service rendered in Tribal/Rural/Urban areas including Covid-19 duties is maximum upto 15 marks as per G.O.Ms.No.211, HM&FW (B2) department, dated.08.05.2021 read with G.O.Rt.No.573, HM&FW (B2) department, dated.01.11.2021.

Note-2: The above Covid-19 shall be applicable only to the persons who have rendered their services for Covid-19 on Contract/Outsourcing/Honorarium basis and they are appointed by the District Collectors or any other Competent authority exclusively for Covid-19 purpose, based on Orders issued by the Government from time to time.

**Note-3: The candidates who claim service weight age should submit Original service certificates in prescribed proforma duly issued by the competent authority along with copy of appointment orders issued by competent authority. Those who fail to submit the Original service certificate in prescribed proforma duly issued by the competent authority with appointment orders by competent authority will not be allowed service weight age.**

**PARA:7::Tenure of appointment and important conditions:**

The tenure of the contract/outsourcing initially one year from the date of joining in the post and may be extended for further period as per the instructions issued by the Government from time to time.

The District Selection Committee; **Krishna** reserves all the rights to terminate the contract/out sourcing services of any candidate/candidates at any time without giving any prior notice as per directions of the Government from time to time.

**Self attested copies of the certificates to be enclosed to the filled in application:**

- a. SSC or its equivalent.
- b. Intermediate or its equivalent.
- c. Pass certificates of qualifications prescribed for the posts concerned.
- d. Proof of appearance for the qualifying examination where ever applicable.
- e. Marks memos of all years of qualifying examination or its equivalent. In the absence of marks memos, marks will be calculated as per rules in force.
- f. Valid certificate of registration and renewal certificates of respective Council Constituted under the relevant rules for specific courses where ever applicable.
- g. Study Certificates from class IV to X from the school where the candidate studied. In case of private study local candidature certificate for that particular 7 years period preceding to the year of passing X class from competent authority in Form Appendix I certificate of residence prescribed vide Sub clause (ii) of clause (a) of para 7 of the Presidential Order (proforma is herewith enclosed).Candidates migrated from Telangana shall submit certificate of Local candidature as per GO No 132 & 133 dt: 13.06.2017. In the absence of the suitable certificate, the candidate will be considered as non local and further action will be as per rules in force.
- h. Copy of valid caste certificate (In case of non submission of valid caste certificate, the candidate will be considered as OC).
- i. Certificate of disability issued in SADAREM.(differently abled candidates will be considered after getting re-assessment from the Board).
- j. Any other certificates as relevant and applicable.

**Note:- Candidates must submit clear, visible documents (a to h of para.7), failing which application will be summarily rejected. Applications without the above documents will be summarily rejected.**

**PARA:8::Debarment:**

Candidates should make sure of their eligibility to the post applied for and that the declaration made by them in the format of application regarding their eligibility is correct in all aspects. Any candidate furnishing in-correct information or making false declaration his/her eligibility at any stage or suppressing any information, is liable to be debarred up to 5 years from applying for any of the notifications conducted by APPSC/District Selection Committee/any other recruiting agencies and their candidature for this recruitment summarily rejected.

The **District Selection Committee, Krishna** is vested with conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by anyone causing or likely to cause breach of this duty in such manner or by such action as to violate or likely to violate the fair practices followed and ensured by **DSC Krishna** will be sufficient cause for rendering such question able means as ground for debarment and other consequences as per law and rules.

**PARA: 10 :: District Selection Committee decision to be final:**

The decision of the District Selection Committee in all aspects and respects pertaining to the application and its acceptance or rejection as the case may be, conduct of recruitment of and at all consequent stages culminating in the selection or otherwise of any candidate shall be final in all respects and binding on all concerned, under the powers vested with it as per rules in force. The District Selection Committee also reserves its rights to alter and modify the terms and conditions laid down in the notification for conducting the various stages up to selection or with draw the notification at any time as warranted by any un for seen circumstances arising during the course of this process, or as deemed necessary by the District Selection Committee at any stage. The Merit List is valid for one year from the date of this notification for the purpose of filling up of arising vacancies as per requirement of the Department.
