HAL's spectrum of expertise encompasses hi-tech programmes involving a number of state-of-the-art technology, design, development, manufacture, repair, overhaul and upgrade of Aircraft, Helicopters, Aero-engines, Industrial & Marine Gas Turbines, Accessories, Avionics & Systems and structural components for Satellites & Launch Vehicles.

2. HAL is looking for learned, experienced and result oriented Professionals with diverse experience profile for Executive post in Central Materials and Processes Laboratory (CMPL) which is one of the R&D Centres located in Foundry & Forge Division of HAL. CMPL's current activities include material testing(Metallic & Non-metallic), Failure Investigation of components, Materials related R&D and consultancy, Characterization of materials and calibration needs of Foundry & Forge Division and other Divisions of HAL. CMPL is an ISO17025 accredited laboratory and holds approvals from Military Aircraft Regulatory Authority DGAQA and other Aerospace primes such as GE-Aerospace, Rolls Royce and Collins Aerospace.

4. QUALIFICATION REQUIREMENT

- 4.1 Candidates applying for above mentioned post should possess the qualification as enumerated above.
 - 4.2 Candidates possessing B.E./ B.Tech. acquired through Part Time/Correspondence/Distance Education/E-learning qualification will not be equated with regular / full time courses.
 - 4.3 Candidate pursuing / enrolled for any other qualifications should mandatorily indicate the same in the application format. All the qualifications possessed by the candidates and qualifications/ courses being pursued by them at the time of submitting the application for employment, are to be clearly indicated in the application. In other words, all the qualifications already possessed and qualifications / courses, which are being pursued / currently undergoing are to be indicated in the application while submitting the same.

5. EXPERIENCE (POST QUALIFICATION) REQUIREMENT

5.1 The number of years of Post Qualification Experience required is 5 years.

- 5.2 Experience will be calculated from the date of having acquired Full time/ part time Doctorate (Ph.D) in Metallurgical Engineering/ Metallurgy/ Material Science/ Metallurgy & Materials Technology. Experience prior to acquiring the Ph.D will not be reckoned for calculation of experience.
- 5.3 The following work experience of candidate will be considered relevant:
 - (i) Experience of candidates in relevant discipline from industries with accreditations ISO 17025 or NADCAP or AS9100 or ISO9001 having metallurgical labs or R&D centers.
 - (ii) Candidates who possess work experience in Metallurgy Laboratory of a National Institute Ranking Framework (NIRF) ranked Engineering/Academic institutions will also be considered.
 - (iii) Work Experience in relevant discipline from Government/Private Research Establishments.

Any experience acquired/ gained during the course of pursuing the higher qualification i.e. M.E./ M.Tech will not be considered for the post Qualification experience and in such case, the duration of course will be deducted from the total PQ experience possessed.

- 5.4 Percentage Rounding off is not allowed to arrive at the aggregate percentage.
- 5.5 Though this post is unreserved, SC/ST/OBC/EWS candidates meeting the minimum qualifying criteria can also apply.

6. EXPERTISE/ SKILLS/ KNOWLEDGE REQUIRED:

Minimum 5 years in area of Metallurgical Testing, Characterization of metallic materials **Experience** and Failure investigation of aeronautical and engineering components. Should have thorough knowledge in metallographic techniques such as optical microscopy, image analysis, micro hardness determination and using other conventional Laboratory metallurgical aids. Should be able to able to prepare sample for metallurgical analysis and carry out test such as microstructure determination, inclusion rating, grain size determination etc. Should have hands-on experience in Fractography analysis using Scanning Electron Microscope and interpretation of results. Knowledge and experience in Mechanical behavior and testing of metals such as Tensile (Room & Elevated temperature), Fatigue Testing, Creep & Stress Rupture Tests, Fracture Toughness etc. The candidate should possess aptitude for taking up R&D work in the area of development of advanced aerospace materials and processes. Any R&D work carried out by the candidate will be an added advantage Should possess good technical report writing and communication/ presentation skills. Knowledge about laboratory accreditations like NABL, ISO/AS9100, NADCAP is desirable. The candidate will look after the planning, management and execution of the Job Profile Laboratory functions in the area of metallurgical testing and mechanical testing. The candidate should be able to carry out the failure analysis independently. The candidate will also support in the area of testing of metallic materials like grain size measurement, inclusion rating, heat treat conditions, case-depth measurement, general micro structure and other mechanical testing etc.

7. AGE LIMIT/ RELAXATION

- 7.1 The upper age limit shall be 38 years.
- 7.2 The Upper Age Limit will be reckoned as on 30.11.2025. Candidates meeting the Age criteria are only required to apply.
- 7.3 For Candidates who had ordinarily been domiciled in the State of Jammu & Kashmir during the period 01-01-1980 to 31-12-1989, Upper Age Limit is relaxable by 5 years:

8. PLACE OF POSTING

On selection, candidates will be appointed in the Scale of Pay as indicated above. - 11.3 Candidates should clearly mention all the details sought in the Application Format. Application should be filled in Capital Letters and should be legible. In case of no clarity / discrepancy in the information provided, Application will be summarily rejected. No communication will be sent to the candidates
- 11.4 No Application will be received in person. Applications received after the due date will not be considered and will summarily be rejected. HAL will not be responsible for any postal delay. **The last date for receipt of Applications is 03.01.2026**
- 11.5 The original Counterfoil of Challan (HAL Copy) for having paid the Application Fee (wherever applicable) should be enclosed to the Application Form. The candidate should retain original counterfoil of the Challan (Candidate's copy) for future reference;

- 11.8 No original documents / Certificates / testimonials are required to be attached along with Application Form; However, it may be noted that all the candidates who are called for Interview at a later stage will have to mandatorily produce Certificates in original in respect of all the particulars submitted in the Application Form during Document Verification;
- 11.9 Candidates are allowed to apply once and application once submitted cannot be altered under any circumstances;
- 11.10 Candidates are required to possess a valid Mobile number and Email Id, which is to be entered in the application, so that intimation regarding further stages of selection like Selection Interview, etc. will be sent on the same Email ID. 12. GENERAL CONDITIONS

- i. Only Indian Nationals are eligible to apply;
- ii. Mere submission of Application will not entail right for claiming appointment/ getting shortlisted for further stages of recruitment process;
- iii. All qualifications should be from Indian Universities/ Institutes recognized by appropriate statutory Authorities in the Country;
- iv. HAL reserves the right to cancel / restrict / enlarge / modify / alter the requirements advertised, if need so arise, without issuing any further notice or assigning any reason there to. The number of vacancies can be modified as per requirements and discretion of the Management;
- v. Selection Procedure: Candidates applying for the aforesaid posts are required to meet the stipulated criteria w.r.t Qualification and the Post Professional Qualification Experience. Eligible candidates short-listed based on the initial screening, relevance of experience and other credentials possessed only will be called for

personal interview. Date, Time and Venue of the Interview will be intimated to the short-listed / eligible candidates only via E-mail / HAL Website. Candidates will be shortlisted and called for Interview in the ratio of 1:10 (Maximum) as per the Rules of the Company. - vii. Candidates staying 30 miles (50km appx) away from the place of interview only will be reimbursed to and fro charges as mentioned above. If the candidate is unable to produce the proof of travel/ tickets, then the reimbursement will not be paid by HAL;

- xv. Once an employee avails himself/herself of voluntary retirement from a PSU, he/she shall not be allowed to take up employment in another PSU. If he/she desires to take up the employment, he/she shall have to return the VRS compensation received by him/her to the PSU concerned.
