- 3. Photocopy of self-attested documents in support of date of birth (Madhyamik or equivalent certificate/Admit card).
- 4. Photocopy of self-attested mark-sheets and certificates of Class $10^{\rm th}$ & $12^{\rm th}$ standard.

The application must be submitted in closed envelope, superscribing thereon the particular post applied for to the undersigned within **4:45 P.M**. on or before **18/03/2025**. Applications reaching after the last date shall not be considered, even though the same are posted well in advance.
